INQUIRY REPORT

On 16/10/2017 accused / official Mst. Rubina Zahid submitted her reply to explanation bearing No. 1480 dated 03/10/2017 issued by learned Senior Civil judge, Abbottabad but reply of accused/official is not convincing, therefore, learned Senior Civil Judge, Abbottabad conducted inquiry against accused & official. Statement of allegations and charge sheet were made on 16/10/2017 and handed over to the accused / officials. Thereafter the undersigned was appointed as Inquiry Officer with the directions to submit report.

Inquiry against accused/official received by the undersigned on 02/11/2017 and notice be issued to accused / official to submit reply to statement of allegations. Accused / official submitted her reply on 28/11/2017 and after submission of reply, notice be issued to Touqeer S/o Faqera Khan for recording his statement. Today, Mr. Touqeer S/o Faqera Khan appeared before the court and recorded his statement.

Perusal of statement of Mr. Touqeer S/o Faqera Khan transpired that accused/official namely Rubina Zahid purchased the crockery valuing Rs. 23000/- from him and promised to pay the amount within 15 days but she failed to pay the same within 15 days. He further stated that on his demand, petitioner paid Rs. 7000/- to him through court after 3/4 months and failed to pay the remaining amount of Rs. 16000/- to him despite repeated demands.







In view of the above the accused/official is hereby *compulsory retired* with immediate effect.


