JUDGMENT

ROZINA REHMAN, MEMBER: The appellant has filed the present service appeal U/S 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the order dated 15.02.2018 vide which major penalty of removal from service was imposed upon appellant.

02. Brief facts of the case are that appellant was appointed as A.T (Arabic Teacher) in a School at Hangu on 05.03.2010. Due to extreme militancy at Tarri Banda G.H.S Hangu, School was closed but the



appellant was compelled to ensure attendance in the said School which was already closed and the teaching staff as well as students were also not in attendance. He was proceeded against departmentally and lastly he was removed from service vide impugned order. Feeling aggrieved, he filed departmental appeal which was not responded to, hence, the present service appeal.

- order is against law and facts as the appellant was not treated in accordance with law. He submitted that the impugned order dated 15.02.2018 was passed in view of previous inquires and that no fresh inquiry was initiated before imposition of the major penalty. He submitted that surprise visit was paid by the authority on 07.02.2017, whereas, the impugned order shows the absence of appellant on 23.01.2017.
- O4. Conversely learned A.A.G submitted that the School was never closed as there was no militancy in the year 2015-16 and that the staff was performing duty regularly. He submitted that the inquiry was conducted against the appellant according to law and that proper show cause notice was issued to the appellant with direction to resume duty, where-after, he appeared before the District Education Officer and submitted judicial stamp paper that he will never remain absent in future.
- O5. Record shows that appellant was appointed as Arabi Teacher in School at Hangu on 05.03.2010. He was transferred to G.H.S Tarri Banda Hangu and he served in the said area till 01.10.2015. Perusal of impugned order would reveal that the District Education Officer paid a surprise visit to G.H.S Tarri Banda on 07.02.2017 at 9:00 AM but no inquiry was conducted in order to check the absence of the appellant

rather the inquiries conducted much before the surprise visit were mentioned in the impugned order. The contents of the impugned order show that the appellant was informed on 07.12.2016 with direction to fulfill the requisite in respect of the affidavit. Accordingly, he submitted his statement on a judicial stamp paper on 04.01.2017. He was found absent till 23.01.2017, therefore, he was issued absentee notices prior to the decision on 04.11.2016. All this shows previous closed transactions which have nothing to do with the surprise visit of the District Education Officer on 07.02.2017. As per Rule-3(d) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, a Government servant shall be liable to be proceeded against under these rules if he is guilty of habitual absenting himself from duty without prior approval or leave. In the instant case, if the appellant was not available in the school when surprise visit was paid on 07.02.2017, then the appellant was liable to be proceeded against Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 and the initiation of proceedings as per Rule-5 of the Rules ibid has to be followed in letter and spirit. But in the instant case, his past conduct was taken into consideration while passing the impugned order of removal from service.

06. Keeping in view the above discussion, this Tribunal is left with no option but to partially allow this appeal. Accordingly, impugned order is set aside. Case is remitted to the Department with direction to conduct de-novo inquiry in view of Rule-3 (d) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 within 30 days after the receipt of this judgment. Reinstatement and back benefits

shall be subject to the outcome of de-novo inquiry. Parties are left to bear their own costs. File be consigned to record room.

- 2:-That the due extrem militancy at Tari Banda GHS Hangu the School was closed and but respondent No-3 having complete knowledge about militancy compell the appellant to ensure attendance at the said school which was already remain closed as well as other teaching staff and student were also not in attendence.
- 3:-That the appellant due to official pressure ensure the attendance as per the direction of Respondent :-03 at closed school .
- 4:-That on 28-02-2017 appellant was on the way to closed school miscreants attacked on appellant due to belonging to Aleh –Tashee caste hence there were emient apperhension of threat to life and this fact has also agaitate before high ups but in vain.
- 5:-That the appellant without any show cause notice and charge sheet or without following the departmental enquiry procedings the appellant was removed from service expartly (Copy of impugned order annexed as annexure A)
- 6:-That appellant feeling aggrived from the impugned order dated 15-02-2018 file departmental appeal on dated 19-02-2018 before the respondent N0-1which is still not entertain nor consider (Copy of departmental appeal is annexed as annexure B)
- 7:-That the appellant since his appointment never ever become absent which could be verify from the appellants service record and it is worth mentioning here that the impugned order issued by respondent No-3 on the basis of personal grevience (Copy of appointment order is annexed as annexure C)
- 8:-That there is no bad entry in the service record of the Appellant but without giving any opportunity of personal hearing the appellant removed from service without any law ful justification.

- 9-That the appellant time and again inform about apperhension of death due to T.T.P but the said written request not consider by respondent above like departmental representation (Copy of application is annexed as annexure D)
- 10:-That the Appellant is aggrieved from the illegal act of the respondents and having no alternate remedy except this Honorable, Tribunal for speedy disposal / redressal for infringement of appellant's legal rights through instant service appeal on the following amongst other grounds.

Grounds

- 1:- That the illegal acts of the respondents No -3 is against to the cannon of law as well as against to the natural justice.
- 2:-That there is legal cogent reason defined by respondent No-3 for which the present Appellant has been removed from service.
- 3:-That the impugned transfer order is against to the principal of natural justice and show the discrimination on the part of respondent No-3.
- 4:-That the impugned order of the above respondent is illegal and highly condemnable and unlawful in nature .
- 5:-That the Appellant is a poor and only person to earn the livelihood for her large supported family and the income from his job is a source of spoon feeding for infant children's.
- 6:-That the bias of the respondent No-1clearly shows by not entertaining the representation of the appellant, keeping in view the decision of apex court the respondent No-1 & 2 were duty bound to record reason of rejection "when departmental

appeal was submitted the competent authority was duty bound to decide same within reasonable time after application of independent mind ,by giving reason such was a requirement of law as well as of the principal of natural justice "2009 (PLC) (CS) 77.

7:- That the Appellant never ever remains absent from his duties till date.

10:- That it is clearly mention in 2003 PLC CS 1468 that any instruction issued in violation of Rules would be illegal and void.

11:- That some other grounds will be agitated at the time of arguments with the permission of this Honorable court.

PRAYER:-

In the light of above circumstances it is respectfully prayed that on acceptance of instant service appeal the Hon bale tribunal may direct to respondents above to set a side impugned order dated 15-02-2018 and the Appellant may graciously be reinstated in service with all back benefit and blessed with any other remedy in the larger interest of justice.

He did not paid due consideration to his attendance, rather to contact through outsider for relief which itself is against the establish norms.

Further more you were granted NOC for inter District transfer on your request vide this office No.49, dated:06/07/2017, which is still under process. During the course of time you did not attend your duty and continuously remained absent.

Keeping all the above in front, It is cleared and proved that you Mr. Muntazir Mehdi AT GHS Tari Banda have no interest in this service.

Preliminary Objections.

Respectfully Sheweth

- 1) That the present appellant has no cause of action.
- 2) That the instant appeals is bad for mis-joineder and non joinder of parties.
- 3) That the instant appeal is not maintainable in its present form.
- 4) That the appellant has not come to the tribunal with clean hands.
- 5) That the appellant has concealed some important material/facts from the honorable tribunal.

Proceeding of Enquiry:

Mr. Mantazar Mehdi AT was directed to appear for enquiry proceedings on the above mentioned date and venue. The teacher, under reference, turned up for enquiry proceedings. Questionnaires were served on Muntazar Mehdi (Annex1) and the I/C of the school (Annex2). Both Muntazar Mehdi and the I/C of the school submitted, their respective replies of the Questionnaires (Annex 3 and 4)

Findings of the Enquiry:

1: The teacher, under reference remained absent from his duty wef 01-09/2015 to 20/09/2016 on the pretext of precarious law and order situation. He has miserably failed to justify his stance.
