APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED ORDER DATED 08.06.2018 WHEREBY THE APPELLANT HAS BEEN REMOVED FROM SERVICE AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned order dated 08.06.2018 may very kindly be set aside and the respondents may be directed to re-instate the appellant into service with all back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

- 1- That appellant was initially appointed in the respondents as Chowkidar vide order dated 16.12.2016. That in response to the said order the appellant submitted his arrival report and started performing his duty quite efficiently and upto the entire satisfaction of superiors. Copy of the appointment order is attached as annexure.....**A.**
- 2- That right from appointment the appellant has served regularly and has never been absented himself from his lawful duty. Copy of the attendance register is attached as annexure.....**B.**
- 3- That during performing duty the appellant has been removed from his service vide impugned order dated 08.06.2018 on the ground of baseless allegations without fulfilling the codal formalities in the

4- That feeling aggrieved from the impugned order dated 08.06.2018 the appellant preferred Departmental appeal before the respondent No. but no reply has been received so far. Copy of the Departmental appeal is attached as annexure.....D.

5- That appellant feeling aggrieved and having no other remedy but to file the instant appeal on the following grounds amongst the others.

GROUND:

A- That the impugned order dated 08.06.2018 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to set aside.

B- That appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of Islamic Republic of Pakistan 1973.

C- That no charge sheet and statement of allegation has issued to the appellant before issuing the impugned order dated 08.06.2018

D- That no show cause notice has been served on the appellant before issuing the impugned order dated 08.06.2018.

E- That no chance of personal hearing/defense has been provided to the appellant and as such the appellant has been condemned unheard.

F- That the respondent Department acted in arbitrary and malafide manner while issuing the impugned order dated 08.06.2018.

G- That the allegation leveled against the appellant are vague and not based of facts, therefore the impugned order is not tenable in the eye of law hence liable to be set aside.

H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.







AND WHEREAS, to know the factual position the Director E&SE (appellate authority) ordered an inquiry in the matter by appointing Mr. Safdar Khan Principal, Govt: Shaheed Saad-ur-Rehman High School Gulshan Rehman, Colony Peshawar, as Inquiry Officer vide Notification No. 3878-80 dated 9.10.2018.

AND WHEREAS, the concerned enquiry officer accordingly submitted enquiry report vide this office dairy No. 305 dated 6.11.2018.


Now therefore, in exercise of the power conferred upon appellate authority, under section-17 read with rules 2(b) of E&D Rules-2011. The Director E&SE Khyber Pakhtunkhwa Peshawar (Appellate Authority) has decided to set aside the major penalty of removal from service imposed by the DEO (M) Peshawar vide Notification No. 14011 dated 8.6.2018 and reinstate Mr. Muhammad Zubair, Ex-Chowkidar Govt Shaheed Aiman Khan Higher Secondary School Naudeh Payan Peshawar in service w.e.f 08/06/2018. The absence period & intervening period from 08/06/2018 to date is hereby treated as EOL without pay and electrically bill for the month of June 2018 amounting to Rs 12720/- be deposited in the Govt: treasury.
