PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 08/03/2021 MAY PLEASE BE SET ASIDE AND THE APPELLANT MAY BE REINSTATED IN TO SERVICE WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY, WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO, BE AWARDED IN FAVOUR OF APPELLANT.

FACTS

1. That the appellant was highly qualified and appointed as SST vide order dated 28.04.2017 by the competent authority after due process of law and posted at GSWIHS Pir Pai District Nowshera. **Copy of Educational documents and appointment order is attached as annexure-A & B.**
2. That ever since appointment, appellant had performed his duties assigned to assigned to him with zeal and devotion and there was no complaint, what so ever regarding his performance.
3. That thereafter, KP EMPLOYEES OF THE E&SE DEPARTMENT (Appointment And Regularization Of Services) ACT, 2017 was promulgated and shall come into force from 08, January 2018. On promulgation of the said Act the service of the appellant was regularized under Clause-3 of the said ACT by the operation of law. **Copy of the act is attached as annexure-C**
4. That salary of the appellant was stopped due to non-submission of original MA English degree and inquiry was initiated but the appellant was not associated with the inquiry proceeding nor handed over the inquiry report but vide letter dated 08.11.2018 appellant was informed to submitted original degree within 15 days. **Copy of letter is attached as annexure-D**
5. That the appellant filed writ petition in Peshawar High Court Peshawar for releasing of salaries. That Peshawar High Court directed the appellant for submission of Original degree. On the direction of PHC appellant submitted Original Degree. Thereafter, on the direction of Peshawar high court Peshawar director E&SE wrote letter to HEC for verification of the degree of the Appellant. **Copy of orders is attached as annexure-E**

6. That HEC vide letter dated 24.12.2019 addressed to District Education officer male Nowshera verified the degree of appellant where after DEO issued clearance certificate and the salary of the appellant has been released. That interim relief was also granted to the appellant in shape of not to take adverse action against the appellant. **Copy of letter dated 24.12.2019 and clearance certificate is attached as annexure-F.**
7. That after 1 year when new District Education Officer came, he again sent the degree of the appellant for verification in response of which HEC replied by vide letter dated 10.12.2020 and disown the letter dated 24.12.2019 but the same letter has refer in impugned order and the same was never provided to the appellant, may be requisition from the deptt:. Thereafter, despite the interim relief, the director E&SE withdraw the appointment order of the appellant vide order dated 2.3.2021 without any notice and hearing which is illegal and has nullity in the eyes of law. **Copy of interim order and impugned order is attached as annexure-G & H.**
8. That the appellant being feel aggrieved from the order dated 08.3.2021 filed the departmental appeal against the impugned order which was not responded within statutory period of 90 days. **Copy of departmental appeal is attached as annexure-I.**
9. That the Peshawar High Court Peshawar vide order dated 27.05.2021 dismissed the writ petition being infractious and directed the appellant to approach proper forum for redressal of grievances. **Copy of high court order is attached as annexure-J**
10. That now the appellant come to this august Tribunal on the following grounds amongst others.

Grounds:

- A. That the orders dated 08.03.2021 is against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.

- B. That the appellant has been condemned unheard in violation of Article 10-A of the Constitution of Islamic republic of Pakistan and in violation of maxim "Audi Alterum Partum" and has not been treated according to law and rules. that according to reported judgment cited as *2019 CLC 1750* stated that Audi Alterum Partum" shall be read as part and parcel of the every statute.
- C. That the appellant have not been treated in accordance with law hence the appellant right secured and guaranteed under the law are badly violated.
- D. That the appellant also have MA (English) Degree from the Newport Institute of Communication and Economics, Karachi. The said institute is recognized/ registered degree awarding body with the HEC. **Copy of the HEC recognized university list is attached as annexure-K.**
- E. That the degree of the appellant has been verified by the respondent from the concern institution and thus the same is valid for all purpose which was also further verified by the department himself through letter dated 9.12.2019 in response of which HEC verified the degree vide letter dated 24.12.2019
- F. That the appellant obtained degree of MA English from new port instate of communication and economic Karachi which is duly recognize from HEC so there is no fault on the part of the appellant
- G. That the appellant now also obtained MA English degree from other university also which may also be consider as fruitful attempt on the part of appellant
- H. That according to Federal Shariyat court Judgment cited as *PLD 1989 FSC 39* the show cause notice is must before taking any adverse action, non-issuance of show cause notice is against the injunction of Islam. Hence the impugned order is liable to be set-aside.
- I. That the show cause is the demand of natural justice and also necessary for fair trial and also necessary in light of injunction of Quran and Sunnah but show cause was not given to the appellant. So, fair trail denied to the appellant which is also violation of Article 10-A of the constitution. Further it is added that according to reported judgment cited as *1997 PLD page 617* stated that every action against natural justice treated to be void and unlawfull order. Hence,s impugned order is liable to be set-aside.

The natural justice should be considered as part and parcel according to superior court judgment cited as 2017 PLD 173 and 1990 PLC cs 727.


- J. That the charges leveled against the appellant were never proved in the enquiry, the enquiry officer gave his findings on surmises and conjectures.
- K. That similar placed person already regularized by the deptt and still serving the deptt who obtain degree from the same institution. The same principle held in the Superior Court judgments cited as 2002 SCMR 71. Copy of record is attached as annexure-L
- L. That the appellant have never committed any act or omission with bad or malafide intentions which could be termed as misconduct, albeit the appellant's appointment order has been withdrawn. Which is violation of reported judgment cited as 1997 PLC cs 564.
- M. That the appellant has been condemned unheard in violation of Article 10-A of the Constitution of Islamic republic of Pakistan and in violation of maxim "Audi Alterum Partum" and has not been treated according to law and rules. The same principle held in the Superior Court judgments cited as 2016 SCMR 943 and 2020 PLC(cs) 67.
- N. That no show cause notice was issued before taking adverse action which is violation of rule **Rule-5(a) Read with Rules -7** in case inquiry was not necessary and **Rule-14(b) of the E&D Rules 2011**, in case where inquiry is necessary. which were totally ignored before taking adverse action. The same principle held in the Superior Court judgments cited as 1987 SCMR 1562, 2019 PLC cs 811 and 209 SCMR 605. Further it is added that inquiry report was also not provided to the appellant which was also violation of **Rule 14(c) of the E&D rules 2011**, so the impugned order was passed in violation of law and rules and norms of justice. The same principle held in the Superior Court judgments cited as 1981 PLD SC 176 and 1987 SCMR 1562.
- O. that no proper regular inquiry was conducted if any then the appellant not associated with the inquiry, neither the statement recorded in presence of appellant nor was the chance of cross examination provided to the appellant which is violation of **Rule-10 (b) and Rule 11 (1) of the E&D Rules 2011**,. which were totally ignored before imposing punishment. The same principle held in the

Superior Court judgments cited as 2010 SCMR 1554, 2016 SCMR 108 and 2008 PLC cs 1107.


- P. That the opportunity of personal hearing and personal defense was not provided to the appellant which was violation of **Rule 7(d)** in case inquiry was not necessary **and 14(5) of the E&D rules 2011** in case where inquiry is necessary. The same principle held in the Superior Court judgments cited as 2006 SCMR 1641.
- Q. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

5. Appointment is subject to the condition that the certificate/documents must be verified from the concerned authorities by the DEO (concerned), any one found producing bogus Certificate will be reported to the law enforcing agencies for further action.
6. His/her services are liable to termination on one month's notice from either side. In case of resignation without notice his one-month pay/allowances shall be forfeited to the Government.
7. Pay will not be drawn until and unless a certificate to the effect by DEO (concerned) is issued that his/her certificates are verified.
8. He/She should join his post within 10 days of the issuance of this notification. In case of failure to join the post within 10 days of the issuance of this notification, his/her appointment will expire automatically and no subsequent appeal etc shall be entertained.
9. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
10. He/she will be governed by such rules and regulations as may be issued from time to time by the Govt.
11. His/her services shall be terminated at any time, in case his performance is found unsatisfactory during his/her contract period. In case of misconduct, he/she shall be proceeded under the rules framed from time to time.
12. His/her appointment is made on School based, He/she will have to serve at the place of posting, and His/her service is not transferable to any other station.
13. Before handing over charge once again their document may be checked if they have not the required relevant qualifications as per rules, they may not be handed over charge of the post.

the Province of the Khyber Pakhtunkhwa.*

WHEREAS it is expedient to provide for the appointment and regularization of the services of certain employees appointed on adhoc or contract basis or appointed in certain projects in the Elementary and Secondary Education Department in the Province of the Khyber Pakhtunkhwa, in the public interest;

It is hereby enacted as follows:

1. Short title, application and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.

(2) It shall apply to all the employees in the Elementary and Secondary Education Department, as defined in clause (c) of sub-section (1) of section 2 of this Act.

(3) It shall come into force at once **and it shall be deemed to have taken effect from the date of the initial appointment of the employees as referred to in clause (c) of sub-clause (1) of section 2 of this Act.**

2. Definitions.---(1) In this Act, unless the context otherwise requires,-

- (a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
- (b) "contract appointment" means appointment of a duly qualified person for a specific period made otherwise than in accordance with the prescribed method of recruitment;
- (c) "employees" mean duly qualified persons,-

- (i) who are appointed as teachers on adhoc or contract basis by the Government after 2013 through National Testing Service but does not include the teachers engaged on work charge basis or who are paid out of contingencies;
 - (ii) who are appointed in the projects on contract basis in accordance with the project policy; and
 - (iii) who are appointed as Junior Clerk in the Elementary and Secondary Education Department by Government after 2013 through National Testing Service;
- (d) "Government" means the Government of the Khyber Pakhtunkhwa;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants;
- (f) "project" means,-
- (i) IT/Computer Teachers in Computer Labs Projects in Khyber Pakhtunkhwa (Phase-II);
 - (ii) establishment of five hundreds (500) IT Labs in Government High and Secondary Schools in Khyber Pakhtunkhwa; and
 - (iii) establishment of five hundreds (500) IT Labs in Government High Schools in Khyber Pakhtunkhwa (Phase-III); and
- (g) "teacher" means a teacher of primary, middle, secondary or higher secondary school.

(2) The expressions "adhoc appointment" shall have the same meaning as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No.XVIII of 1973).

3. Regularization of services of employees.---(1) Notwithstanding anything contained in any other law or rules, the employees, who hold posts till the commencement of this Act, shall be deemed to have been validly appointed on regular basis from the day of the **initial appointment**; provided that-

- (i) they possess the same qualification and experience required for a regular post;
- (ii) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act; and

(iii) the service promotion quota of all service cadres shall not be affected.

(2) The services of the employees shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. Determination of seniority.---(1) The employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

5. Overriding effect.--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.


1. That the appellant was appointed as SST vide order dated 28.04.2017 and posted at GSWIHS Pir Pai District Nowshera. Copy of order is attached as annexure-A
2. That ever since my appointment, I had performed my duties assigned to me with zeal and devotion and there was no complaint, what so ever regarding my performance.
3. That salary of the appellant was stopped due to verification of MA English degree and inquiry was initiated but the appellant was not associated with the inquiry proceeding nor handed over the inquiry report but vide letter dated 08.11.2018 appellant was informed to submitted original degree within 15 days.
4. That the petitioner filed writ petition in Peshawar High Court Peshawar for regularization and releasing of salaries. That on the direction of Peshawar high court Peshawar director E&SE wrote letter to HEC for verification of the degree of the Appellant.


ATTACHED

5. That HEC vide letter dated 24.12.2019 addressed to District Education officer male Nowshera verified the degree of appellant where after DEO issued clearance certificate and the salary of the appellant has been released. That interim relief was also granted to the appellant in shape of not to take adverse action against the appellant
6. That after 1 year when new District Education Officer came, he again sent the degree of the appellant for verification in response of which HEC replied by vide letter dated 10.12.2020 and disown the letter dated 24.12.2019 thereafter despite the interim relief the director E&SE withdraw the appointment order of the appellant vide order dated 8.3.2021 without any notice and hearing which is illegal and has nullity in the eyes of law
7. That the appellant being feel aggrieved from the order dated 8.3.2021 therefore filling this instant departmental appeal on the following grounds among others

Grounds:

- A. That the appellant have not been treated in accordance with law hence the appellant right secured and guaranteed under the law are badly violated.
- B. That no proper procedure has been followed before awarding appellant the major penalty, no proper inquiry has been conducted, the appellant have not been properly associated with the inquiry proceedings, statements of witnesses if any were never taken in the appellant presence nor the appellant have been allowed opportunity of cross examination, thus the proceedings so conducted are defective in the eye of law.
- C. that the degree of the appellant has been verified by the respondent from the concern institution and thus the same is valid for all purpose which was also further verified by the department himself through letter dated 9.12.2019 in response of which HEC verified the degree vide letter dated 24.12.2019
- D. that the appellant obtained degree of MA English from new port instate of communication and economic Karachi which is duly recognize from HEC so there is no fault on the part of the appellant



- E. that the appellant now also obtained MA English degree from other university also which may also be consider as fruitful attempt on the part of appellant
- F. That the appellant have been not allowed fair opportunity of personal hearing, thus the appellant have been condemned unheard.
- G. That the charges leveled against the appellant were never proved in the enquiry, the enquiry officer gave his findings on surmises and conjectures.
- H. That the appellant have never committed any act or omission with bad or malafide intentions which could be termed as misconduct, albeit the appellant have been awarded the penalty.



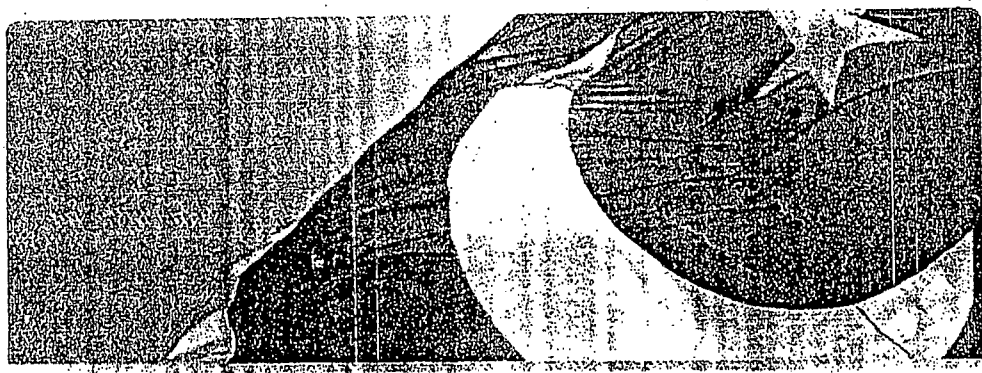

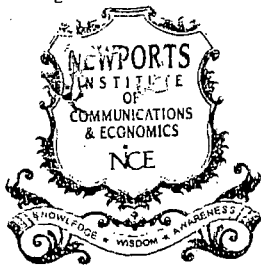

Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2017, and such rules & regulations as may be issued from time to time by the Government.

5. Their services are liable to termination on one month notice from either side, in case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
6. They shall have not resign from their services or terminated from services on account of misconduct, inefficiency or any other ground before the commencement of this Act.
7. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadre.
8. They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this Act are to be appointed to the cadre, irrespective of their actual date of appointment.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in case of two or more employees is the same, the employee older in age shall rank senior to the younger one.


