**SERVICE APPEAL U/S 4 OF THE service Tribunal ACT, 1974, FOR THE DIRECTIONS TO THE RESPONDENTS TO CORRECTLY WRITE THE REAL DATE OF BIRTH i.e.**

20/11/1961 OF THE APPELLANT IN THEIR  
RESPECTIVE RECORDS INSTEAD OF  
WRONGLY INCORPORATED IN THEIR  
RESPECTIVE RECORD I.E. 20/11/1958.

**Respectfully Sheweth:**

The appellant very humbly submits as under:

1. That the appellant was appointed as Patwari in the year 1988 and the real and correct date of birth of the appellant is 20/11/1961 but the respondents have wrongly incorporated it as 20/11/1958, which effects upon the legal rights of the appellant, in their respective records which needs correction for the interest of justice and best convenience of the appellant. (Copies of CNIC, Pay Roll, SSC Certificate, Birth Certificate, FA Certificate, Certificate of Patwar and his Service Book are attached as annexure "A" to "G" respectively).
2. That similarly the real date of birth of Muhammad Ayaz Khan (being real brother of the appellant) is 11/06/1964, so there is long gap of six years in between the ages of two real brothers which is

exceptionable and unnatural date of births, which is not normally possible to born babies from the same parents in such a long gap of six years which is liable to be corrected. (Copy of CNIC of Muhammad Ayaz is attached as annexure "H").

3. That this Hon'ble Tribunal has plenary jurisdiction to entertain the instant appeal and dispose it of according to the facts and circumstances of the present appeal.
4. That the appellant is ready for conducting his medical examination for determination of his real age/ date of birth by any kind of medical test whatsoever it may be through any Medical Officer as is deemed fit and appropriate by this Hon'ble Tribunal.
5. That appellant submitted an appeal before the respondent No. 7 on dated 15/11/2017 for correction of his date of birth, but the respondent No. 7 did not correspond/decide the appeal of the appellant till today, hence instant appeal. (Copy of



appeal dated 15/11/2017 is attached as annexure "I").

6. That in the same nature case, the Hon'ble Civil Judge-IX, Peshawar namely Asif Raza has given direction to the M.S of Police Services Hospital, Peshawar on dated 07/02/2018 for determination the age/ date of birth of one Salman Khan S/o Kamal Khan R/o Marokhel, Tehsil Lower Kurram, District Kurram Agency, by conducting medical test/ medical examination. (Copy of application and order dated 07/02/2018 are attached as annexure "J" respectively).

7. That in the light of judgments of superior Courts of Pakistan i.e. (1970 SCMR Page 30), (1992 MLD 991), (PLJ 2006 CRC Lah 941), (2012 SD 63), (2011 PcRLJ 920), (PLD 2002 Karachi 18) & (PLD 2009 Karachi 278) wherein it is held that age can be determine by X-Ray, Ossification Test or any other type of modern medical examination/tests for determination the real and correct date of birth of a person/citizen for the best convenience of justice and good governance of law.

8. That the act of the respondent no. 7 is contrary to Civil Servant Act, 1973 and as well as against the natural justice and good governance of law while not deciding the appeal dated 15/11/2017 of the appellant within the stipulated period, therefore, the appellant having no other remedy except of to come this Hon'ble Tribunal for redressal of his grievances on the following grounds, inter-alia:

**GROUND:**

- A. That the appellant is the peaceful and well abiding citizen of Pakistan has never ever violated any law, rule or regulations in his entire life.
- B. That the appellant is just declaring his real date of birth/ age through the Medical Examination/ Test by any Medical Officer of the country as legal and fundamental right under Article 19-A of the Constitution of Islamic Republic of Pakistan, 1973.
- C. That the non disposal of appeal dated 15/11/2017 by respondent No. 7, committed gross lethargy of

and committed illegality which needs to be corrected by this Hon'ble Tribunal.

- D. That the respondent No. 7 is bound under the law specially Section 4 of Civil Servant Act 1973 to dispose the appeal of the appellant within 60 days, but fail to do so, shows his incompetency in the instant matter.
- E. That this Hon'ble Tribunal has ample jurisdiction and authority to entertain the present appeal and disposed it of according to the facts and circumstances of the instant case.
- F. That other point will be agitated at the time of arguments under the permission of this Hon'ble Tribunal.

It is therefore, very humbly prayed before this Hon'ble Tribunal, that on acceptance of this appeal, the respondents may kindly be directed to correctly incorporate the real date of birth of the appellant i.e. 20/11/1961 instead of wrong entries i.e. 20/11/1958 which is made by the respondents in

their respective records about the real date of birth of the appellant, it is further prayed that the appellant may kindly be referred to any Medical Officer for conducting his medical examination/ tests for determination the real and actual date of birth/ age of the appellant or respondent No. 7 may kindly be directed to disposed of the already pending appeal of the appellant of dated 15/11/2017 for the ends of justice.

Any other relief may also be granted to the appellant and against the respondents for the best interest of justice, which is deemed fit by this Hon'ble Tribunal according to the facts and circumstances of the case in hand though which are not specifically asked for in the being appeal.

**Preliminary Objections:**

- i. The appellant has got no locus standai.
- ii. The appeal of the appellant is based on malafide.
- iii. That the appellant is estopped by his own conduct.
- iv. That the appeal is bad for mis-joinder & non-joinder of parties.

**Facts:**

1. That Para No.1 of the appeal is incorrect. That the appellant applied for MNIC in the year 1976 and obtained MNIC# 129-58-280350 and entered his date of birth as 18 years while applying for MNIC in his MNIC form. The appealant obtained CNIC with same particulars in the year 2005 and subsequently obtained Smart CNIC in the year 2018 and that has been correctly recorded in his MNIC,CNIC and SCNIC. **(Copy of RG-1 From, Smart CNIC forms are attached as Annexure "A" & "B")**
2. That Para No.2 of the appeal is incorrect. The gap in date of birth between two brothers is quit natural.
3. That Para No.3 of the appeal is incorrect.According to Serive Rules and Regulations a Government servant can modify his date of birth within two years after joining of his service whereas the appellant has not modify his date of birth within the stipulated period.
4. That Para No.4 of the appeal is incorrect. The appellant has applied for MNIC in the year 1976 and remain silent for quiet long period, therefore at this beleated stage the appellant cannot be referred to Medical Board for ascertainment of correct date of birth.
5. That Para No.5 of the appeal is not concerned with answering respondent# 2.

7. That Para No.7 of the appeal is not concerned with answering respondent# 2.
8. That Para No.8 of the appeal is incorrect.

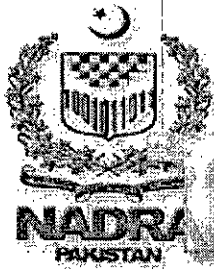
