**SERVICE APPEAL UNDER SECTION 4 OF
KPK SERVICE TRIBUNAL ACT, 1974.**

Respectfully Sheweth:-

That the facts forming the backgrounds of the instant service appeal are arrayed as under:-

1. That the appellant got appointment as PST at serial No.67 of the appointment order No.47946-18230 dated 21/02/2010 in the respondents department. Copy of appointment order dated 21/02/2010 is attached as Annexure "A".
2. That appellant as per appointment order reported at Govt. Primary School Sial Khan, where no post of PST was available. In this regard, copy of letter of respondent No.3 is attached as Annexure "B".

3. That the respondents department vide corrigendum order dated 19/03/2011 posted the appellant at GPS Tahra and the appellant took over the charge in the said school. Copies of corrigendum order dated 19/03/2011 and charge report of the appellant are attached as Annexure "C" & "D".

4. That the appellant came to know on 28/12/2013 that respondents No.4 to 91 have been shown seniors to the appellant. Therefore, the appellant filed departmental appeal on the same date i.e 28/12/2013. Following this, respondents department rejected departmental appeal of the appellant on 15/01/2018 which was received by the appellant on 30/01/2018. Copies of departmental appeal and its rejection order dated 15/01/2018 are attached as Annexure "E" & "F".

5. That feeling aggrieved, the instant service appeal is filed, inter-alia, on the following grounds:-

GROUNDS:-

- a) That as per settled principle of law that seniority of the employees is fixed according to the order of merit assigned to them at the time of their appointment and not from the date of assumption of charge. Therefore, the appellant is senior to respondents No.4 to 91.

- b) That as per law, seniority of the appellant is to be rectified according to the order of appointment and thereafter revise seniority list is to be issued after placing the appellant at the top of respondents No.4 to 91.

- c) That when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise. Besides, department is bound to follow the service law as well as follow the

dictum of superior courts on points of law.

- d) That respondents No.4 to 91 are blue eyed and have been placed senior to the appellant with malafide intentions.
- e) That placing of respondents No.4 to 50 seniors to the appellant is discriminatory, perverse, against the law and the same is liable to be reconciled/ rectified.
- f) That this fact may not be left to fade in oblivion that the respondents has led the appellant to the place which is utterly unknown to the principle of jurisprudence, natural justice and fair play.
- g) That the valuable rights of the appellant are involved.
- h) That there is no efficacious and adequate remedy available to the

appellant except the invocation of jurisdiction of this Honourable Tribunal.


- i) That other points shall be urged at the time of arguments.

It is therefore, humbly prayed that on acceptance of the instant service appeal, respondents department may graciously be directed to fix seniority of the appellant above the respondents No.4 to 50 and thereafter, revise seniority list of the PSTs may be issued.
