PRAYER: That on acceptance of the instant appeal the impugned appellate order dated 20.7.2022 may very kindly be rectified/modified by directing the respondents to restore the three annual increments of the appellant with all back benefits. That the respondents may further please be directed to treat the intervening period w.e.f. 8.6.2022 to 20.7.2022 as period spent on duty. Any other remedy which this august Tribunal deems fit that may also be awarded in favour of the appellant.

RESPECTFULLY SHEWETH:

- 1. That the appellant was appointed in the year 2014 and since his appointment the appellant was working with great devotion and honesty, whatsoever, assigned to him and no complaint has been filed regarding his performance.
- 2. That the appellant while serving as computer operator at Service Delivery Centre, Peshawar a charge sheet along with statement of allegation were issued to the appellant in which following charges were leveled against the appellant.

- i. That the appellant has deliberately contradictory Fardat in violation of law & rules with the consent, knowledge & authority of land owners.
- ii. That he deliberately did not verify the CNIC of the land owners, hence an embarrassment situations were created. Resultantly, a fake Power of Attorney was issued and registered involving of prevailing Rules and procedure.

7. That having no other remedy the appellant preferred the instant appeal on the following grounds amongst the others.


GROUNDS:

- A That the impugned orders dated 08.06.2022 and 20.7.2022 are against the law, facts, norms of justice and material on record, therefore, not tenable and are liable to be set aside/rectified.
- B. That inquiry conducted against the appellant was not according to the prescribed procedure as neither statements were recorded in the presence of the appellant nor gave him opportunity of cross-examination, which is violation of law and rules and as such the impugned orders are liable to be set aside on this ground alone.
- C. That no opportunity of defense was provided to the appellant during inquiry proceeding, which is violation of Article-10A of the Constitution of Pakistan.
- D. That the inquiry office did not conduct regular inquiry in order to dig out the realty about the matter by observing the reply to the charge sheet, even the inquiry report was not provided to the appellant, which is violation of law and rules.
- E. That the appellant has duty to issue Fardat to the land owner or theperson nominated by the land owner through power of attorney and on 26.04.2021 Sabz Ali S/O Abdul Hameed R/O of Sara sang came to the office of SDC and he has original CNIC of the land owner and the land owner also gave him power of attorney and after all the codal formalities the appellant issued the Fardat to Sabz Ali and in this respect he requested to the Sub Registrar to verify the actual owner of the land before registration of deed/power of attorney as per job description of the sub registrar, which shows that the appellant did not commit any misconduct and he has performed his duty as per rule and has been punished for no fault on his part.
- F. That it is the duty of the concerned Patwari to verify the concerned site and other issue about the property as court proceeding and after verification by the Patwari it is duty of concerned Sub Registrar to verify original CNIC, actual land owner before registration of deed/power of attorney and the appellant after issuing the fardat to Sabz Ali requested to the Sub Registrar to verify the owner of the land before registration of deed/power of attorney as per job description of the sub registrar, which shows that the appellant has performed his duty as per rules and has no malafide intention in the respect of issuing fardat to Sabz Ali.

- G. That the Sub Registrar-I has jurisdiction in the area of Kafoor Dheri, but Sub Registrar-II has registered the fake power of attorney but despite minor punishment has been imposed upon the sub registrar -II and sub registrar has transferred, while major punishment has been imposed upon the appellant by him as scope goat.
- H. That Patwari has continue contact with the Sbaz Ali through Cell Phone in this respect 223 outgoing calls and 221 incoming calls are traced through CDR by the Inquiry officer, which is evident from the inquiry report conducted by ADC Peshawar, but no action has taken against the patwari.
- I. That the power of attorney was canceled by the competent authority verification of power of attorney as the power of attorney was found fake and no loss was occurred to the Government Exchequer.
- J. That the appellant has also issued 23 Fardats measuring 1863 Kanal to the complainant party on the same way, but no objection has been raised by the authorities and all of them were approved by the authorities.
- K. That it is also the duty of the concerned Patwari and sub registrar to verify the fardat, but no action has taken against the Patwari and minor punishment of stoppage of increments has been imposed-upon the registrar, while the appellant has been discriminated by imposing major punishment of compulsory retirement from service has been imposed upon the appellant which is clear violation of Article-25 of the Constitution of Islamic Republic of Pakistan.
- L. That the appellate order dated 20.7.2022 is violative of E&D Rules, 2011 as well violative of FR 29, therefore the impugned appellate order is liable to be modified/rectified.
- M. That the appellant has condemned unheard throughout been and has been treated in accordance with law and rules.
- N. That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.



REPLY TO THE SHOW CAUSE. SUBJECT:

Kindly refer to your office letter No.LR-IV/Inquiry/Kafoor Dheri /238 R/sir. dated 12/05/2022 whereby show Cause has been served upon the applicant. In this context, may I allude to the explanatory application in Urdu version dated 01-04-2022 wherein certain facts have been incorporated for your kind perusal. However, let me put forward some more submissions for your perusal and sympathetic consideration as under:

- 1. That obviously, there is nothing on record to substantiate the charges leveled against me, besides there exists no mala-fide on the part of the applicant with regard to commission of the guilt(s) sufficient to incriminate me.
- 2. That from perusal of my detailed reply to the inquiry I have explained the whole episode of transaction and provision of Fardat. Copy of reply along with its English version are enclosed.
- 3. As regard to issuance of contradictory Fardats, reply already submitted to the Inquiry Officers may be considered as reply to this show cause notice as well where no irregularities is committed.
- 4. That during the entire period of service, I performed duties to the entire satisfaction of the superiors and the high-ups have never noticed about any sort of corruption on the part of the applicant.
- 5. That the mishap caused in the discharge of duties in public dealings might be result of misunderstanding amongst the complainant and applicant. Moreover, sensing the gravity of the situation, the issue with regard to annulment of Power of Attorney has since been settled and now there is no hitch or harm to any person, as to power of attorney and deed registered have been cancelled.
- 6. That let me add that the applicant in the capacity of Computer Operator as per his job description was duty bound to issue Fardat of a particular piece of land to the landlords or their representative being deputed for the purpose and such like mishap has never occurred Pertinent to apprise your kind honor that during my tenure round about 2000 Fardat were issued, however, no complaint has ever been noticed. As regards the instant mishap, in almost 23 mutations measuring 1863 kanals land, Fardat have been issued to the complainant party with no objection at all, detail of which is attached.

- 7. That instead of repetition, I deem it suffice and expedient to make my previous explanation as part and parcel of reply to the Show Cause.
- 8. That even then, if there is some omission on my part, I humbly request for pardon. I am sure that nothing wrong has been committed with mala-fide intention.
- 9. That I may kindly be heard in person to explain the matter before your good self with proof.

Forgoing in view, it is humbly requested that the show Cause served upon me may kindly be withdrawn and I may be exonerated from the charges leveled against me.

With profound veneration, it is submitted that the appellant was working as Computer Operator under your kind control since 04/08/2014 to the entire satisfaction of the immediate superior. On 26/04/2021, the appellant issued a Fard after fulfilling the following standard operating procedures.

> "Fard for Registry, Bank Loan, Court Guarantee or any other transaction can only be obtained by the land owner or his authorized representative, after completion of the codal formalities i.e."

- Production of Computerized National identity Card (CNIC)
- b. Requisite Fee deposition in Bank.

A fact finding inquiry was conducted against the appellant on the ground of violating the rules and regulation.
