

This appeal has been preferred to impugn the order dated 21.12.2021, whereby the appellant has been transferred from Irrigation Sub Division, Haripur to Irrigation Sub Division (Shinkiari Section) purporting the transfer being in the best public interest. The remarks column in the impugned order is blank and thus it is not clear that the post against which the transfer has been made is vacant or otherwise. According to the designation of the appellant given in the impugned order, he is Work Munshi and as per contention of the learned counsel this is a post in BPS-02. Whether the transfer of holder of such post from one Sub Division to the other Sub Division has any expediency, need arguments from both sides. The appeal is admitted for regular hearing subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments on 18.02.2022 before S.B at Camp Court Abbottabad.
