

**APPEAL UNDER SECTION -4 OF THE KHYBER PAKHTUNKWA SERVICE TRIBUNAL ACT, 1974 AGAINST NON-ISSUING OF FINAL SENIORITY LIST SINCE, 2017 TO 2022 AS WELL AS GRANTING UNLAWFUL, ILLEGAL AND IRREGULAR PROMOTIONS TO RECRUIT COURSE UNQUALIFIED/JUNIOR OFFICIALS ON THE BASIS OF SO CALLED/ UNSANCTIONED TRADES/ INCOMPLETE DISREGARD OF SENIORITY AND IGNORING THE APPELLANT FROM PROMOTION TO THE NEXT HIGHER RANKS AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL WITHIN THE STATUTORY PERIOD OF NINETY DAYS**

**Prayer:**

That on acceptance of this appeal the respondents may kindly be directed to issue final seniority list according to initial appointment/absorption and in light of Section-8 of the Civil servant Act, 1973 read with rule 17 of the appointment, promotion and transfer Rules, 1989. That the illegal, unlawful and irregular promotions granted to unqualified/ junior officials on the basis of so called/unsanctioned trades may kindly be set aside. That the respondents may further please be directed either to grant/allow seniority to appellant from the date of initial appointment in the tele unit or in the parent unit along with their original batch mats with all back benefits in accordance to section-8 of the Civil servant Act, 1973 read with Rule 17 of the APT rules, 1989. Any other remedy which this

august Tribunal deems fit that may also be awarded in favour of the appellant.

1. That the appellant was recruited as constables in FRP Unit of KPK Police, transferred to Police Telecommunication Unit and consequently permanently absorbed in the Police Telecommunication unit by the competent authority and placed in the seniority list at the bottom, performing his duty since 17/18 years in the Police Tele Unit up to the entire satisfaction of superior. Copies of the initial appointment and transfer order are attached as annexure .... **A & B.**
2. That the applicant is qualified Basic Recruit course as well as Special Wireless Telegraphy Course which are pre-requisite/mandatory for the Police Telecommunication Officials, in addition to, the appellant is qualified A, B, C courses which are mandatory for promotion of Police Telecommunication officials,
3. That SSC qualification, seniority cum-fitness, basic recruit course and wireless Telegraphy course are pre-requisite and mandatory for promotional exam and promotion, the appellant fulfill the above-mentioned criteria.
4. That the appellant having 17/18 years' service, with unblemished service record was/is fit for promotion in all respect, but is still constable and even a single promotion has not been given to the appellant.
5. That It is pertinent to mention here that due to non-implementation of supreme court of Pakistan judgments in Police Tele unit, the appellant and others officials of Police Tele unit by compulsion have instituted writ petitions 2259/2019, 2290/2021 Rahid Gul vs Govt of KPK and others and Saleem Shah vs govt of KPK and others in Peshawar High court against the unlawful and out turn promotions of police Tele Unite
6. That the appellant is still constable have never got out of turn promotion but the respondents mala-fide included the name of the appellant in the list of out of turn promotion instead of the names of those officials who got unlawful and out of turn promotions on computer and others so-called Trades.
7. That the Tele unit vide letter No. 5872/Tele/OHC dated 22.4.2022 and letter No. 9931/Tele/OHC date 27-8-2022 for legal opinion for promotions (**Copies Of Letters Enclosed As Annexure .....****C**)
8. That the appellant was stopped from promotion vide letter No. CPO/CPB/253 dated 24-8-2022 (**Copy enclosed as annexure D**) on the pretext of out of turn Promotions, but astonishing that the appellant has not been given even a single promotion in the 17 years serves till date.

- 9.** That juniors and recruit course unqualified officials have been granted illegal, unlawful and irregular promotions on the pretext of so called/unsanctioned trades.
- 10.** That Supreme Court of Pakistan vide its judgments 2013 SCMR 1752, 2017 SCMR 206 and intra court appeal 26-1-2016 and 31-5-2018 clearly directed that all illegal, unlawful and out turn promotions granted either to police personnel on gallantry award or otherwise may be set-aside and cancelled and their seniority be re-fixed along with their original batch mates
- 11.** That the above-mentioned directions were circulated by the Inspector General of Police KPK to all heads/unite in various time vide **enclosed letters are attached as annexure ..... E.**
- 12.** That the judgments of august supreme Court were/is not followed/implemented in the Police Tele Unit.
- 13.** That the respondents granted further illegal and out of turn Promotions to junior officials in 2018, 2019 and 2020 despite the clear cut Directions of august supreme court of Pakistan regarding out of turn promotion and even without issuing final seniority list in the same years. Move over, the Tele unit has not issued final Seniority list according to prescribed rules and law till date.
- 14.** That the respondents donot follow the rules/law and seniority, and invariably grants illegal unlawful Promotions to junior and unqualified officials in deviation of rule and law.
- 15.** That, the Tele unit has not issued seniority list since 2017 according to prescribed rules and law, notwithstanding junior and recruit course unqualified/illiterate officials have been granted illegal/unlawful and out of turn promotion after promulgation of 2017 Police Act in deviation of rules and law. (**SeniorityList enclosed as annexure .....F**)
- 16.** That the D.P.C Committee consisting of **Superintendent Ibrahim Shah** and others invariably/always rendered recommendation of junior and recruit course unqualified/illiterate officials to Deputy Inspector General of Police Telecommunication in disregard of rules and law.
- 17.** That the Deputy Inspector General of Police Tele has directed in the Minutes of DPC 2018 to SRC to give recruit course qualified certificate of the officials who are included/recommended by the DPC member for promotion, the SRC mislead/misguide the Deputy Inspector General Tele regarding the officials who are included in the DPC minutes of 2018 who are unqualified Basic recruit course. (**Copy of minutes enclosed as annexure ..... G**)

- 18.** That no sanctioned strength of each separate Trades are available on the budget Book as well as no Approval of Provincial Government and Inspector General Police in respect of so-called trades is available on record. All the trades in the Police Tele unit are established for the purpose of duty not for the purpose of promotions but the juniors official have been granted illegal, unlawful promotions on the so called trades. (**Copy of budget Book as annexure ..... H**)
- 19.** That ASI Turab Khan of Police Tele Establishment, granted out of turn/illegal/irregular promotion on the basis of so-called computer trade, he was reverted to his substantive rank vide order No. 4286-4300, the said Asi challenge his reversion order in Khyber Pakhtunkhwa Service Tribunal but the service Tribunal dismissed the appeal of the ASI Trub khan, (copy of order and tribunal judgment enclosed) the said Asi challenge the khyber Pakhtunkhwa judgment in August Supreme court of Pakistan vid C.P No. 754/2019 but the August Supreme court rejected the Civil Appeal of the petitioner and maintained the Judgment of Khyber Pakhtunkhwa service Tribunal, (**copy of reversion order, judgment of service tribunal enclose as annexure ..... I**)
- 20.** That astonishing that the remaining Three ASIs, recruited in the year 2002, most junior to substantial portion of officials, granted promotion on the basis of computer Trade are still serving on their unlawful and illegal positions,
- 21.** That ASI Liaqat Ali recruited as Constable wireless operator in 2002 converted his trade from wireless operator to computer operator through fake and forfeited way in 2005 through internal manipulation and connivance got illegal promotion in deviation of rules and law, (**copy of bogus trade conversation order is enclosed as annexure ..... J**)
- 22.** That ASI Imran recruited as constable wireless operator in 2002 converted his trade from wireless operator to computer operator through internal manipulation and connivance got illegal promotion in deviation of rules and law, in this respect it is submitted that seniority cum-fitness, recruit course is prerequisite and mandatory for promotional exam and promotion, but the same were not followed, the said Asi promoted without seniority and recruit course.
- 23.** That Head Constable Atif Mujeeb appointed as civil helper in BPS-I in the year 2012 at the time of appointment he was overage and under matic and did not fulfill the criteria for constable but instead of that he was promoted to constable in BPS-5 in 2013 and then promoted to head constable in complete deviation of rules and law.
- 24.** That Head Constable Muhammad Inam appointed in the year 2010, on unsanctioned post as service man, at the time of appointment he

was overage and through internal manipulation converted his trade to constable Store man and then promoted as head constable in complete deviation of rules and law.

- 25.**That on the one hand the department appointed illiterate and unqualified officials and on the other hand promoted in complete deviations of rules and law.
- 26.**That the appellant feeling aggrieved from the action and inaction of the respondents filed departmental appeal which has not responded till date. Copy of the departmental appeals is attached as annexure.....**K.**
- 27.**That HC/1063 Rahat Gul, at serial No.48 completed his Recruit Course in the year 2019 and astonishingly, he has been selected for the course of Intermediate in September, 2022 for next promotion. Copy enclosedand other relevant documents are attached as annexure .....**L.**
- 28.**That the dealing hands of police Tele unite, i.e. **Superintendent Ibrahim Shah** including out of turn promoted official **ASI Liaqat Ali, ASI Nadeem and ASI Imran, SRC Clerk Israr Ahmad and many others** are, posted on key positions in police Tele Headquarters since long, by internal manipulation and connivance mislead/misguided and kept the high ups in dark and concealed the real matter of out of turn promotion from them and they are transferred only in paper/ documents, the policy of the government in respect of transfer posting are not followed in the tele unit.

It is therefore humbly prayed that the above mentioned appeal may kindly be accepted as prayed for.



In this regard it is submitted that the subject case was forwarded to AIG/Legal/CPO for legal opinion. The remarks of AIG/legal are reproduced below:-

1. The case of officers/officials absorbed/inducted from other districts/units in the Telecommunication may not be considered for promotion till the outcome of Supreme Court decision in the case of out of turn promotions.
2. In regard to the case of three ASI of Computer Cell, a letter has already been submitted vide this office memo No. CPO/CPB/217 dated 24.05.2022 that writ petition has been filed. The matter is sub-judice in the Peshawar High Court, hence, the case may be kept pending till the decision of the court.

Memo:	<p>It is submitted that the appellants, namely, Muhammad Ijaz, Muhammad Tariq, Faizur-Rahman, Hanayim Khan, Nazeer Muhammad and Shabir Ahmad (Computer Operator), while serving as ASIs/SI in Investigation CPO, were reverted to their substantive rank of Constables by the then Addl. IGP/Investigation Khyber Pakhtunkhwa Peshawar vide order dated 29.01.2014 because it was found that they have not undergone the basic promotion courses i.e. lower intermediate and were promoted in violation of rules.</p> <p>The above mentioned officers filed Service Appeal No. 561, 562, 563, 537, 715 &amp; 536/2014 respectively, which were vide consolidated Judgement 16.11.2015 as referred to above. The relevant para of the judgement review is as follows:</p> <p><i>"This cannot be disputed that the Crimes Branch is part and parcel of the Khyber Pakhtunkhwa police, being regulated by its rules for the purpose of promotion and maintaining the seniority list. Evidently this aspect of the matter was lost sight by the concerned officers who passed the preliminary orders. In any of the issue is that the appellant has served on the promoted post for sufficient time in the course of which they also received, emoluments but nobody took notice of the same. This being so it would be also true if the impugned cancellation order are issued based on whims, likes and dislikes and plots and chosen as alleged by the appellants that HC Shafiqullah and Mujahid Hussain were left untouched. Since departmental appeal of the appellant has also not been responded, therefore, the Tribunal of the considered view that further indulgence by the Tribunal at this stage may cause further complications. Hence the appeal is remitted to the appellate authority with the direction to examine appeals of the appellants and decide the same strictly on merits without any discrimination".</i></p> <p>Meeting of the Appeal/Review Board was held on 02.03.2016, and the appellants were heard in person. The cases were perused; lists obtained from Addl. IGP/Investigation, Khyber Pakhtunkhwa Peshawar was also perused/examined by the board. The Board decided that all promotions in the Investigation Wing/Computer Section as well as other Units have been done against law and rules. Therefore, the cases of these Constables may be filed with the recommendation that all such promotions in the light of the Supreme Court of Pakistan decision on out of turn promotions be cancelled.</p> <p>This order is passed in the light of judgement of Service Tribunal Khyber Pakhtunkhwa Peshawar that all promotions in the Investigation Wing, Sls, ASIs, DCOs &amp; Constables as well as other Units of Police have been done against law and rules may be set aside/cancelled. All such promotions in the light of the Supreme Court of Pakistan decision on out of turn promotions may also be cancelled.</p>

It is submitted that appellants Muhammad Ijaz, Muhammad Tariq, Fazl-ur-Rehman, Hamayun Khan, Nizar Muhammad and Shabir Ahmad (Computer Operator), while serving as ASIs/SI in Investigation CPO, were reverted to their substantive rank of Constables by the then Addl; IGP/Investigation, Khyber Pakhtunkhwa, Peshawar vide order dated 29.01.2014 because it was found that they have not undergone the basic promotion course i.e lower Intermediate and were promoted in violation of rules.

The above mentioned officers filed Service Appeal No. 561, 562, 563, 537, 715 & 538/2014 respectively, which were vide consolidated judgment 16.11.2015 as referred to above. The relevant para of the judgment review as follow:

*"This cannot be disputed that the Crimes Branch is part and parcel of the Khyber Pakhtunkhwa police, being regulated by its rules for the purpose of promotion and maintaining the seniority list. Eventually this aspect of the matter was lost sight by the concerned officers who passed the promotion orders, irony of the issue is that the appellant has served on the promoted post for sufficient time in the course of which they also received enrolment but nobody took notice of the same. This being so it would be also irony if the impugned cancellation order are found based on likes & dislikes and pick and choose as alleged by the applicants that HC shafiullah and Mujahid Hussain were untouched. Since departmental appeal of the appellant has also not been responded, therefore, the Tribunal of the considered view that further intelligence by the Tribunal at this stage may cause further complications. Hence the appeal is remitted in the appellate authority with the direction in examine appeals of the appellants and decide the same strictly on merits without any discrimination."*

Meeting of the Appeal/Review Board was held on 02.03.2016, and the appellants were heard in person. The cases were pursued; lists obtained from Addl; IGP/Investigation, Khyber Pakhtunkhwa, Peshawar was also perused/examined by the board. The Board declared that all promises in the investigation Wing/Computer Section as well as either Units have been done against law and rules. Therefore, the cases of these Constables may be filed with the recommendation that all such promotions in the light of Supreme Court of Pakistan decision on out of turn promotions may also be canceled.

JUDGMENT

AHMAD HASSAN, MEMBER. - Arguments of the learned counsel for the  
parties heard and record perused.

ARGUMENTS

2. Learned counsel for the appellant argued that he joined the Police Department as constable (Wireless Operator) on 15.01.1978. After undergoing computer training course in 1995, he was posted in the newly created computer cell of police Telecommunication Unit. He was promoted to the rank of Head Constable (Incharge computer cell) w.e.f 01.07.1995 vide order dated 12.07.1995. That on creation of the post of ASI in the above organization and after clearance DPC in its meeting held on 25.04.2003, he was recommended for promotion to the post of ASI. It was notified on 30.04.2003. However, vide impugned order

dated 09.04.2018, he was reverted to his substantive rank of Head Constable. The sole ground of his reversion was out of turn promotion as ASI. The appellant is at the verge of retirement and will reach the age of superannuation on 28.02.2019. He preferred departmental appeal on 16.04.2018 which was regretted on 09.07.2018. Learned counsel for the appellant further argued that it does not fall in the ambit of out of turn promotion and principle of locus-poententiae is also attracted in this case.

3. On the other hand learned Deputy District Attorney argued that the appellant was granted out of turn promotion as Head Constable as well as ASI. A computer cell was established to computerize the system of repair of wireless workshop in Peshawar and not for the purpose of promotion. No sanction/approval of the post of Computer Operator/cadre was available on record/budget book. The Police Telecommunication Unit was basically a signal Unit in which officials were promoted on the basis of seniority-cum-fitness and undergoing Basic Recruit /WT/ABCD course. No vacancy of ASI had ever been created/sanctioned in the computer cell. The appellant got out of turn promotion in utter disregard to the laid down procedure. He was reverted to his substantive post in the light of the judgment of the Supreme Court of Pakistan dated 26.01.2016 and 13.05.2018.

#### CONCLUSION

4. We have examined the available record and observed that the appellant got promotion as Head Constable and ASI without undergoing the required courses which are pre-requisite for promotion in Police Telecommunication Unit. Proper sanction/approval of Computer post/cadre is not available in the record of the

respondents and budget book. Moreover, the vacancy of ASI was never created/sanctioned in the aforementioned computer cell. The staff in Police Telecommunication Unit is recruited as Constable(Wireless Operator) are promoted on the basis of seniority-cum-fitness qualifying Basic Recruit/WT/ABCD course. To cut short the long story, it is evident from the record that he got out of turn promotion which was held to be illegal/unlawful by the Supreme Court of Pakistan in its judgment dated 26.01.2016 and 13.05.2018.

5. As a sequel to above, the appeal is dismissed. Parties are left to bear their own costs. File be consigned to the record room.

The applicants begs to submit as under

1. That the applicants were recruited as constables in various Districts/Unit of KPK Police, transferred to Police Telecommunication Unit and consequently permanently absorbed in the Police Telecommunication unit by the competent authority and placed in the seniority list at the bottom.
2. That the applicants are qualified Basic Recruit course as well as Special Wireless Telegraphy Course which are pre-requisite/mandatory for the Police Telecommunication Officials, in addition to the applicants are qualified A, B, C courses which are mandatory for promotion of Police Telecommunication officials,
3. That SSC qualification, seniority cum-fitness, basic recruit course and wireless Telegraphy course are pre-requisite and mandatory for promotional exam and promotion but the same was not followed in the police Tele unite.
4. That in Police Telecommunication, Juniors official have been granted out of turn promotions on computer trade and other deferent pretext in complete deviations of rules and law(**list of out of turn promoted officials and seniority enclosed**)
5. That Supreme Court of Pakistan vide its judgments 2013 SCMR 1752, 2017 SCMR 206 and intra court appeal 26-1-2016 and 31-5-2018 clearly directed that all illegal, unlawful and out turn promotions granted either to police personnel on gallantry award or otherwise may be set-aside and cancelled and their seniority be re-fixed along with their original batch mates
6. The above-mentioned directions were circulated by the Inspector General of Police KPK to all heads/unite in various time vide enclosed letters.
7. That the judgments of august supreme court were/is not followed/implemented in the police Tele unit due to internal manipulations and connivance of dealing


hands and dealing hands always send misinformation to CPO and concealed the real matter of unlawful and out turn promotions from the high ups.

8. That the dealing hands of police Tele unite, i.e. **Superintendent Ibrahim Shah** including out of turn promoted official ASI Liaqat Ali, ASI Nadeem and ASI Imran and others recruited in the year 2002, are most junior to hundred of officials, got out of turn promotion on the pretext/bogus computer trade and bogus A,B,C courses, posted on key positions in police Tele Head quarters since long, by internal manipulation and connivance mislead/misguided and kept the high ups in dark and concealed the real matter of out of turn promotion from them and they and other junior officials who have got unlawful, illegal and out turn promotions are still serving on their unlawful positions which are against the rules/law and continues contempt of august court orders and violations of inspector General of Police instructions.
9. That the Dealing Hands concealed the real matter of out of turn promotions and kept the high ups in dark, sent misinformation to CPO and granted further illegal and out of turn Promotions to junior officials in 2018, 2019 and 2020 despite the clear cut Directions of august supreme court of Pakistan regarding out of turn promotion and even without issuing seniority list in the same years. Mover over the Tele unit has not issued final Seniority list according to prescribed rules and law till date.
10. That It is pertinent to mention herethat due to non implementation of supreme of Pakistan judgments in Police Tele unit, most of the officials of Police Tele unit by compulsion have instituted writ petitions 2259/2019, 2290/2021 Rahid Gul vs Govt of KPK and others and Saleem Shah vs govt of KPK and others in Peshawar High court against the unlawful and out turn promotions of police Tele Unite.
11. That the applicants are still constables have never got out of turn promotions but the dealing hands of police Tele Unit have sent misinformation to CPO including the name of the applicants instead of the names of those officials who got unlawful and out of turn promotions only for the concealment of out of turn promoted officials and their wrong doings.
12. That the above-mentioned dealing hands invariably mislead/misguide and kept the high ups dark in respect of out of turn promotions and send misinformation to CPO and conceal the real matter of their out of turn promotions due to their long standing posting on key position in the Tele head quarters.
13. That due to internal manipulation of the abovementioned dealing hands, the Tele unit has not issued seniority list since 2017 according to prescribed rules and

law, notwithstanding junior and recruit course unqualified/illiterate officials have been granted illegal/unlawful and out of turn promotion after promulgation of 2017 Police Act in deviation of rules and law. (List enclosed)

14. That the D.P.C Committee consisting of **Superintendent Ibrahim Shah** and others invariably/always rendered recommendation of junior and recruit course unqualified/illiterate officials to Deputy Inspector General of Police Telecommunication in disregard of rules and law.
15. That the Deputy Inspector General of Police Tele has directed in the Minutes of DPC 2018 to SRC to give recruit course qualified certificate of the officials who are included/recommended by the DPC member for promotion, the SRC mislead/misguide the Deputy Inspector General Tele regarding the officials who are included in the DPC minutes of 2018 who are unqualified Basic recruit course. (Copy of minutes enclosed)
16. That AsiTurab Khan of Police Tele Establishment, granted out of turn/illegal/irregular promotion on the basis of so-called computer trade, he was reverted to his substantive rank vide order No. 4286-4300, (copy of order and tribunal judgment enclosed) As annexure D
17. That on the one hand the department appointed illiterate and unqualified officials and on the other hand promoted in complete deviations of rules and law.
  - I. It is therefore, most humbly prayed that the names of the applicants may kindly dropped from the list sent by the Tele unit and may be implemented the judgment of august Supreme Court on the officials who have got unlawful and out of turn promotions.
  - II. Inquiry may kindly be conducted against the dealing hands of Tele unit who kept the high ups in dark in respect of out of turn promotions and sent misinformation to CPO for the ends of justice please.

(The applicants have sent this application to your good self, through TCS on 08/02/2019 but no response received to the applicants, therefore is sent again for your kind perusal and redressal of grievances of the applicants.) (TCS slip is enclosed)

Respected Sir,

The applicants beg to submit as under.

1. That the applicants and many others officials were recruited as constable wireless operator in the years 1998/2000 respectively, have passed Basic Recruit Course in the Police Training College Hangu/Kohat etc and completed 06 months WT Course in the established WT School Peshawar, having 20/21 years service but unfortunately are still constable and waiting for promotion on their own turn. (Copy of seniority list ~~form 7H~~ enclosed as annexure "A")
2. That during the course of his duty the applicant No.1 got LLB Degree through departmental permission; the applicant is law graduate working diligently up to the entire satisfactions of his superiors. The applicant was nominated/assigned the task to carry out the court cases of Police Telecommunication in consultation with AIG/Legal CPO Peshawar in addition to his own duty vide order no. 10769-73/Tele/OASI dated Peshawar the 16/08/2016.
3. That in pursuant to above order, the applicant assist the department in legal matters in collaboration with AIG Legal CPO Peshawar, having sufficient computer knowledge/well versed of computer duty as well as working on computer as well in Police Telecommunication unit but is still constable and waiting for promotion on his own turn.
4. That Police Telecommunication unit is a signal unit from the very begging in which the officials, initially/basically are recruited as Constables/Wireless Operators and promoted on the basis of seniority Cum- fitness, i.e. after passing Basic Recruit Course in the Police Training College Hangu/Kohat etc. as well as completing 06-month Wireless Telegraphy

Course in the established WT School Peshawar, the seniors officials are called for list A. B. C. courses of promotion respectively, and after qualifying the course, the successful candidates are promoted subject to the availability of vacancies.

5. That in Police Telecommunication different nature/kind of duties is assigned to officials according to their skills and qualification. They are not entitled to be granted promotion on the basis of nature/kind of duties.
6. That according to the laid down law and rules, promotion is granted to the officials according to initial appointment and seniority cum-fitness.
7. That juniors most officials who initially/basically were recruited as Constable/Wireless Operator in 2002/2012 have gotten, out of turn promotions on the pretext of fake/forged computer cadre and other so called cadre due to internal manipulations and collusion which is Mala fide, illegal, against rules/law, against the fundamental rights of the Telecommunication staff, against the principles of natural justice against the Islamic injunctions. (List enclose as annexure B).
8. That no law, rules and standing orders is existed in respect of the of self-created computer cadre, no sanction/approval as well as sanctioned strength of computer cadre and other so called cadres are available on record/budget book on which junior most officials have gained.out of turn promotion. (Copy enclosed) as annexure "C"
9. That Police Telecommunication is a Signal Unit from the very begging, in which, Seniority Cum-Fitness, Basic Recruit Course, WT Course is prerequisite for promotion.
10. That most of the officials are not qualified Basic Recruit Course, WT Course, notwithstanding they have acquired illegal, unlawful, irregular promotions which is unconstitutional and against the rules.
11. That junior official have adopted short cut way for promotion and usurped the rights of most senior officials which is against law/rules, unconstitutional, unislamic, against the fundamental rights of the Police Telecommunication staff and against the principles of natural of justices.
12. That the officials who were initially appointed as Constables/Wireless Operators in 2002/12 which are most junior to the applicants and hundreds of official, have been granted out of turn promotions on the pretext of fake/forged and self-created computer cadre and other so called cadres on the basis of favoritism, pick and choose, like and dislike, which is illegal, unconstitutional, unislamic and violation of the of supreme court of Pakistan orders.
13. That taking A.B.C test of promotion from few favored junior officials instead of qualified seniors officials without any cogent reason, only for granting out of turn promotion on baseless and unjustified A.B.C test, is ridiculous and clearly reveal, liking and disliking, pick and choose, favoritism as well as discrimination on the part of department, which is

unconstitutional, unislamic, against the fundamental rights of seniors officials and violation of apex court orders.

14. That Junior officials, who have been called, out of turn for the test of A, B, C, D, courses instead of senior officials without any cogent reason and have been granted out of turn promotions, must probably on the basis of favoritism, liking and disliking, pick and choose, are liable to be reverted to their substantive rank in compliance with the Judgment of Honorable Supreme Court of Pakistan.
15. *That the Honorable Supreme Court of Pakistan vide its judgments 26/01/2016 and 31/05/2018 clearly directed that all out of turn promotion granted to either to the police personnel on gallantry award or otherwise shall be undone within four weeks from today and their seniority be re-fixed with their batch mats in terms of the directions contained in the previous judgments.*
16. *That the Inspector General of Police, Khyber Pakhtunkhwa vide order No. S/2262-2312/16 dated Peshawar the 23-03-2016, reverted those officials who were granted, out of turn promotions serving as SIS/ASIS and HCS, to their substantive rank of constables in the light of Supreme Court judgment.*
17. *That the above mentioned order was not materialized in the Police Telecommunication Unit so far, due to internal manipulation and connivance of the dealing hands.*
18. That the dealings hands of Police Telecommunication kept the highs ups in dark regarding out of turn promotion of Police Telecommunication and the officials who have obtained out of turn promotion are still serving on the promoted rank which is against law/rules and unconstitutional, against the injunctions of Islam as well as contempt of judgments of apex court of Pakistan.
19. That astonishingly, the junior officials who have once been granted out of turn promotions as HCs on the basis of pick and chose, like and dislike, further granted out of turn, irregular, illegal and unlawful promotion as officiating ASIs vide order No. 31, dated 17/01/2019, is unconstitutional, unislamic, against the principal of natural justice as well as consecutive violation of apex court orders.(Order enclosed as annexure D)
20. That if the practice/concept of out of turn, irregular, unlawful promotions continue, it will become a convention. Because a chain of out of turn, irregular and unlawful promotions is existed in the Police Telecommunication Unit and they will have to be promoted too in future on the analogy of vides order No.31 dated 17/1/2019 which is unconstitutional, unislamic, against the fundamental rights of Police Telecommunication Staff and violation of the apex court orders.
21. That the junior officials who have been granted out turn promotion on baseless and unjustified A.B.C.D courses are liable to be reverted to their substantive rank in compliance with the Honorable Supreme Court orders.

22. That the applicants submitted an application on 15/01/2019, requesting therein for not granting further out of turn/irregular promotions to junior officials but to little avail. It is pertinent to mention here that earlier too the applicant has submitted a series of application in the subject matter but no response received to the applicant.
23. That if the promotion is given/justified on the basis of assigned task/nature of duty to junior officials. The applicant No. 1, is eligible/entitled to be promoted as SI on the vacant posts of Sub -Inspector according to his qualification and of assigned task/ nature of duty. It is pertinent to mention here that one constable of this unit namely **Tahir Khan** recruited in 1998, is PhD holder and working in FSL Peshawar according to his qualification, but is still constable and waiting for promotion on his own turn like the applicant.

In view of the above, it is humbly prayed, that the:-

- A. Junior officials who have attained out of turn promotions on the pretext of fake/forged and self created computer cadre and other so called cadres may kindly be set-aside/canceled and reverted them to their substantive rank of constable in the light of Honorable Supreme Court orders and placed them in the seniority list in accordance with the date of their initial appointment and re-fixed their seniority along with their batch mates in the light of apex court orders for the ends of justice and fairplay please.
- B. That the impugned order No. 31, dated 17/1/2019 may very kindly be cancelled/set-aside to the extent of junior officials.
- C. If the promotion is justified on the basis of kind/nature of duty, the applicant No.1 may kindly be promoted on the vacant post of Sub-Inspector according to his qualification and assigned task/nature of duty.
- D. That the applicants may kindly be allowed to advance other grounds during hearing.
