





**Respectfully Sheweth,**

The appellant most respectfully submits as under:

- 1) That the appellant appointment was made in the year 1986 i.e. on 22.03.1986 as Field Assistant BPS-6.
- 2) That with the due passage of time, the appellant was promoted to BPS-09 and the seniority list was thereupon maintained.
- 3) That the appellant has successfully completed Short course of 6 Months in Agriculture from Agricultural Research Institute, Tarnab, Peshawar. (Copy of course completion certificate is attached as annexure A)
- 4) That the authority has promoted the Field Assistant but appellant was not promoted. (Copy of notification is attached as annexure B)
- 5) That previously the appellant was on at Serial No. 60 of Old Seniority List but astonishingly in the New Seniority List the appellant name has been excluded which is against the fundamental rights of the appellant. (Copies of Seniority List are attached as Annexure C)
- 6) That on 16.01.2018 the appellant moved an application before the concerned authority for his

promotion and again on 05.10.2021 the appellant moved an application before the concerned authority but the same was fruitless till date. (Copies of applications are attached as Annexure D)

- 7) That the appellant moved another application / departmental appeal before the respondent No. 2, but till date it was fruitless. (Copy of application / departmental appeal is attached as Annexure E)
- 8) That feeling aggrieved of the above said Sonority List the appellant approach this hon'ble tribunal, inter alia, upon the following amongst other grounds.

#### **GROUND**

- a) That appellant has served the department for more than almost 33 years with unblemished service.
- b) That the entire service career of the appellant is clean and neat and no bad remarks or any sort of stigma is ever been available.
- c) That keeping in view his lengthy service, best professional abilities but even then deferring him from the promotion is a grave miscarriage of justice.
- d) That deferring the appellant from the promotion is against the relevant section of Service Law as well as against the Fundamental rights of the appellant.
- e) That appellant has always performed his duties with keen interest and now he is at the verge of retirement and the Government Servant always look for his

promotion to get pension benefits for the benefits of his family.

- f) That no bad remarks, bad entries, warning, sensure, penalties is ever available on PER but the Departmental Selection Committee and Competent Authority did not bothered to gone through all that aspects and deferred the appellant from promotion upon flimsy reasons.
- g) That other Field Assistants of the same were promoted, but appellant has been deprived from promotion which is dissemination and injustice.
- h) That in the year 1983 in the same situation other candidates had been promoted to upper scale on the basis of short course, therefore the appellant also deserve to be promoted. (Copy of document is attached as Annexure F)
- i) That any other ground will be taken and the time of arguments.

It is, therefore, most humbly prayed that on acceptance of instant appeal, the appellant may graciously be awarded promotion from 25.02.2020 with all back benefits. Any other relief which this hon'ble court deem proper and fit in the circumstances of the case may also be granted in favour of the appellant.
