That on acceptance of this appeal the impugned orders dated 17.8.2018 & 25.9.2018 may very kindly be set aside and the respondents may be directed to restore the appellant on the post of Tehsildar (BPS-16) with all consequential back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1-That appellant was initially inducted/ appointed as Assistant the Department in respondent on the proper recommendation of the Departmental selection committee vide office order dated 22.6.2006. Copy of the appointment order is attached as annexure A.
- That according to the service structure of the respondent 2-Department Notified on 23.1.2015 twenty percent promotion quota was allocated for the cadre of Assistant

- 4- That lastly vide office order dated 21.2.2018 the appellant posted against the vacant post of political Tehsildar FR Bannu. That in response to the said order the appellant started his duty at the concerned station efficiently. Copy of the order dated 21.2.2018 is attached as annexure F.
- 6- That appellant feeling aggrieved from the impugned order dated 17.8.2018 filed Departmental appeal and where after filed writ petition No.4172/2018 before the Peshawar High Court Peshawar but the same was withdrawn by the appellant with the permission to approach the proper forum vide judgment dated 5.9.2018. Copies of the Departmental appeal and judgment are attached as annexure H & I.

GROUNDS:

A- That the impugned orders dated 17.8.2018 and 25.9.2018 issued by the respondent No.2 are against the

law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.

- B- That the respondents has not been treated the appellant in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Pakistan 1973.
- C- That appellant is the senior most employee of his cadre and is eligible with all respect for the post of Tehsildar in light of the service Rules of the respondent Department, hence the reversion/ repatriation of the appellant is not tenable in the eye of law and Rules.
- D- That the order regarding posting of the appellant against the post of Tehsildar has been fully acted upon and attained finality thus is a past and closed chapter/transaction, hence re-inquiring of it is not free from malafide also suggested involvement of hidden hands in depriving the appellant from the post of Tehsildar.

- E- That the impugned order dated 17.8.2018 regarding reversion of the appellant to the post of Assistant is amounts to double jeopardy.
- F- That the respondent No.2 is competent under the recruitment Rules mentioned above, who himself issued valid/legal order which has been acted upon thus subsequently he can not be allowed to turn around after the laps of more than five years alleging that such posting order was not competently issued.
- G- That the action of Senior Member Board of Revenue by issuing the impugned order dated 17.8.2018 against the appellant certainly amounts to the violation of judgments of the superior Courts.
- H- That the impugned action of the respondent No.2 is against the doctrine of the natural justice.
- I- That the appellant has been treated discriminately, therefore, the impugned action needs to be declared illegal, against the law, have no legal effect and against the constitution of Islamic Republic of Pakistan 1973. That colleagues of the appellant namely Mr. Feroz Khan and Mr. Tarig Ahmed who were also reverted/ repatriated to his original post of Assistant have been again posted as Tehsildar on Current charge basis vide orders dated 13.9.2018 and 13.8.2018. So much so those kanungos who were posted as Tehsildars on current charge basis

- J- That the action of the concern authority by issuing the impugned order dated 17.8.2018 at this belated stage is not only malafide but void ab initio and corum-non-judice.
- K- That the concerned authority acted in arbitrary and malafide manner while issuing the impugned order dated 17.8.2018 reverting the appellant to the post of Assistant.
- L- That no show cause notice has been served against the appellant by the respondents before issuing the impugned order dated 17.8.2018.
- M-That appellant seeks permission to advance other grounds proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed far.



- 1. That the appellant is performing his duties as Tehsildar on current charge basis <u>TEASILDAR SUL DIVISION MAXIR</u>, <u>BANNO</u>.
- 2. That the appellant is being subjected to persistent acts of discrimination on continuous basis and turned to be into shuttle cock as without observing the normal tenure of posting and transfer, the appellant is transferred and posted again and again.
- 3. That this was the case of appellant who had been initially transferred and posted vide order No. 1938 [\$1/8/vel-V) Estre (NTLR) dated 19-3-Rol3 and lastly to the present place of posting vide order dated <u>2-2-sort (b vest</u>. (Copies of the transfer and posting orders are annexed).

4. That this was the background that yet, another herein impugned notification Estt: 1/P,1/30393-430, Dated 17.08.2018 was illegally issued whereby the appellant was repatriated to his present department in an illegal discriminatory, void and unwarranted manner. (Copies of the impugned office order is annexed).

5. That before passing on the grounds of the instant appeal, it is pertinent to mention that the appellant holding the substantive pay scale of <u>Assistant</u> BPS-16 but having the ability and potential, otherwise eligible as well, have been transferred and posted as Tehsildar on CCB wherein his rights are protected and governed by rule 9 of the Transfer Promotional and Appointment Rules 1989.

Grounds

A. That persistent orders of transfer and posting any Civil Servant / Government servant is always hazardous and injurious to the potential and capabilities of the such civil servant / Government servant and has always been depreciated and discouraged by the Superior Courts, being always held as violation to fundamental rights and not solely to the service rights.

ļ

- B. That the impugned transfer and posting order are highly discriminatory ones and at the same time the repatriating the appellant to his parent department without any rem and reason and without observing the law on subject while all the blue eyed ones were posted and transferred to their favorites places of posting and were left in field is highly discriminatory and void and amount to falling of the bolt from the blue upon the appellant.
- C. That without going into minute details in would be suffice to mention here that persons who are holding same positions of responsibility on current charge basis to other field offices instead of repatriating all the officials working on CCB to the parent department and thus only the appellant was subject to unfettered discrimination an even only on this score the impugned office order is void and illegal.
- D. That the normal tenure of transfer and posting can only be allowed to be left in rare and exceptional cases and that to in a defined public interest. But here the appellant has repeatedly been transferred and repatriated for no reasons, which is certainly not a good omen.

That posting and transferring any Civil Servant / Government on current charge basis is a defined mechanism of service law and procedure is detailed in ESta Code while the accrued rights, accrued thereupon, are fully protected under the same code whose details are provided under rule 9 of Transfer, Promotion and Appointment Rules 1989, But here that situation is volte-face and the appellant is repatriated to parent department without any justification and the same tantamount to violation of only service law.

F. That no one can condemned unheard, nor any one can be







REJOINDER ON BEHALF OF APPELLANT IN RESPONSE TO THE REPLY SUBMITTED BY THE OFFICIAL RESPONDENTS

R/SHEWETH:

(1 to 5):

All the objections raised by the respondents are in correct, baseless and not in accordance with law and rules, rather the respondents are estopped due to their own conduct to raise any objection at this stage of the appeal.

ON FACTS:

- 1- Admitted correct by the respondents hence need no comments.
- 2- Admitted correct to the extent that the appellant was posted as Naib Tehsildar (OPS) while the remaining Para is incorrect. That according to the service structure of the respondent Department Notified on 23.1.2015 twenty percent promotion quota was allocated for the cadre of Assistant working in the office of Commissioners, Deputy Commissioners and Political Agents. That in light of the said Rules the appellant was initially posted against the post of Head Clerk (Revenue)/Naib Tehsildar Land Reforms Swat vide order dated 14.3.2013 and subsequently was posted on the vacant post of Tehsildar Dargai on current charge basis vide order dated 11.2.2016.
- 3- Admitted correct to the extent that the appellant was posted as Tehsildar Mirali on current charge basis while the remaining Para is incorrect, hence denied.
- 4- Admitted correct hence need no comments.
- 5- Admitted correct to the extent that the appellant was the Assistant of office of the Deputy Commissioner Buner while the remaining Para is incorrect and misconceived. That appellant is the senior most employee of the respondent Department and the competent authority reverted/repatriated the appellant alongwith his other colleagues from the post of Tehsildar on the question that the newly promoted Tehsildars were placed out on the said posts, but in fact the above mentioned posts of Tehsildar were again filled up by posting on (OPS) of the Kanungo, Assistants, Political Moharrar and

Senior Clerks vide different orders. That it is pertinent to mention that the one Mr. Tanzil-Ur-Rehman who was posted on (OPS) in place of the appellant basically is Naib Tehsildar (BPS-14) vide Notification No. 30367 dated 17.8.2018 and further order No.3672/95 dated 31.08.2018 for which he is not eligible on the reason that the post of Political Tehsildar is (BPS-16). That the act of the respondents is against the law and prescribed Rules of the respondent Department. Copies of the orders are attached as annexure.....R.

- 6- Admitted correct that appellant filed Departmental appeal before the appellate authority which was rejected on no good grounds.
- 7- Incorrect and misconceived hence denied.

GROUNDS:

That appellant is the senior most employee of his cadre and is eligible with all respect for the post of Tehsildar in light of the service Rules of the respondent Department, hence the reversion/repatriation of the appellant is not tenable in the eye of law and Rules. That the order regarding posting of the appellant against the post of Tehsildar has been fully acted upon and attained finality thus is a past and closed chapter/transaction, hence re-inquiring of it is not free from malafide also suggested involvement of hidden hands in depriving the appellant from the post of Tehsildar. That the impugned order dated 17.8.2018 regarding reversion of the appellant to the post of Assistant is amounts to double jeopardy. That the respondent No.2 is competent under the recruitment Rules mentioned above, who himself issued valid/legal order which has been acted upon thus subsequently he can not be allowed to turn around after the laps of more than five years alleging that such posting order was not competently issued. That the action of the Senior Member Board of Revenue by issuing the impugned order dated 17.8.2018 against the appellant certainly amounts to the violation of judgments of the Superior Courts. That the appellant was discriminated amongst his other colleagues who were posted as Tehsildars while the appellant has been reverted/repatriated to the post of Assistant.

It is therefore, most humbly prayed that on acceptance of this rejoinder the appeal of the appellant may kindly be accepted in favor of the appellant with all back benefits.

REJOINDER ON BEHALF OF APPELLANT IN RESPONSE TO THE REPLY SUBMITTED BY THE OFFICIAL RESPONDENTS

R/SHEWETH:

(1 to 5):

All the objections raised by the respondents are in correct, baseless and not in accordance with law and rules, rather the respondents are estopped due to their own conduct to raise any objection at this stage of the appeal.

ON FACTS:

- 1- Admitted correct by the respondents hence need no comments.
- 2- Admitted correct to the extent that the appellant was posted as Naib Tehsildar (OPS) while the remaining Para is incorrect. That according to the service structure of the respondent Department Notified on 23.1.2015 twenty percent promotion quota was allocated for the cadre of Assistant working in the office of Commissioners, Deputy Commissioners and Political Agents. That in light of the said Rules the appellant was initially posted against the post of Head Clerk (Revenue)/Naib Tehsildar Land Reforms Swat vide order dated 14.3.2013 and subsequently was posted on the vacant post of Tehsildar Dargai on current charge basis vide order dated 11.2.2016.
 - 3- Admitted correct to the extent that the appellant was posted as Tehsildar Mirali on current charge basis while the remaining Para is incorrect, hence denied.
 - 4- Admitted correct hence need no comments.
 - 5- Admitted correct to the extent that the appellant was the Assistant of office of the Deputy Commissioner Buner while the remaining Para is incorrect and misconceived. That appellant is the senior most employee of the respondent Department and the competent authority reverted/repatriated the appellant alongwith his other colleagues from the post of Tehsildar on the question that the newly promoted Tehsildars were placed out on the said posts, but in fact the above mentioned posts of Tehsildar were again filled up by posting on (OPS) of the Kanungo, Assistants, Political Moharrar and

Senior Clerks vide different orders. That it is pertinent to mention that the one Mr. Tanzil-Ur-Rehman who was posted on (OPS) in place of the appellant basically is Naib Tehsildar (BPS-14) vide Notification No. 30367 dated 17.8.2018 and further order No.3672/95 dated 31.08.2018 for which he is not eligible on the reason that the post of Political Tehsildar is (BPS-16). That the act of the respondents against the law and prescribed Rules of the respondent is Department. Copies of the orders are attached as annexureR.

- 6- Admitted correct that appellant filed Departmental appeal before the appellate authority which was rejected on no good grounds.
- 7- Incorrect and misconceived hence denied.

GROUNDS:

That appellant is the senior most employee of his cadre and is eligible with all respect for the post of Tehsildar in light of the service Rules of the respondent Department, hence the reversion/repatriation of the appellant is not tenable in the eye of law and Rules. That the order regarding posting of the appellant against the post of Tehsildar has been fully acted upon and attained finality thus is a past and closed chapter/transaction, hence re-inquiring of it is not free from malafide also suggested involvement of hidden hands in depriving the appellant from the post of Tehsildar. That the impugned order dated 17.8.2018 regarding reversion of the appellant to the post of Assistant is amounts to double jeopardy. That the respondent No.2 is competent under the recruitment Rules mentioned above, who himself issued valid/legal order which has been acted upon thus subsequently he can not be allowed to turn around after the laps of more than five years alleging that such posting order was not competently issued. That the action of the Senior Member Board of Revenue by issuing the impugned order dated 17.8.2018 against the appellant certainly amounts to the violation of judgments of the Superior Courts. That the appellant was discriminated amongst his other colleagues who were posted as Tehsildars while the appellant has been reverted/repatriated to the post of Assistant.

It is therefore, most humbly prayed that on acceptance of this rejoinder the appeal of the appellant may kindly be accepted in favor of the appellant with all back benefits.

JUDGMENT

AHMAD HASSAN, MEMBER.-

This judgment shall dispose of the instant service appeal as well as connected service appeal no. 1114/2018 titled Asad Umair, appeal no. 1115/2018 titled Shafaqatullah, appeal no. 1116/2018 titled Amjid Imran, appeal no. 1117/2018 titled Mustafa Shah, appeal no. 1118/2018 Mustamir Shah, appeal no. 1123/2018 titled Nawab Ali, appeal no. 1124/2018 titled M. Ghufran, appeal no. 1125/2018 titled Saeed Manan, appeal no. 1130/2018 titled Azmat Ali and appeal no. 1202/2018 titled Zardad Khan as similar question of law and facts are involved therein.

2. Arguments of the learned counsel for the parties heard and record perused.



ARGUMENTS

3:

Learned counsel for the appellant argued that he was performing duty as Tehsildar PESCO. Khyber Circle on current charge basis. That vide impugned order dated 09.07.2018, he was repatriated to his parent office. For redressal of his grievances, he filed departmental appeal on 11.07.2018, which was dismissed on 17.08.2018, hence, the instant service appeal. Appointment of the appellant was protected under Rule-9 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989. He had not completed normal tenure at the place of previous posting. The appellant was repatriated with mal intent by the respondents to adjust their blue eyed officials. Treatment meted out to the appellant was discriminatory and also condemned unheard.

On the other hand learned Deputy District Attorney for respondents argued that the appellant was basically an Assistant of the office of Commissioner Peshawar. Due to shortage of regular Tehsildars and with a view to ensure smooth running of official business, he was posted as Tehsildar on current charge basis. After posting of regular Tehsildars he was repatriated to his original position. Out of turm promotion did not create any right for regular promotion. He was otherwise not eligible to be considered for promotion against the post of Tehsildar.

CONCLUSION

It is not disputed that the appellant was basically an Assistant of the office of Commissioner, Peshawar. Due to non-availability of regular Tehsildars, he was posted as Tehsildar on current charge basis in the exigency of service and to ensure uninterrupted continuation of official business. Learned counsel for the appellant was unable to quote a single rule that could be pressed in his favour. Being on a weaker wicket his pleadings Tacked substance and failed to make out a convincing case in favour of the appellant. Even he could not spot a single judgment of superior courts to supplement his arguments.

When regular Tehsildars become available with the respondents then through impugned order he was repatriated to his parent office. Action taken by the respondents was backed by Sub-Rule-4 of Rule-9 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989, wherein it is laid down that against vacancies occurring for less than six months current charge appointment may be made according to the orders issued from time to time. Similarly Sub-Rule-6 of the said rules provides that even acting charge appointment shall not confer any vested right for regular promotion to the post held on acting charge basis. Nothing is contained in these rules about current charge appointment. In these circumstances action taken by the respondents appeared valid/justified. Being a juniors most Assistant he was not eligible for promotion as Tehsildar. It amounted to out of turn promotion held to be illegal/unlaw in various judgments of the superior courts. The question of tenure was not relevant in the present case. Opportunity of personal hearing is afforded to a civil servant when proceedings are instituted against him under Khyber Pakhtunkhwa Civil Servants (Efficiency and Discipline) Rules-2011.

6. As a sequel to above, the appeal is dismissed. Parties are left to bear their own costs. File be consigned to the record room.
