### **JUDGMENT**

Rozina Rehman. Member (J): Briefly stating the facts necessary for the disposal of the lis in hand are that appellant was a regular employee of the Education Department. He was proceeded against departmentally on the charges of dual duties but was exonerated of the charges. Despite inquiry report, neither his salary was released nor adjustment order related to the posting of appellant was acted upon, he, therefore, filed writ petition in the august Peshawar High Court, Peshawar but he was advised to approach Service Tribunal. In the meanwhile, Show cause notice was issued to the appellant and



major penalty of removal from service was imposed upon appellant.

He preferred departmental appeal which was not responded to, hence, the present service appeal.

- 2. We have heard Arshad Khan Advocate for appellant and Asif Masood Ali Shah learned Deputy District Attorney for the respondents and have gone through the record and the proceedings of the case in minute particulars.
- 3. Arshad Khan Advocate learned counsel appearing on behalf of appellant, inter-alia, argued that show cause notice and the impugned order has been passed in violation of the decision rendered by the upper hierarchy and that frequent transfer posting of the appellant violated the rights of appellant. He contended that case of the appellant was decided in a mechanical manner without diverting to the facts of the case and that the appellant was subjected to administrative persecution.
- 4. Conversely, learned D.D.A submitted that the appellant remained absent from duty on the dates of the visits of the officers as well as during the entire period between 01.03.2017 to 15.12.2017. He contended that the appellant never performed duty at his duty station since 14.11.2017 and as per complaints of the S.D.E.O Barikot Swat, appellant remained absent from duty time & again as he was working abroad and lastly, he submitted that show cause notice was served upon the appellant and after observing codal formalities, he was removed from service.
- 5. From the record, it is evident that appellant filed writ petition in the august Peshawar High Court, Peshawar and he prayed for



issuance of directions to the Department to release his salary since August, 2017 and to make his adjustment at G.P.S Zarkhela. As the writ petition was not maintainable, therefore, was dismissed and appellant approached Service Tribunal by filing appeal U/S 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the respondents, whereby, his salary was held since August, 2017 and regarding issuance of his premature and illegal transfer posting from one station to another. It merits to mention here that the said service appeal was adjourned sine die. The order which is impugned before this bench in the instant service appeal was passed on 31.07.2008, whereby, major penalty of removal from service was imposed upon appellant. From the impugned order, it is evident that the proceedings were initiated against the appellant under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, Admittedly, no charge sheet and statement of allegations were served upon appellant and no proper inquiry was conducted into the mater. The appellant was not given any opportunity of production of defense. Similarly, no witness was examined in his presence. The respondents have placed on file traveling history of the appellant but he was never confronted with these documents as no regular inquiry was conducted. It is also on record that initially an inquiry was conducted before passing of the impugned order which report was submitted by the Inquiry Officer Assistant Director (G) Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar 25.01.2018, whereby, the allegations leveled by the S.D.E.O against present appellant were declared baseless recommended that the S.D.E.O may be reverted to his original post of Subject Specialist. It was also recommended that salary of the

in the second se

appellant may be released with all back benefits and he may be adjusted at his original duty station. From the record, it is evident that no proper inquiry was conducted in respect of the allegations mentioned in the show cause notice. Travelling history coupled with other material available on file were not provided to the appellant. The respondents have candidly violated the set norms & rules and conducted the proceedings in an authoritarian manner. We have observed that the appellant was kept deprived of affording opportunity of defense. It is a well settled legal proposition duly supported by numerous judgment of the apex court that for imposition of major penalty, regular inquiry is a must.

6. For what has been discussed above, this appeal is allowed. The respondents are directed to reinstate the appellant into service for the purpose of de-novo inquiry to be conducted within 90 days of the receipt of this judgment. Needless to mention that the appellant shall be provided proper opportunity of defense during the inquiry proceedings. The issue of back benefits shall be subject to final outcome of the de-novo inquiry. Parties are left to bear their own costs. File be consigned to the record room.

SERVICE APPEAL UNDER SECTION 4, OF THE KPK SERVICE TRIBUNAL ACT, 1974, AGAINST THE impugned order dated 31-07-2018, whereby the major penalty of "Removal from Service" has been imposed upon the appellant.

### PRAYER IN APPEAL

On acceptance of this appeal, the impugned order dated 31-07-2018 passed by respondent may kindly be set-

aside and the appellant may kindly be reinstated with all back benefits. Any other remedy not specifically asked for in the appeal and the appellant is entitled, therefore may kindly be granted.

### Respectfully Sheweth,

### The facts of the instant case are as under;-

- That the appellant is a regular employee of the Education Department currently posted at GPS Zarakhela, Tehsil Barikot, District Swat.
- 2) That frequent transfer posting of the appellant was agitated before the respondent No.2.
- 3) That in the meanwhile departmental proceedings also been initiated on the charges of dual duties, the inquiry report was submitted, wherein the appellant has been exonerated of the charges leveled, and it was held in the aforesaid inquiry report that the allegation of complainant are based on malevolent intentions, hence the recommendation for punitive action against the complainant / official was also suggested. (Copy of inquiry report dated 07-02-2018 is attached as annexure "A")

- 4) That it is depressing, to mention that despite of the aforementioned inquiry report neither the salary of the appellant has been released nor the adjustment order related to posting of the appellant has been acted upon, and a service book of the Appellant has also not been recovered, and the complainant still working as SDEO Barikot, Swat despite of clear recommendation by the inquiry officer.
- 5) That after the result of the inquiry in favour of the appellant, the respondent No. 3 did not implement the recommendation of the inquiry report, therefore, the appellant went to the Honorable Peshawar High Court for redressal of his grievances. But the Honorable Court held that the relief sought in the writ petition pertains to the "terms & condition" of service, hence having no jurisdiction to entertain the same and held to approach this Honorable Tribunal. (Copies of writ petition & judgment dated 21-03-2018 are attached "B")

So, the appellant approached the Tribunal, and the appeal is pending for adjudication. (Copies of service appeal is attached as annexure "C")

6) That the respondent No. 3 again issued show cause notice to the appellant, related to the issue already decided by the upper hierarchy. (Copy of show cause notice is attached as annexure "D")

- 7) That the appellant filed written reply to the allegations leveled. (Copy of reply is attached as annexure "E")
- 8) That the respondent No. 3 imposed a major penalty upon the appellant. (Copy of impugned order dated \$\frac{1}{2}\$ 07-2018 is attached as annexure "F")
- 9) That the appellant preferred departmental appeal against the impugned order and is still pending for adjudication, hence filed the instant appeal. (Copy of appeal is attached as annexure "G")
- 10) That to the utter surprise of the appellant, another show cause notice been issued to the appellant on 15-10-2018.(Copy of notice is attached as annexure "H")
- 11) That the appellant have no other proper remedy, except to file the appeal this Honorable Tribunal Court, on the following grounds..

### GROUNDS:

- A) That the action of respondent No. 1 is unlawful, against the law, arbitrary and against the norms of justice.
- B) That the show cause notice and the impugned order has been passed in violation of the decision rendered by the upper hierarchy i.e.,

respondent No. 2, hence, not sustainable in the eyes of law.

- C) That frequent transfer posting of the petitioner has violated statutory right of the petitioner.
- D) That the respondent No. 3 has decided the case of the appellant in mechanical manner without adverting to the facts of the case, hence, liable to be set aside.
- E) That impugned order is devoid of any merit, and has been issued with sheer abuse of power on the part of the respondent No. 3, which need interference of this honorable tribunal in safeguarding the fundamental right of the appellant.
- F) That the whole proceedings has been conducted in violation of due process, hence, not sustainable.
- G) That the appellant has been subjected to administrative persecution out of mala-fide and ill will, which is evident from the fact that a subsequent show cause notice has been issued to the appellant after removal of service vide impugned order.

 That further grounds, with leave of this Honorable Court, would be raised at the time of arguments before this Honorable Court.

### PRAYER.

It is therefore humbly prayed that on acceptance of this appeal, the impugned order dated 31-07-2018 passed by respondent may kindly be set-aside and the appellant may kindly be reinstated with all back benefits. Any other remedy not specifically asked for in the appeal and the appellant is entitled, therefore may kindly be granted.

ENQUIRY REPORT SUBJECT:

Întroduction:

The undersigned has been nominated as enquiry officer vide Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar Notification Lindsit: No. 6375-77 dated 27/12/2017 to hunt out the facts in the light of the request of District Education Officer (M) Swat letter No.5582 dated 28-11-2017 which is self-explanatory (F/A).

#### Case History:

A letter was submitted by District Education Officer (M) Swat, wherein, it was mentioned that an enquiry committee constituted consisting upon Mr. Zulfiqur ut Mulk Dy. DEO (M) Swat as Chairman & Mr. Mohsin ADEO (Establishment Secondary) as member to enquire the matter regarding complaint against Mr. Abdul Mastuan SDEO (M) Barikot and Karim Khan SPST for his long absence/dual duties etc.

Meanwhile, the alleged Mr. Abdul Mastaan SDEO (M) Barikot submitted an application requesting that he is not satisfied with enquiry committee and demanded for conduction an impartial enquiry regarding the subject issue

It is further mentioned in there, that a complaint was submitted by Mr. Karim Khan SPST regarding personal grudges with the earlier mentioned SDEO and he was complaining that his missing service book may kindly be recovered and his salary be released.

#### Procedure:

In compliance with the notification of the Directorate of E&SE and to find out the factual position of the case the undersigned proceeded as follows:

### Checking of record:

All the available record has been thoroughly checked and enclosed herewith wherever necessary for further proceedings (F/B).

# Statement/opinion of the Ex-Enquiry Officers:

For a crystal clear findings the undersigned met with the Ex-enquiry committee to record their opinion regarding the case and proceed further on the track (F/C).

### Statement of the alleged SDEO:

A structured questionnaire was served to Mr. Abdul Mustaan the alleged SDEO and record his reply (F/1).

## Statement of the Mr. Karim Khan SPST:

To justify the case, a similar natured questionnaire was also served to the teacher concerned for recording his reservations (F/E).

#### Findings: \

Following findings drawn after conducting enquiry:

- 1) According to available record and evidence, the allegation labeled by Mr. Abdul Mustaan SDEO against Mr. Karim Khan were baseless as they were not supported with any documentary proof.
- 2) Mr. Abdul Mustaan failed to provide any evidence which shows Mr. Karim Khan his ever been abroad.
- 3) Charges of dual duty of Mr. Karim Khan could not be proved.
- 4) Charges framed against the said teacher shows malevolent intentions.
- 5) Cancellation of sanctioned leave without pay of 275 days before availing completely and thrice adjustments of the teacher concern during a month shows personal dislikes.
- 6) The teacher concerned proved a regular official through documental proof yet again his salary was not released up till now.

### Conclusion:

After following the procedural sequence mentioned above, snooping into the matter through documentary evidences the under signed came to the conclusion that:

- 1. Charges labeled against Mr. Karim Khan SPST were not proved.
- 2. The above findings reflected that there were personal grudges between SDEO concerned and Mr. Karim Khan SPST.


### Recommendations:


Keeping all the facts in view, it is recommended that:

- 1. Since Mr. Abdul Mustaan SDEO (M) Barikot failed to prove any charge labeled against Mr. Karim Khan SPST hence, he may be reverted to his original post of Subject Specialist and may never be appointed on any managerial post in future.
- 2. The salary of Mr. Karim Khan SPST may be released with immediate effect along with all benefits.
- 3. The teacher concern may be adjusted at his original duty station.
- 4. The teacher concern may be kept under strict observations on his duty place in future



### Parawise Comments on Behalf of the Respondents Respectfully shewith

### Preliminary objections

- 1. That the appellant is not an aggrieved person within the meaning of section 4 of the service tribunal Act, 1974.
- 2. That the appellant has no cause of action / locus standi.
- 3. That the appellant has not come to this honourable court with clean hands.
- 4. That the appellant has filed this instant service appeal just to pressurize the respondents.
- 5. The present service appeal is liable to be dismissed for non-joinder/miss joinder of necessary parties.
- 6. That the instant service appeal is against the prevailing law and rules.
- 7. That the appellant has filled this instant Writ service appeal on malafide motives.
- 8. That the instant service appeal is not maintainable in the present form, and above in the present circumstances of the issue.
- 9. That the appellant has estopped by his own conduct.
- 10. That the appellant has concealed the material facts from this honourable tribunal.

#### **FACTS**

1. That the Para No. 1 is correct to the extent of the employment of the appellant in education department, the rest of the Para is incorrect and not admitted. In fact the appellant was posted at GPS Rangila Barcham in corrigendum order on need basis within the same Union Council. The appellant remained absent from his duties since 14.11.2017 without proper leave. (order and attendance register

#### Copy as Annexure A,B)

- That the Para No.2 is irrelevant to the present issue, hence no comments.
   However it is worth to mention here that transfer is not a penalty. It is the
   discretionary powers of the competent authority to adjust/ transfer any
   employee according to the needs of the department and in public interest.
- 3. That the Para No.3 is correct to the extent of the said enquiry report. The rest of the Para is incorrect and not admitted. The appellant has concealed the material facts from the Honourable Service Tribunal. The sanctioned leave for the period of 01/03/2017 to 15/12/2017 was cancelled on 19/07/2017 by the competent authority on the written complaint of the SDEO Barikot Swat and the appellant was directed to join his duty. The SDEO Barikot Swat submitted the absence report of the appellant on 18/03/2017, 17/11/2017, respectively. The appellant remained absent from duty on the dates of visits of the officers as well as the

entire period between the dates mentioned above. The appellant has never performed duty at his duty station i.e GPS Rangila since 14.11.2017. As per complaints of the SDEO Barikot Swat, the appellant remained absent from duty time and again because he was also working abroad as seaman.

As per FIA report the appellant arrived on 04/08/2017 at Peshawar Internations.

As per FIA report the appellant arrived on 04/08/2017 at Peshawar International Airport through Flight No. G9566, under documents No.PP-4100773 after cancellation of his leave by the competent authority. The appellant took over charge on 03/08/2017 while he arrived from abroad on 04/08/2017, which is clearly fraudulent. Hence the competent authority did not agree with the said enquiry.

### (Copies of the log book, SDEO Reports, FIA report, as annexure C,D,E,F)

- 4. That the Para No.4 is incorrect and denied. The appellant has been removed from service due to willful absence from duty. Therefore, he cannot claim salary as far as the service book of the appellant is concern, service book is not a personal document, and it is an official document and should be in the custody of the concern department. Hence his service book is lying in the safe custody of the official respondents. Whereas the SDEO Barikot Swat has been transferred as headmaster to GHS Gogdara Swat. Hence his objection on the said SDEO is baseless.
- 5. That the Para No.5 is correct to the extent of the appellant approach to the Honourable Peshawar High Court and the judgment of the Honourable High Court, the rest of the Para is the repetition of the above Para. Hence no comments.
- 6. That the Para No.6 is incorrect and not admitted. Respondent No.3 is the competent authority in the instant issue. Being competent authority respondent No.3 did not agree with the recommendations of the said enquiry, because the said enquiry was in contradiction with the FIA report and other relevant record, hence the appellant cannot claim the implementation of the said enquiry according to his whims and wishes.
- 7. That the Para No.7 is correct to the extent of reply, however it is worth to mention here that the story written in the reply by the appellant is based on ill well of the appellant. In fact the appellant remained absent from his duty time and again and went abroad time and again without proper leave as stated in the foregoing Para and clear from the FIA report. In fact the appellant has not performed his duty at any station/ GPS Zara khella. (Head Master Report and teacher report as annexure G,H)
- 8. That the Para No.8 is correct. The Deputy DEO (M) Swat and SDEO (M) Barikot visited GPS Rangila Barcham on 16.5.2018. Show Cause notice was served upon the appellant and after observing all codal formalities, the appellant was removed from service.
- 9. That the Para No.9 is correct to the extent of the departmental appeal, however the said appeal has not been accepted as the records show that the appellant remained absent from his duties time and again.
- 10. That the Para No.10 is correct to the extent of the other show cause. However it is worth to mention here that the said show cause notice was issued on the IMU report and was immediately cancelled by the respondent No.3, as the appellant was already removed from service. (order as Annexure I)
- 11. That the instant service appeal of the appellant is bereft of any merit, hence liable to be dismissed inter alia following grounds.

### **GROUNDS**

- A. That the Para No. A is incorrect and not admitted. The action of the respondent department is not illegal, Un-lawful, arbitrary and against the norms of justice.
- B. That the Para No. B is incorrect and not admitted. The detail reply of this Para has been given in the foregoing Paras.
- C. That the Para No. C is incorrect and not admitted, as stated in the foregoing Paras, the transfer/ adjustment of the employees is the discretionary powers of the competent authority, hence the order of the respondent department is not illegal.
- D. That the Para no. D is the repetition of the above Paras, hence no comments.
- E. That detail reply has been given in the foregoing Paras.
- F. That the Para No.F is incorrect and not admitted. The respondent No.3 has acted upon the rules, policy and procedure. The appellant remained absent time and again and was also working as sea-man therefore he has been treated as per law, rules and policy.
- G. That the para No.G is the repetition of the above paras, hence no comments.
- i. That the Para No.I is irrelevant, hence no comments. However respondents also seek permission of this Honourable Tribunal to raise further grounds at the time of arguments.

It is, therefore, very humbly prayed that the instant writ service appeal of the appellant may be dismissed with cost in favour of the respondents.


