



Learned counsel for the appellant present. Heard.

The appellant has filed the present service appeal against the order dated 07.12.2018 whereby office order dated 12.11.2018 regarding posting of the appellant as Sub Registrar Buner was withdrawn. The appellant has also challenged the order dated 21.12.2018 through which his departmental appeal was rejected. Perusal of the file would show that the appellant is indeed a Kanungo but was assigned the higher post of of Naib Tehsildar on OPS basis and then he was also posted as Sub Registrar on OPS basis. In the interest of justice pre-admission notice be issued to the respondents. To come up for reply of the respondents and preliminary hearing on 11.03.2019 before S.B.

The august Supreme Court of Pakistan has already held that the appointment on higher post on OPS basis is without any legal backing. In spite of that the Revenue Department is found reluctant to fill up the vacant posts of Sub Registrars, Naib Tehsildars and Tehsildars on regular basis in the prescribed manner. The SMBR and Director Land Record/Inspector General Registration Revenue & Estate Department Khyber Pakhtunkhwa owe an explanation to that effect. Copy of this order sheet be sent to SMBR and Director Land Record/Inspector General Registration.







1. That the appellant was appointed as Patwari, was then promoted as Kanungo, and was posted as Kanungo at the office of Deputy Commissioner Dir Lower. The appellant was posted as Naib Tehsildar on Current Charge Basis vide Notification dated 12-07-2017. (Copy of Notification dated 12-07-2017 is enclosed as Annexure A).
2. That vide Notification dated 11-05-2018, the services of the appellant were placed at the disposal of Commissioner Peshawar Division for further posting as

Naib Tehsildar (CCB) in the Division and vide Office Order dated 21-05-2018, he was posted as District Revenue Accountant Charsadda (OPS). **(Copy of Notification dated 11-05-2018 and Order dated 21-05-2018 are enclosed as Annexure B & C).**

3. That vide Order dated 09-07-2018 the appellant was repatriated to his parent office and vide Notification dated 17-08-2018 the services of the appellant were placed at the disposal of the Commissioner Malakand Division for further posting and he was posted as Naib Tehsildar Mastuj Chitral vide Order dated 07-09-2018. **(Copy of Order dated 09-07-2018 and Order dated 07-09-2018 are enclosed as Annexure D & E).**
4. That vide Office Order dated 12-11-2018, the appellant was transferred as Sub Registrar Buner and he assumed charge on 22-11-2018 but strangely his vide Office Order dated 07-12-2018 the order dated 12-11-2018 was withdrawn. **(Copy of Order dated 12-11-2018 and Order dated 07-12-2018 are enclosed as Annexure F & G).**
5. That the appellant submitted Departmental appeal, before respondent No 1, which was filed on 21-12-2018. **(Copy of appeal and order on the same is enclosed as Annexure H and I).**
6. That the impugned order dated 21-12-2018 of respondent No 1 and order dated 07-12-2018, of respondent No 2 are against the law, facts and principles of justice on grounds inter alia as follows:-



### **GROUND:-**

- A. That the impugned orders are illegal and void ab-initio.
- B. That the impugned order is without jurisdiction and legal authority, as respondent No 2 is not the competent authority in case of the appellant.
- C. That the orders are based on nepotism and favoritism besides politically oriented and thus not maintainable in the eyes of law.

- D. That even the same are premature as the appellant was transferred just after about a month of his posting without any justification.
- E. That the appellant was made a rolling stone and during a span of one year he was transferred about ten times which could in no way be justified.
- F. That even there is no complaint of any sort against the appellant.
- G. That mandatory provisions of law have been violated by the respondents while taking action against the appellant.
- H. That the appellant is having long service with unblemished service record and has not relinquished the charge yet.
- I. That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.


