**APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 READ WITH ALL ENABLING LAW & RULES AGAINST THE APPELLATE ORDER DATED 29-10-2016 (received to the appellant on 23-01-2017) WHEREBY DEPARTMENTAL APPEAL DATED 29-05-2014 OF THE APPELLANT FOR ASSIGNING/GIVING SENIORITY FROM 2003 ALONG WITH PROMOTION SINCE 2003 WAS DISMISSED ON NO GOOD GROUNDS**

**PRAYER:**

**That on acceptance of the instant service appeal the act of the respondents by not assigning/giving seniority to the appellant & not considering for promotion since 2003 may very kindly be declared illegal & unconstitutional and the respondents may kindly be directed to assign seniority of the appellant since 2003 as well as consider the appellant for promotion from 2003 or from the date his colleague is given promotion to the higher rank of Junior Clerk/Moharrir (BPS-11) with all Back & consequential Benefits. Any other remedy which this august Tribunal deems appropriate that may also be awarded in favor of the appellant.**

*Respectfully Sheweth;*

**FACTS:**

**Brief facts giving raise to the instant appeal are as under:**

1. That appellant is a regular employee of the respondent Department Khyber Pakhtunkhwa and was initially appointed as Process Server (BPS-01) vide order dated 21-06-1993 passed by Senior Civil Judge, District Nowshera after fulfilling all the legal & codal formalities required for the post and since then the appellant is performing his duty quite efficiently whole heartedly and upto the entire satisfaction of his high ups.

Copy of Appointment Order dated 21.06.1993 is attached as Annexure ..... A.

2. That appellant was at numerous occasions designated as Naib Qasid and as such was later on designated as Naib Qasid to the court of Civil Judge 1<sup>st</sup> Class at Nowshera vide order dated 21-02-1995.

Copy of Order dated 21.02.1995 along with other documents is attached as Annexure ..... B.

3. That appellant was transferred from District Nowshera to Charsadda vide Peshawar High Court Peshawar order dated 14-10-1999 on mutual transfer with one Amin Shah (Naib Qasid) and on receipt of the order dated 22-10-1999 the appellant submitted his arrival report before Respondent No. 2 vide dated 03-11-1999.

Copy of Order dated 22.10.1999 & Arrival Report dated 03.11.1999 is attached as **Annexure** .....C.

4. That the appellant filed an application before the Respondent No. 3 vide dated 03-01-2001 wherein the appellant requested for his promotion to the next higher rank of Junior Clerk/Moharrir keeping in view his length of service since 1993 and qualification.

Copy of Application dated 03.01.2001 is attached as **Annexure**.....D.

5. That appellant was astonished to see that the respondents had issued seniority list vide dated 12-04-2003 of Class-IV employees working in the District Judiciary Charsadda but the appellant was completely ignored to be included in the Seniority List 2003 prepared for Class-IV employees.

Copy of Seniority List Dated 12.04.2003 & promotion is attached as **Annexure** ..... E.

6. That in the year 2006-07 a separate seniority list of the establishment of Respondent No. 3 was prepared wherein name of the appellant was enlisted at Serial No. 5 in the list but unfortunately other colleagues of the appellant were given promotion to the next higher rank of Junior Clerk/Moharrir/Naib Nazir in the 2<sup>nd</sup> Departmental Promotion Committee held on 31-07-2008 and this time too, the appellant was completely ignored from promotion to the next higher rank of Junior Clerk.

Copy of Seniority List 2006 & Promotion Orders are attached as **Annexure** .....F.

7. That the appellant filed appeal dated 29-08-2008 before the Respondent No. 2 whereupon comments was called from Respondent No. 3 which was submitted on 18-09-2008 but when the appeal dated 29-08-2008 was not decided after lapse of sufficient time, the appellant filed an application date 30-01-2010 for its re-opening through proper channel to Respondent No. 2 upon the application dated 30-01-2010 the District & Session Judge haphazardly decided the appeal without informing the appellant regarding the procedure.

8. That the appellant feeling aggrieved from the inaction of the respondents filed Mercy Petition dated 25-05-2010 before the Worthy Chief Justice Peshawar High Court Peshawar which was responded on 22-06-2010 with the remarks that only Process Server & Bailiff can be promoted to the post of Naib Nazir while the Naib Qasid to the post Junior Clerk and on receipt of the reply dated 22-06-2010 the appellant filed implementation petition dated 03-07-2010 which was forwarded to Superintendent for disposal and accordingly the same was disposed of after due process by Respondent No. 3.

9. That later on the appellant came to know that some posts of Junior Clerks are lying vacant that are going to be filed the appellant applied for the same by filing application dated 01-02-2014 requesting therein for promotion and assigning of seniority since 2003 but of no avail.  
Copy of Appeal dated 01-02-2014 is attached as Annexure .....I.
10. That there were ambiguity amongst the District Judiciary regarding Joint & Separate Seniority List of Class-IV employee for which respondent No. 3 move a letter dated 13-03-2014 to respondent no. 2 for removing the ambiguity the same was moved to respondent no. 1 for guidance which was replied vide letter dated 18-04-2014 upon which Daftaries, Naib Qasids, Sweepers, Chowkidars, of District Judiciary Charsadda was asked for submission of Secondary School Certificate within three days vide letter dated 03-05-2014, hence, the appellant submitted his Secondary School Certificate within the stipulated time and accordingly a joint seniority list dated 10-05-2014 was prepared during the pendency of the appeal dated 01-02-2014 and accordingly the appellant was placed at serial no. 6 of the seniority list.

11. That on the issuance of the common seniority list the appellant filed Departmental Appeal dated 29-05-2015 for his promotion and seniority since 2003 which dismissed on 29-10-2016 and on receipt of the attested copy of order dated 29-10-2016 on 23-01-2017 the appellant filed Service Appeal No. 180 of 2017 before the Khyber Pakhtunkhwa Service Tribunal Peshawar which was dismissed with the permission



to file fresh appeal after removal of deficiencies vide order dated 01-02-2022 hence this appeal.

12. That the appellant after receipt of the order sheet dated 01-02-2022 on 17-03-2022 received the Seniority List prepared for the year 2021-22 wherein all the private respondents from 04 to 14 who are junior to the appellant are not only given due place in the seniority but also been promoted much prior to the appellants the appellant is given promotion to the next higher rank on 28-06-2019 due not assigning proper place in seniority since 2003 the detail are as:

### GROUNDS:

- A-** That act of the respondents by not assigning due place in seniority since 2003 to the appellant is against the law, rules, facts, void ab initio, Norms of Natural Justice and materials available on the record hence not tenable in the eye of Law and needs interference of this Honourable Tribunal.
- B-** That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C-** That act of the respondents by not assigning due place in seniority since 2003 to the appellant is against Section-08 of the Civil Servant Act 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

- D-** That respondents were in the ambiguity of Joint & Separate Seniority List between the Class-IV of District Judge & Senior Civil Judge due to which the appellant was not given seniority since 2003 as well as not considered for promotion.
- E-** That act of the respondents by not assigning due place in seniority since 2003 to the appellant is highly discriminatory as the appellant has completely been ignored since from the First DPC conducted in 2003 for promotion to the high rank.
- F-** That under Article 38 (e) of the Constitution of Pakistan, 1973 state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan, therefore the respondent has to act upon the ibid Article of the constitution and had to remove the disparity from the salary of the appellant by allowing benefit for the period from 2003 when the appellant was first ignored from seniority & DPC.
- G-** That the respondent has acted in an arbitrary and malafide manner by not assigning due place in seniority since 2003 to the appellant and not considering for promotion since 2003 when the First DPC was conducted.
- H-** That accordingly to the provision involved in Fundamental Rules & various judgment passed by the Apex Supreme Court of Pakistan the appellant is fully entitle for the back benefits when the seniority is assigned since 2003 as well as promotion.
- I-** That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

- 4 That vide office order dated 09-09-1995 the Applicant was transferred by the session judge Nowshera from the Court of Civil Judge to his/ session Judge Court on his own pay scale. (Copy of office order dated 09-09-1995 is attached)
- 5 That Peshawar High Court Peshawar vide order dated 22-10-1999 mutually transferred the Applicant from Nowshera to Charsadda with amin Shah (Naib Qasid) and accordingly the Applicant submitted his arrival report to the district and session judge Charsadda on 03-11-1999. The Applicant was also given character certificate by the district judge Nowshera. (Copy of Order Dated 22-10-1999, arrival report and character certificate are attached).

Respected Sir,

- 1 That applicant was appointed as process server in BPS 01 vide office order dated 21.06.1993 by Senior Civil Judge, Nowshera. (Copy of appointment letter is attached).
- 2 That on various occasions the Applicant was designated as Naib Qasid and process server in the service book.
- 3 That vide order dated 20.02.1995 the Applicant was transferred and posted as Naib Qasid to the court of Civil Judge-I, Nowshera. (Copy of order dated 20.02.1995 is attached).
- 4 That vide office order dated 09.09.1995 the Applicant was transferred by the Session Judge, Nowshera from the court of Civil Judge to Court of Session Judge, Nowshera in his own pay scale. (copy of office order date 09.09.1995 is attached).
- 5 That Peshawar High Court Peshawar vide order dated 22.10.1999 mutually transferred the Applicant from Nowshera to Charsadda with Amin Shah (Naib Qasid) and accordingly the Applicant submitted his arrival report to the District & Sessions Judge, Charsadda on 03.11.1999. The Applicant was also given character certificate by the District Judge, Nowshera. (copy of order dated 22.10.1999), arrival report and character certificate are attached).
- 6 That the Applicant moved an application before the Senior Civil Judge and Chairman Departmental Promotion Committee on 03.01.2004 regarding his promotion. The point raised/highlighted by the applicant in the said application was that the applicant has not been given opportunity of promotion despite of his long service. (copy of applicant dated 03.01.2004, is attached).
- 7 That the Judicial Department issued a seniority list duly signed by the Senior Civil Judge, Charsadda on 12.04.2003. The applicant was shocked rather dismayed to know that his name was not short-listed in the said seniority list.
- 8 That Departmental Promotion Committee in its 2<sup>nd</sup> meeting on 31.07.2008 once again completely ignored the applicant and 03 process servers were promoted to Junior Clerk post regarding which departmental appeal was filed by the applicant before the District Judge, Charsadda on 29.08.2008. The District Judge, Charsadda called for the comments from Senior Civil Judge, Charadda and accordingly comments were submitted on 18.09.2008. The decision of the District Judge was awaited for more a year. The applicant filed an application for reopening of the appeal on 30.01.2010 to the office of

the Additional District and Session judge/Charsadda which was forwarded to Hon'ble District and Session judge Charsadda. The District and Session judge Charsadda haphazardly decided the appeal and considered the comments as his decision. It is worth to mention here that the applicant was not called/ informed about the comments of Senior Civil Judge.[copy of the appeal, comments, reopening application are attached].

- 9 That feeling aggrieved the applicant filed a mercy petition before the Hon'ble Peshawar high court Peshawar on 25-05-2010. It was decided by the Hon'ble Peshawar high court Peshawar vide order dated 22-06-2010 that only process server/ bailiff can be promoted to the post of Naib Nazir while the Naib Qasid can be promoted to the post of junior clerk.[ copy of mercy petition and order dated 22-06-2010 are attached).
- 10 That for the implementation of the order of Hon'ble Peshawar High Court Peshawar the applicant filed an application before the Hon'ble District and Session judge Charsadda on 03-07-2010. The application was forwarded to superintendent who accordingly replied that the matter relates to senior civil judge as the applicant is Naib Qasid in the court of senior civil judge. The district judge forwarded the same to senior civil judge for disposal according to rules. The worthy senior civil judge ordered

*Consequent upon the application of Mr Azam Ali Khan and Iftikhar Muhammad Naib Qaid of this establishment requested for promotion to the post of Naib Nazir/ junior Clerk. As per our office record there is no vacancy of the said post at present on which the officials can be promoted, so the application be kept pending till the availability of the vacancies and if vacancies become available, the promotion of the said official shall be considered in the departmental promotion committee.*

- 11. That later on it came to the knowledge of the applicant that there are some posts of Naib Nazir vacant which are going to be filled. The applicant accordingly/in accordance with law applied for the said post vide letter dated 01-02-2014. Copy of the letter is attached.
- 12. That upon inquiry by the District and Session Judge Charsadda regarding the joint seniority list of Naib Qasid, Chowkidars and sweeper of sessions and civil court; it was held by the Registrar Peshawar High Court Peshawar that rules are clear about the maintenance of joint seniority of the above mentioned posts. **Separate Common Seniority Lists** were used at relevant places in Peshawar High Court Peshawar. Copy of the applications along with Recruitment rules of 2003 are attached.
- 13. That the Hon'ble District and Session Judge Charsadda vide office order dated 03-05-2014 directed all the Sweepers, Daftaries, Naib Qasids and Chowkidars to submit attested copy of secondary School


