

Respectfully Sheweth;

FACTS:-

- 1. That the appellant was appointed as Qirat Teacher on 05.04.1999.
- 2. That the respondent No.4 was appointed as Qerat Teacher on 16.09.2006.
- 3. That the respondent No. 3 issued a tentative seniority list dated 31.08.2018 wherein the appellant's name is shown as serial No 10 while the name of respondent No.4 is shown as serial No 17 (The said seniority is attached as annexure A)
- 4. That after the issuance of said tentative seniority list, the respondent No.3 issued the final seniority list wherein the name of appellant was shown as serial No. 9 while respondent No.2 was shown in

serial No.2. The appellant was unaware of both the said seniority list as neither these lists were circulated nor pasted on notice boards in the appellants school. (Copy of annexed as annexure B)

order adjustment 5. That through an 05.03.2019 in accordance with notification issued by the respondent No.2 vide endorsement No 3927dated 2019 cases/ 32/A-17/SS/F/promotion 18.02.2019. The respondent No.3 illegally promoted the respondent No.4 and ignored the appellant which is illegal, against the law and service rules of the land which is a clear violation of seniority of promotion laws.

6. That the appellant filed a departmental appeal dated on 06. 04.2019 against the illegal order of respondent No. 3 before the respondent No.2 but no remedy was granted uptill now.




