SERVICE APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED OFFICE ORDER NO. 30370, DATED: 17/08/2018 OF THE OFFICE OF THE SENIOR MEMBER BOARD OF REVENUE. KHYBER PAKHTUNKHWA **PESHAWAR** WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT AGAINST THE **IMPUGNED**

NOTIFICATION WAS DISMISSED IN A CLASSICALLY CURSORY MANNER

Respectfully Sheweth;

- 1. That the Appellant is a naturally born bonafide citizen of the Islamic Republic of Pakistan and hails from a respectable family of Khyber Pakhtunkhwa.
- 2. That infact the Appellant is performing his duties as Naib Tehsildar on own pay scale basis (OPS).
- 3 That the Appellant is being subject to persistent acts of discrimination on continuous basis and turned to be into shuttle cocks as without observing the normal tenures of postings and transfers, the Appellant is transferred and posted again and again.
- 4. That Appellant who had been posted to the present place on dated 11/04/2018 the same had been issued after posting order dated 26/03/2018which had been fallen in the series of transfer and posting order repeatedly fall one after another i.e. 08/01/2018, 27/09/2017, 14/07/2017. (Copies of transfer and posting orders of

AppellantNo.9 is annexed as annexure "A to A/IV").

- 5. That this was the background that yet another, herein impugned office order No. Estt: V/PF/30370 dated 17/08/2018, which followed impugned notification No: I/P-I/30393-430 and impugned office order NO. Estt:I/P-I/30393-430 dated 17/08/2018 impugned in W.P# 3545-P/2018 &3833-P/2018 were illegally issued whereby the Petitioners were repatriated to their parent department in an illegal, discriminatory, void, and unwarranted manner. (Copies of the office impugned /order dated 17/08/2018 notification dated 17/08/2018 alongwith 09/07/2018 are annexed as annexure "B to E" respectively)
- 6. That before passing on to the grounds of the instant appeal, it is pertinent to mention that the Appellant is holding the substantive pay scale of Patwari, but having the ability and potential, otherwise eligible as well, have been transferred and posted as Naib Tehsildar on own pay scale (OPS), wherein his rights are protected and governed by Rule-9 of the Transfer,

Promotion and Appointment Rules 1989. (Copy of the rule 9 is annexed as annexure "F")

- 7. That besides the above the normal tenure of any transfer and posting order in 3 years while in the last one year, more than 04 times the transfer orders of the Appellant were issued which is against the fundamental rights and highly discriminatory in nature.
- 8. That while repatriating the Appellant to parent office, while at the same time so many other his colleagues, including Assistants and Jr. Scale Stenographer who are posted on CCB are further posted as such on CCB & (OPS), while, the Appellant is repatriated discriminatory, which under the law is not allowed. (Copies of posting and order on CCB & (OPS) of other Blue eyed are annexed as annexure "F to F/IV")
- 9. That feeling aggrieved and having no other expeditious remedy available, the Appellant approached this August Court for recognition, enforcement and

acknowledgment of his fundamental rights upon the following grounds inter alia:-

Grounds:

- A. That the Appellant is a the naturally born bonafide citizen of the Islamic Republic of Pakistan and are fully and equally, on equality basis, entitled to all basic and fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed and enforced by the laws of the land and discrimination alongwith unfettered exercise of discriminatory powers by an authority or office is always been deplored, deprecated and depreciated by superior Courts of the land.
- B. That persistent orders of transfer and posting of any Civil Servant/Government servant is always hazardous and injurious to the Potential and capabilities of the such civil servant /Government servant and has always been depreciated and discouraged by the Superior Courts, being always held as violation to fundamental rights and not solely to the service rights.
- c. That the impugned transfer and posting orders are highly discriminatory ones and at

Appellant to his parent office and even not parent department without any rem and reason and without observing the law on subject while all the blue eyed ones were posted and transferred to their favorite places of posting and were left in field is highly discriminatory and void and amount to falling of the bolt from the blue upon the Petitioner.

- D. That without going in to minute details it would be suffice to mention here that persons who are holding same positions of responsibility on own pay scale & Current Charge Basis to other field offices instead of repatriating all the officials working on CCB & (OPS) to the parent department and thus only the Appellant was subject to unfettered discrimination and even only on this score both the impugned office orders are void and illegal.
- E. That the normal tenure of transfer and posting can only be allowed to be left in rare and exceptional cases and that to in a defined public interest. But here the Appellant has repeatedly been transferred, transferred and



transferred for no reasons, which is certainly not a good omen.

- F. That posting and transferring any Civil Servant/Government Servant on Current Charge Basis & own Pay Scale is a defined mechanism of service laws and a procedure is detailed in Esta Code while the accrued rights, accrued thereupon, are fully protected under the same code whose details are provided under rule 9 of Transfer, Promotion and Appointment Rules of 1989. But here the situation is volte-face and the Petitioners are repatriated to parent office and even not to parent department without any justification and the same tantamount to violation of not only service laws but as well as fundamental law.
- G. That no one can be condemned unheard, nor anyone can be condemned for no wrong.
- H. That even vide the same impugned Notification the posts of the Petitioners have been made vacant, without posting anyone else, which is illegal and void and against the normal course, whereby simultaneously at the transfer of one incumbent another is



transferred and never ever the posts is left vacant.

- I. That from every angle and perspective the impugned transfer and posting orders are illegal, discriminatory, void, unwarranted, vexatious, unlawful and is liable to be cancelled and set aside.
- J. That its pertinent to mention here that while performing duties in his original capacity at Bajour Agency, was posted as Naib Tehsildar in his own pay and scale at Tehsil Wara Mamund on 14/07/2017 and soon after that, was given the additional charge of Political Tehsildar loe Mamund.
- K. That it is pertinent to mention here that infact the post of Political Tehsildar Loe Mamund fall vacant due to martyrdom of Mr. Syed Fawad Ali and as the area was extremely volatile and there were rampart terrorist attacks over responsible officers and the political Tehsildar was used to be the prime target. This was the reason that after the martyrdom of the martyr Syed Fawad Ali Shah, no one was ready to be posted and assumed the charge of that office. At this juncture the additional charge of the same

Tehsil was also entrusted to the Appellant and in the Supervision of the Petitioner, there were conducted two major and numerous minor operations against the miscreants and peace was brought to that ill-fate Tehsil and that Peace is because of the tenacity and unflinching determination of the Petitioner. Even the armed forces and their commanders appreciated and applauded the performance of the Appellant by awarding many certificates.

- L. That the story didn't end here and after bringing peace in Tehsil "Loe mamund", the Appellant was thereafter given the Additional Charge of political Naib Tehsildar Nawagai, along with his first arrangement of political Naib Tehsildar "Wara Mamund" for the same purpose of bringing triquelency and peace in the Nawagai Tehsil on the same lines as carried at "Loe Mamund" and because of Pragmatic Supervision of the Petitioner, peace once again returned and saw the fertile land of Bajour.
- M. That inspite of such glaring performance the Appellant was paid back such chiefly and derisoriously which amounts to embarrassment and almost humiliation.

- N. That it is also pertinent to mention here that unfortunately there is no sanctioned post of Kanungo in Bajour Agency, where against the Appellant can be promoted, being the Senior most Patwari and from where the Appellant could further be Promoted as Naib Tehsildar and Tehsildar the Appellant has also moved many applications for the creation of the post of Kanungo but the same is subject to red tapism of the responsible officers, for whose creation a separate petition shall be filed in due course of time.
- O. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the impugned notification No. 30370 dated 17/08/2018 of the office of Senior Member Board of Revenue may graciously be cancelled and set aside and even if the same is not feasible then the Appellant be posted and transferred in the same capacity of Naib Tehsildar on own pay and scale basis likewise similarly placed Naib Tehsildars and Tehsildars posted on CCB or (OPS)

Any other relief not specifically asked for may also graciously be extended in favour of the petitioners in the circumstances of the case.

INTERIM RELIEF:

By way of interim relief, of the impugned Notification No *Estt:V/PF/30370 dated 17/08/2018* may graciously be suspended, to the extent of the Petitioners, till the final disposal of the instant service appea.

- (3) It will be the sole discretion of the appointing authority to accept or refuse a request for transfer under this rule and any decision made in this behalf shall be final and shall not be quoted as precedence in any other case.
- 3. Appointment on Acting Charge or current Charge Basis. (1) Where the appointing authority considered it to be in the public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the eadre or service concerned, who is otherwise eligible for promotion, does not possess the specified length of service the authority may appoint him to that post on acting charge basis;

¹³Provided that no such appointment shall be made, if the prescribed length of service is short by more than ³⁴[three years].

- (2) So long as a civil servant holds the acting charge appointment, a civil servant junior to him shall not be considered for regular promotion but may be appointed on acting charge basis to a higher post.
- (3) In the case of a post in Basic Pay Scale 17 and above, reserved under the rules to be filled in by initial recruitment, where the appointing authority is satisfied that no simple officer drawing pay in the basic scale in which the post exists is available in that category to fill the post and it is expedient to fill the post, it may appoint to that post on acting charge basis the most senior officer otherwise eligible for promotion in the organization, cadre or service, as the case may be, in excess of the promotion quota.
- (4) Acting charge appointment shall be made against posts which are likely to full vacant for period of six months or more. Against vacancies occurring for less than six months, current charge appointment may be made according to the orders issued from time to time.
