appellant on 08.04.2014 which was responded by the appellant on 07.05.2014. That on verification of the Detailed Marks Certificate submitted by the appellant the same was found fake as per report of the Board of Intermediate & Secondary Education (B.I.S.E), Abbottabad and that on the strength of the same the impugned order dated 03.05.2014 withdrawing the appointment order of the appellant from the date of issuance of the notification was passed.

Learned counsel for the appellant has argued that the appellant 4. has submitted the D.M.C issued to him by B.I.S.E, Abbottabad wherein his marks were shown 506-D. That the said certificate was found fake due to incorrect numbers as the appellant had in fact secured 406-E Marks and a revised certificate was accordingly issued to the appellant. That the mistake committed by the B.I.S.E was not attributed to the appellant as he has submitted the certificate with a clerical mistake made by the Board and without any malafide on the part of the appellant. That the appellant is even entitled to the said seat reserved for employees sons on the basis of revised certificate wherein his marks are shown as 406-E. That even the appellate authority directed the respondent No. 3, District Education Officer (Male) Mansehra to clarify the entire documents of the employee concerned from the concerned board/quarter and that report to be re-submitted to the appellate authority in the light of verification from the concerned quarter. That neither any enquiry was conducted nor appellant associated with any such enquiry and appellant deprived of his vested right on the basis of a report and ex-parte action taken against him.

5. Learned Senior Government Pleader has argued that show cause notice was issued to the appellant and that certificate submitted by him was found fake. That the appellant has taken undue advantage of the said certificate wherein his marks were shown as 506-D while in fact his marks were 406-E.

6. We have heard arguments of learned counsel for the parties and perused the record.

It is not disputed before us that certificate submitted by the 7. appellant at the time of seeking his appointment were reflecting 506-D Marks. It is also not disputed before us that the correct marks assigned to the appellant and reflecting in the subsequent D.M.C bearing S.No. AB 840698 were 406-E. The question as to whether the appellant has tampered with the DMC to secure appointment against the post reserved for deceased sons quota through illegal means would require probe. It would also require re-assessment as to whether the appellant was entitled to the said seat on the strength of deceased sons quota on the strength of 406-E marks which were actually secured by him in the Secondary School Certificate examination. In such circumstances we deem it appropriate to remand the case to the competent authority with the directions to re-investigate the issue of DMC of the appellant so as to ascertain as to whether the said certificate was tampered with by the appellant or so issued by the BISE, Abbottabad with an erroneous entry. The competent authority shall also ascertain as to whether the appellant was entitled to the said appointment on the basis of employees sons quota on the strength of his actual marks i.e. 406-E, at the time of

appointment. The competent authority shall there-after pass an order deemed appropriate.

8. In the light of the above the appeal is accepted and the impugned order dated 03.05.2014 is set aside and appellant stand reinstated in service for the purpose of the denovo enquiry in the mode and manners as observed above which shall be conducted within 2 months from the date of receipt of this judgment. Parties are left to bear their own costs. File be consigned to the record room.


