**NOTIFICATION.**

**No:SOH-(Lit-I) 1-1/2017 (Gen: Misc):** In pursuance of this Department order of even No. dated 16-02-2017, it is clarified that every citizen shall have the right to enter upon any lawful profession or occupation as envisaged under Article-18 of the constitution of Islamic Republic of Pakistan. Therefore, the decision taken in the meeting on 12-07-2006 reflected below sub-para-ix and above sub-para-x of para-5 is hereby repealed. The reasons behind are that the decision ibid affected the hygienic condition of the Health facilities in the Province. In some areas of the Province non-Muslim Sweepers are not available. Furthermore, the posts sanctioned in the budget book are "Sweepers". There is no separate category of Muslim Sweepers and non-Muslim Sweepers.

2. Any vested right accrued in favour of any person in pursuance of decisions already announced by the Hon'ble court and attained finality and this Department order dated 16-02-2017 shall be implemented.

3. Now therefore, it has been decided that whenever the appointment of sweepers are made, preference shall be given to non-Muslims. Wherever, applications/requests are not received as such, the persons belonging to Muslim community shall be appointed as sweepers provided that a certificate of non-availability of non-Muslim candidates will be issued by the concerned Appointing Authority /Selection Committee, or as the case may be. In this regard the person seeking appointment as such, shall submit an affidavit/undertaking on judicial stamp paper duly attested by Oath Commissioner, with no claim of change of cadre.

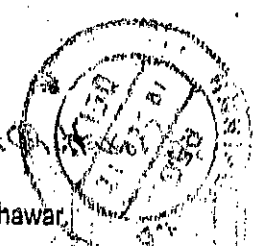
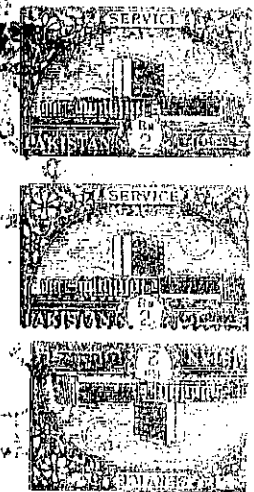

Attention is invited to the minutes of the meeting dated 12.07.2006  
in the Chairmanship of Secretary Health Khyber Pakhtunkhwa circulated  
in the Khyber Pakhtunkhwa Health Department letter No. SOH-III/1-179/06  
dated 25.07.2006. Extract of the decision taken in the meeting is  
as follows:-

It was decided that all the Health Institutions should promote the Muslim  
candidates against existing vacancies of Ward Orderly, Chowkidar, Mali, Dai, Aya  
and Class-IV posts, on seniority basis and not to appoint Muslim  
candidates against the post of Sweepers in future

WHEREAS the above decision was also affirmed by the Hon'ble Peshawar  
Court Peshawar vide judgment dated 27.09.2013 in Writ Petition No.293-  
13-2013 - Titled "Noor ul Qamar S/O Shams ul Qamar Muslim Sweeper THO,  
Shahzad Shabiradár, District Charsadda & 9 others versus Govt of Khyber  
Pakhtunkhwa Health Department & others.

NOW THEREFORE in pursuance of the above decision taken/judgment of the  
Hon'ble Court, it is sufficiently clear that those who were appointed as Muslim  
Sweepers before 12.07.2006 are entitled for adjustment against the  
above mentioned posts without disturbing the quotas reserved under the Rules for  
appointment of Class-IV Govt. Servants and children of  
(retiring/incapacitated/deceased civil servants etc. However, those who were  
appointed as Muslim Sweeper after 12.07.2006 in violation of the above  
decision/judgment are not covered under the policy.

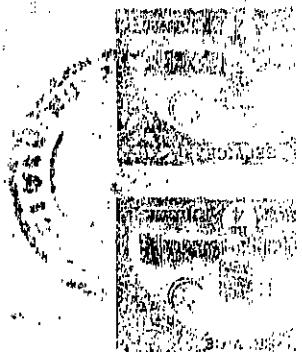

**COMMENTS ON BEHALF OF RESPONDENT NO.7**

***Respectfully Sheweth: -***

The written comments are as under:-

1. That the appellant has no cause of action to file the instant appeal.
2. That the special of the appellant is time barred, hence liable to be dismissed.
3. That the instant appeal is not maintainable as per law.
4. That the appellant has filed the present appeal to pressurize the respondent.
5. That the appellant has not come to this Honnurable Tribunal with clean hands.
6. That the appellant is stopped to sue due to his own conduct.
7. That the instant appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
8. That this Honourable Tribunal has not got jurisdiction to entertain the present petition/appeal as this Honourable Tribunal is not a Constitutional Court, hence this appeal is liable to be dismissed.
9. That the appellant himself submitted an affidavit regarding appointment as Sweeper.

**FACTS**

1. Para No.1 of the appeal does not relates to answering respondent, hence no comment.
2. Para No. 2 of the appeal does not relates to answering respondent, hence no comment.
3. Para No.3 of the appeal is incorrect, the answering respondent No.7 has also applied for the post of "Ward Orderly" and was properly interviewed/recommended and appointed by the competent authority. **Copy of appointment order dated 25.05.2009 as mentioned at S.No.99 is annexed.**
4. Para No.4 of the appeal is also incorrect, the respondent No.7 has also applied for the post of "Ward Orderly" and was called for interview, recommended by the committee and appointed as "Ward Orderly" vide former EDO Health Haripur vide Order No.3490-3622 dated 25.05.2009 at S.No.99 at D-Type Hospital Khanpur, due to certain reasons the order of the respondent No.7 was cancelled and the answering respondent No.7 filed a Writ Petition wherein the EDO committed to consider the petitioner against the post of "Ward Orderly" on availability of the post and for the time being former EDO issued appointment No.3136-38/Estt/App dated 02.08.2010 as **Chowkidar. Copy of order is annexed.**

As per commitment, the Respondent No.7 was called for interview against the post of "Ward Orderly", interviewed and selected by the Selection Committee and the authority issued appointment order of the Respondent No.7 as "Ward Orderly" vide order dated 20.07.2017. **Copies of call letter, minutes of the Selection Committee and appointment order dated 20.07.2017 are annexed.**

- 5. Para No.5 is incorrect, does not relates to the answering respondent.
- 6. Para No.6 is incorrect, does not relates to the answering respondent.
- 7. Para-7 is incorrect, does not relates to the answering respondent.
- 8. Para-8 is incorrect, does not relates to the answering respondent.
- 9. Para-9 is incorrect, misconceived, against the fact and circumstances of the case, the appellant was never selected against the post of Ward Orderly and he was called for interview against the post of Sweeper and upon issuance of order the appellant, he also submitted an affidavit on Judicial Stamp paper that he will be bound of the affidavit as appointed against the post of Muslim Sweeper. Moreover the orders of the respondents No.6&7 were issued in accordance with law, rules and policy, as per committed made before Peshawar High Court, Abbottabad Bench in Writ Petitions. **Copies of call letter, minutes of the meeting, appointment order and affidavit are annexed.**

10. Para-10 is also incorrect.

**REPLY/COMMENTS ON GROUNDS:-**

- (a) Para-a,b,c,d of grounds are does not relates to answering respondent.
- (b) Para-e of ground the impugned order was passed by the competent authority after observing all codal formalities.
- (c) Para-f of ground is incorrect, misconceived, and against the circumstances of the case, respondent No.7 was appointed initially against the post of Ward Orderly vide order 25.05.2009, the same was withdrawn, the respondent No.7




filed Writ Petition, the former EDO issued appointment order of respondent No.7 as Chowkidar for the time being, as per commitment before Honourable Peshawar High Court Abbottabad Bench, the respondent No.7 was called for interview against the post of Ward Orderly and recommended by the Selection Committee, in the light of DSC recommendation, the appointment order of the respondent No.7 was issued in accordance with law.

4. Para-4 is incorrect, hence denied. The respondent No.7 cannot be registered with employment exchange as was serving on permanent post of Chowkidar for last 8 years, and till December salary slips is very crystal clear in this regard.

5. Para-5 to 10 are incorrect, hence vehemently denied. The appellant is Hafiz-e-Quran and qualified electrician, served as Electrician and Tube Well Operator regarding which duty roaster already annexed. The appellant since 30.08.2014 served as Ward Orderly and is registered with employment exchange as Ward Orderly and willfully of respondent No.5 is very clear on this point. The respondents No.1 to 4 cannot change the cadre of respondents No.6 & 7 as per law.

### **FACTUAL OBJECTIONS**

1. Para No.1 is correct regarding appointment of appellant dated 30.08.2014 as ward orderly.
2. In reply to Para-2 is incorrect. The administration is bound to perform duties within law and is not above law.

The affidavit is given by DMS Dr. Dildar Khan who remained in criminal activities regarding which FIR has already been lodged against him. The original affidavit on judicial stamp paper be sent to FSL for matching signature of appellant to bring truth and just to meet the ends of justice. The arrival report not submitted by appellant, the said arrival report is fake, fictitious and forge one and signature of appellant is different one and also not in handwriting of appellant.
6. Para No.8 is incorrect, hence denied. The respondent No.2 never ever gave any reply of departmental appeal of appellant.
7. Para- 9 is incorrect, hence vehemently denied.

**No.SOH-(Lit-I) 1-1/2017 (Gen: Misc):** In pursuance of this Department order of even No. dated 16-02-2017, it is clarified that every citizen shall have the right to enter upon any lawful profession or occupation as envisaged under Article-18 of the constitution of Islamic Republic of Pakistan. Therefore, the decision taken in the meeting on 12-07-2006 reflected below sub-para-ix and above sub-para-x of para-5 is hereby repealed. The reasons behind are that the decision ibid affected the hygienic condition of the Health facilities in the Province. In some areas of the Province non-Muslim Sweepers are not available. Furthermore, the posts sanctioned in the budget book are "Sweepers". There is no separate category of Muslim Sweepers and non-Muslim Sweepers.

2. Any vested right accrued in favour of any person in pursuance of decisions already announced by the Hon'ble court and attained finality and this Department order dated 16-02-2017 shall be implemented.

3. Now therefore, it has been decided that whenever the appointment of sweepers are made, preference shall be given to non-Muslims. Wherever, applications/requests are not received as such, the persons belonging to Muslim community shall be appointed as sweepers provided that a certificate of non-availability of non-Muslims candidates will be issued by the concerned Appointing Authority /Selection Committee, or as the case may be. In this regard the person seeking appointment as such, shall submit an affidavit/undertaking on judicial stamp paper duly attested by Oath Commissioner, with no claim of change of cadre.



3. That the appellant has concealed the facts from this honorable Service Tribunal. Hence not entitled for any relief and appeal is liable to be dismissed.
4. That the appellant has filed appeal on malafidi.
5. That the appeal is against the prevailing law and rules.
6. That the appellant is stopped by his own conduct to file instant appeal.

7. That the instant appeal is not maintainable in its present form and also in the present circumstances of the issue.
8. That the appeal is time barred by the law hence liable to be dismissed on this score alone-
9. That the appeal is liable to be dismissed due to mis-joinder and non-joinder of necessary parties.
10. That the competent authority has done all proceedings according to the law & Rules therefore appeal is liable to be dismissed.

**Facts:**

1. It is incorrect. That the appellant was not appointed as word orderly in DHQ hospital Haripur by provincial Govt. he was purely working on temporary/fixed/contract/daily wages base under the HMB fund and he concealed the terms and condition of temporary appointment under the HMB fund, which are as:
  - a) That, this appointment is purely temporary basis/daily wages.
  - b) In case of poor and unsatisfactory performance/non availability of funds, service can be terminated any time without prior notice.
  - c) They will not claim in future for regularization of their services at any forum/court of law, being daily wages employees.

2. It is correct that during the service, the administration can assign/change duties of Class II or III and Class IV Servants according to the requirement of hospital.

6. Incorrect. The appellant appeared before the selection committee and did not qualify.

7. The appellant appeared before selection committee for the post of sweepers and was selected for the sweeper post. Which he accepted and submitted affidavit /under taking Vide No. 10164 dated 16.12.2017 on judicial stamp of cost 30 rupees duly attested by the notary public. In the affidavit he accepted the post of Muslim sweeper in District Head Quarter Hospital with all terms and conditions regarding the post. In the affidavit the appellant accepted that, I shall perform my duty as Muslim sweeper and during the service, I shall neither claim nor submit sue to any court to change my cadre. He submitted affidavit that, if I did not follow the terms and conditions of my appointment as Muslim sweeper, the department can terminate me from my service without any prior notice. He after selection submitted joining for the post of sweeper

8. It is correct, that the appellant filed appeal before the competent authority which was properly entertained and after perusing the appeal, the appeal was rejected. **(copy attached 04.)**

9. Incorrect, that the respondents have been treated in accordance with the rules regulation.

No non-Muslim had registered himself in the office of the Employment Exchange Haripur for the post of sweeper informed by the Government of Khyber Pakhtunkhwa Employment Exchange Haripur vides Letter No. EE/HPR/VACANCIES/54 dated 29.05.2017. Therefore, recruitment of Muslims sweepers was made for the posts of sweepers.

Government of Khyber Pakhtunkhwa Health Department Vide No. SOH-(Lit-1) 1.1.2017 (Gen: Misc.) has issued directions that it is clarified that every citizen have the right to enter upon any lawful profession or occupation as envisaged under article -18 of the constitution of Islamic Republic of Pakistan. There is no separate category of Muslim sweepers and non-Muslims sweepers. It has been decided that whenever the appointment of sweepers are made, preference shall be given to non-Muslims. Where ever applications / requests are not received as such, the persons belonging to Muslim community shall be appointed as sweepers provided that a certificate of non-availability of non-Muslim candidates will be issued by concerned appointing authority / selection committee or as the case may be.

In this regard the person seeking appointment as such shall submit an affidavit /under taking on judicial stamp paper duly attested by oath commissioner, with no claim of change of cadre.

those who were appointed as Muslim sweepers before 12.07.2006 are entitled for the adjustment against the mentioned post without disturbing the Quotas Reserved under the rule for the appointment of Class IV Government servants and children of Incapacitated/diseased civil servants however, those who were appointed as Muslim sweeper after 12.07.2006 in violation of above decision/judgment are not covered under the policy.

**Grounds:**

- a. Incorrect that the impugned order of Muslim sweeper is legal, lawful, within jurisdiction and without any discrimination as envisaged under article -18 of the constitution of Islamic Republic of Pakistan.
- b. Incorrect that the appellant was treated in accordance with the law and rules and to the policy of Govt. of Kpk Health department notification vide no. SOH-(Lit-1) 1-1.2017 (Gen: Misc.)
- c. Incorrect that the appellant appeared for the post of ward orderly before the selection committee and did not qualify. The appointment order of ward orderlies was issued on 20/7/2017. (copy attached 07)
- d. Incorrect after notification of Employment Exchange office that no non-Muslim registered with this office till date, the Govt. of Kpk Health department issued notification vide no. SOH-(Lit-1) 1-1.2017 (Gen: Misc.) for the recruitment of



Muslim sweeper, that in this regard the person seeking appointment as such shall submit an affidavit/undertaking on judicial stamp paper duly attested by oath commissioner, with no claim of change of cadre.

e. Incorrect that the appointment of Muslim sweeper was done approximately five months after the appointment of ward orderly, office order was issued on 14/12/2017. Appellant / petitioner was appointed according to the law and rules.

f. Incorrect that the appellant after appointment as a Muslim sweeper submitted affidavit / undertaking on the judicial stamp paper duly attested by the oath commissioner, accepting job as a Muslim sweeper with no claim of change of cadre on any forum on court of law.

g. Incorrect that the Waqar Khalid was appointed in the year of 2014 in accordance with the rules and regulation while the appellant appeared before the selection committee in year 2017.

h. Incorrect the appellant was working under HMB funds which was purely temporary job with the terms and conditions that the appellant will not claim for regularization of job at any forum or court of law and service will be terminated any time in case of unsatisfactory/poor performance or no availability of funds without any prior notice.

i. That the respondents seek permission to raise additional grounds at the time of arguments.

It is therefore, most respectfully prayed that on acceptance of reply / comments the appeal of the appellant may graciously be dismissed.







**No.SOH-(Lit-I) 1-1/2017 (Gen: Misc):** In pursuance of this Department order of even No. dated 16-02-2017, it is clarified that every citizen shall have the right to enter upon any lawful profession or occupation as envisaged under Article-18 of the constitution of Islamic Republic of Pakistan. Therefore, the decision taken in the meeting on 12-07-2006 reflected below sub-para-ix and above sub-para-x of para-5 is hereby repealed. The reasons behind are that the decision ibid affected the hygienic condition of the Health facilities in the Province. In some areas of the Province non-Muslim Sweepers are not available. Furthermore, the posts sanctioned in the budget book are "Sweepers". There is no separate category of Muslim Sweepers and non-Muslim Sweepers.

2. Any vested right accrued in favour of any person in pursuance of decisions already announced by the Hon'ble court and attained finality and this Department order dated 16-02-2017 shall be implemented.

3. Now therefore, it has been decided that whenever the appointment of sweepers are made, preference shall be given to non-Muslims. Wherever, applications/requests are not received as such, the persons belonging to Muslim community shall be appointed as sweepers provided that a certificate of non-availability of non-Muslim candidates will be issued by the concerned Appointing Authority /Selection Committee, or as the case may be. In this regard the person seeking appointment as such, shall submit an affidavit/undertaking on judicial stamp paper duly attested by Oath Commissioner, with no claim of change of cadre.

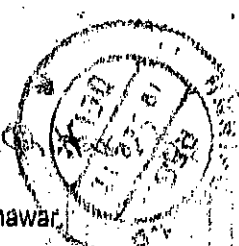

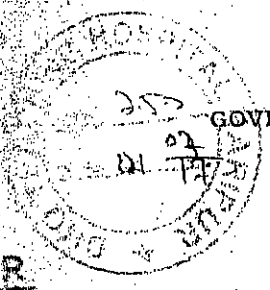

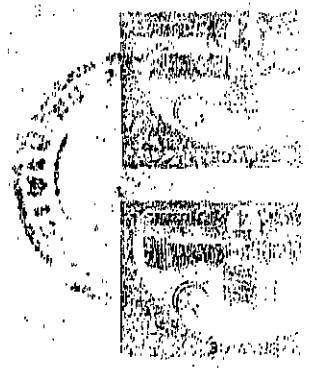
