The written comments are as under:-

- 1. That the appellant has no cause of action to file the instant appeal.
- 2. That the special of the appellant is time barred, hence liable to be dismissed.
- 3. That the instant appeal is not maintainable as per law.
- 4. That the appellant has filed the present appeal to pressurize the respondent.
- 5. That the appellant has not come to this Honnurable Tribunal with clean hands.

FACTS

- 3. Para No.3 of the appeal is incorrect, the answering respondent No.7 has also applied for the post of "Ward Orderly" and was properly interviewed/recommended and appointed by the competent authority. Copy of appointment order dated 25.05.2009 as mentioned at S.No.99 is annexed.

Para No.4 of the appeal is also incorrect, the respondent No.7 has also applied for the post of "Ward Orderly" and was called for interview, recommended by the committee and appointed as "Ward Orderly" vide former EDO Health Haripur vide Order No.3490+3622 dated 25.05.2009 at S.No.99 at D-Type Hospital Khanpur, due to certain reasons the order of the respondent No.7 was cancelled and the answering respondent No.7 filed a Writ Petition wherein the EDO committed to consider the petitioner against the post of "Ward Orderly" on availability of the post and for the time being former EDO issued appointment No.3136-38/Estt/App dated 02.08.2010 as Chowkidar. Copy of order is annexed.

As per commitment, the Respondent No.7 was called for interview against the post of "Ward Orderly", interviewed and selected by the Selection Committee and the authority issued appointment order of the Respondent No.7 as "Ward Orderly" vide order dated 20.07.2017. Copies of call letter, minutes of the Selection Committee and appointment order dated 20.07.2017 are annexed.

- 5. Para No.5 is incorrect, does not relates to the answering respondent.
- 6. Para No.6 is incorrect, does not relates to the answering respondent.
- 7. Para-7 is incorrect, does not relates to the answering respondent.



SERVICE APPEAL REJOINDER ON BEHALF OF APPELLANT

Respectfully Sheweth: -

The appellant submit rejoinder as under:

ON PRELIMINARY OBJECTIONS

- 1. That Para No. 1 of the reply is incorrect, the appellant has cause of action and got locus standi.
- 2. Para No. 2 is incorrect. The appellant came to this Honourable Service Tribunal with clean hands.
- 3. Para-3 is incorrect. The respondents have concealed the material facts from this Honourable Service Tribunal. The respondent No.5 as a sweeper permanent employee of already served 8 years and freshly appointed as Chowkidar which is against the law.
- 4. Para-4 is incorrect, hence denied. The respondent No.7 cannot be registered with employment exchange as was serving on permanent post of Chowkidar for last 8 years, and till December salary slips is very crystal clear in this regard.

5. Para-5 to 10 are incorrect, hence vehemently denied. The appellant is Hafiz-e-Quran and qualified electrician, served as Electrician and Tube Well Operator regarding which duty roaster already annexed. The appellant since 30.08.2014 served as Ward Orderly and is registered with employment exchange as Ward Orderly and willfully of respondent No.5 is very clear on this point. The respondents No.1 to 4 cannot change the cadre of respondents No.6 & 7 as per law.

FACTUAL OBJECTIONS

- 1. Para No.1 is correct regarding appointment of appellant dated 30.08.2014 as ward orderly.
- 2. In reply to Para-2 is incorrect. The administration is bound to perform duties within law and is not above law.
- In reply to Para-3,4&5 considered correct by the respondents .
- 4. In reply to Para-6 is totally incorrect against the facts, the appellant appeared before the selection committee for the post of Ward Orderly and qualified for the said post and was told that the appellant has qualified for the post of Ward Orderly. The respondent No.7 who was permanent Chowkidar in DHQ and served for 8 years and has been appointed fresh on the post of ward orderly against law at the place of appellant on direction of local MPA. The respondent No.7 could not be registered with employment exchange as per law. The appellant is Hafiz-e-Quran and qualified electrician and also served in the department as an Electrician as well as Tube well operator, in this regard duty roaster are crystal clear.

- Para No.7 is absolutely incorrect and false one. The appellant is Hafiz-e-Quran and never ever applied for the post of sweeper. The forge, fake and fictitious affidavit on judicial stamp paper has been prepared by respondents No.1 to 4 and also forged signature put on affidavit which is crystal clear by perusing the affidavit. The respondents No.1 to 4 not only violated and shattered the law of the land but also committed illegal acts and involved in preparation of fake, fictitious and forged affidavit on judicial stamp paper on behalf of appellant which comes in the sphere of criminal act/offence and also action be taken for such offence against respondents No.1 to 4. The affidavit is given by DMS Dr. Dildar Khan who remained in criminal activities regarding which FIR has already been lodged against him. The original affidavit on judicial stamp paper be sent to FSL for matching signature of appellant to bring truth and just to meet the ends of justice. The arrival report not submitted by appellant, the said arrival report is fake, fictitious and forge one and signature of appellant is different one and also not in handwriting of appellant.
- 6. Para No.8 is incorrect, hence denied. The respondent No.2 never ever gave any reply of departmental appeal of appellant.
- 7. Para- 9 is incorrect, hence vehemently denied.

GROUNDS:-

- (a) Para-a ground is incorrect, hence denied. The appellant is Hafiz-e-Quran and never ever applied for the post of sweeper.
- (b) Para-b of the ground is also incorrect and denied. The respondents have not treated appellant in accordance with law and shattered the law of land and policy of Government of Khyber Pakhtunkhwa.
- before selection committee for the post of Ward Orderly as the appellant is registered with Employment Exchange Commission as ward orderly and respondent No.5 already admitted this fact, remaining para is incorrect.
- (d) Para-d of the ground is incorrect and vehemently denied.
- (e) Para-e of the ground is incorrect and vehemently denied. The appellant applied for the post of Ward Orderly and it came in the knowledge of appellant on 08.08.2018 on receiving of letter and after that on 10.08.2018 the appellant filed departmental appeal.
- (f) Para-f is incorrect, baseless and false one, hence denied. The appellant is Hafiz-e-Quran and never ever submitted any affidavit, undertaking on judicial stamp paper for the post of sweeper.

- (g) Para-g is incorrect, hence vehemently denied, one Waqar Khalid was appointed alongwith appellant as Ward Orderly in the year 2014 and again in the year 2017 appointed as Ward Orderly but the appellant has not been appointed as Ward Orderly only on the direction of local MPA respondent No.7 is given preference over the appellant.
- (h) Reply of Para-h is that one Mr. Waqar Khalid was also working along with appellant as Ward Orderly under HMB Funds but in the year 2017 Mr. Waqar Khalid was appointed as Ward Orderly and appellant has been discriminated only on the direction of local MPA and adjusted the respondent No.7 permanent chowkidar as ward orderly.
- (i) Para-I of ground is incorrect, hence denied. the respondents having no right to raise any additional ground as respondents have committed illegal acts.

Pray of the respondents is denied.

It is, therefore, respectfully prayed that on acceptance of this rejoinder, the service appeal of appellant may kindly be allowed.
