#### PRAYER IN APPEAL:

On acceptance of this Appeal, the impugned office orders dated 26.01.2021, whereby the appellant was demoted from higher rank of head constable to constable, order dated 08.02.2021 whereby the appellant was dismissed from service and order dated 21.06.2021 whereby the appeal of the appellant was partially accepted and the dismissal order was converted into compulsory retirement may kindly be Set aside, declared illegal, without lawful authority and in consequence whereof the service of the Appellant may graciously be restored on his previous position with all back benefit and consequential relief etc.

### Respectfully Sheweth:-

The Appellant humbly submits as under:-

1. That the Appellant is the peaceful and law abiding citizen of Pakistan and is entitled for all the rights guaranteed by the Constitution of Islamic Republic of Pakistan, 1973.

- 2. That briefly stated the fact relevant for the purpose of this Appeal are that the Appellant was serving in the Respondents Department since long and the Appellant was performing his duties with great zeal & zest and with full devotion with no complaint whatsoever by any means.
- 3. That the Appellant was performing his duty on the post of "D" List Head Constable, in the meanwhile the Respondent No 3 issued an Office Order OB No. 29 dated 10.01.2019 whereby the Appellant was awarded major punishment on the allegations that he being Moharor of Police Station Thall, he has been found irresponsible and the case property was missing, therefore he has been reverted from the "D" List Head Constable to "C-I" Head Constable. (Copy of the Order dated 10.01.2019 is attached)
- 4. That after some time the Respondent No 3 was having personal grudges with the Appellant, again charge sheeted to the Appellant on the same sort allegations and without conducting regular inquiry, the Respondent No 3 again issued Office Order No. 1045-46 dated 26.01.2021 whereby the appellant was demoted from higher rank of head constable to constable. (Copy of the Order dated 26.01.2021 is attached)
- 5. That it is worth to mention here that the Respondent No 3 once again issued charge sheet, in which same sort of allegations have been leveled

against the Appellant and without giving any opportunity of personal hearing, another impugned order vide dated 10.02.2021 has been issued, whereby the Appellant has been dismissed from service. (Copy of the Order dated 10.02.2021 is attached)

- That thereafter the Appellant filed Departmental 6. Appeal to the Respondent No 2 against the Impugned order dated 26.01.2021 which was pending before the Respondent No 2 and the same was yet to be decided and in the meanwhile the Respondent No 3 issued another Order dated the Appellant 10.02.2021, whereupon dismissed from service and the same was again challenged through Departmental Appeal before the Respondent No 2, which was decided and the dismissal from service order is converted into compulsory retirement from service vide Order previous 21.06.2021, the however dated departmental appeal against the order dated 26.01.2021 was not mentioned in the impugned (Copy of Departmental Appeal and Impugned Order dated 26.01.2021 are attached)
- 7. That the Appellant feeling aggrieved from the acts of Respondents, having no other adequate and efficacious remedy, approaches this Hon'ble Tribunal for set aside of the Impugned Orders mentioned above, on the following grounds inter alia:

GROUNDS:-

A) That the Appellant is peaceful and law abiding citizens of Islamic Republic of Pakistan and are fully entitled to all the basic and fundamental rights as enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.

- That it is settled law that during departmental B) proceeding inquiry officer shall issue charge sheet, statement of allegations, show cause notice etc to the Civil Servant but in this case, no such rules malafide, the which shows followed were discrimination of Respondent No 3 and the entire against the rules law, proceedings are constitution, thus liable to be set aside and declared illegal.
- by the Respondent Department against the Appellant in order to establish the charges levelled against the Appellant which was mandatory under the law, if so no such copy of inquiry has been supplied to the Appellant.
- D) That the Respondent No 3 without giving property opportunity of being heard had illegally and malafidely dismissed the Appellant, which is illegal, unlawful, without lawful authority, void ab initio and is ineffective upon the fundamental rights of the Appellant.

- E) That the acts of the Respondents of not following the relevant rules, regulations which is illegal, unlawful, unnatural, ab-initio, null and voidin the eye of law, hence liable to be declared so.
- F) That the fundamental right of the Appellant has blatantly violated by the Respondents and the Appellant has been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- G) That the Appellant from his time of first appointment till now is performing his duties without any break.
- H) That vested rights have been accrued in favour of the Appellant because he was performing his duties efficiently and with devotion and also without any complaint from any quarter.
- I) That any other ground not raised here specifically may graciously be allowed to be raised at the time of arguments.

#### PRAYER:-

It is, therefore, most humbly prayed that, On acceptance of this Appeal, the impugned office orders dated 26.01.2021, whereby the appellant was demoted from higher rank of head constable to constable, order dated 08.02.2021 whereby the

It is stated on oath that the contents of the instant Application are true and correct to the best of my knowledge and belief and nothing has been kept concealed from this Hon'ble Court.

DEPONENT

This order of mine will dispose off the departments inquiry against IHC Akmal Khan No. 834/IHC on the basis of allegations the he while posted as Moharrar Police Station Thall, in case FIR No. 303 dated 17.09.2017 u/s 302, 365, 203, PPC Police Station Thall the PWs of case were called by the Court for recording their statements but due non-production of case property i.e USB and 02 Mobiles sets no court proceedings were took place. Later on, the Honorable Court issued order for production of the said articles on fixed date i.e 22.10.2018. According to Police Station record these articles were in the safe custody of defaulter IHC. His above act shows his negligence, disinterest and also amount to gross misconduct on his part.

Fle was served with Charge Sheet along-with Statement of Allegations vide No. 113/PA, dated 24.10.2018. Sted Shaukat Al-Shah Bukhari was appointed as Enquiry officer. The Enquiry Officer called him time and again but he did not record his statement. After 15 days he came and submitted his reply. After completion of enquiry, the Enquiry Officer submitted finding report on 07.12.2018 in which he disclosed that the defaulter IHC was Moharrar at the time of registration of FIR and as the Moharrar is responsible for the safe and sound custody of case property, but IHC Akmal Khan did not perform his duty due to which the case property was not produced on time in the Honorable Court. Therefore, the Enquiry Officer recommended him for appropriate punishment.

Thereafter, he was called in orderly room on 01.01.2019 but as usual he remind absent. He once again called in orderly room on 08.01.2019 and heard in person but his reply was found unsatisfactory because he intentionally did not produce case property in the Court.

Keeping in view of above and naving gone through available record, the undersigned has come to the conclusion that he is a careless official and did not take interest in official job in the said case, he misplaced the case property due to which the case process was badly suffered. He being a member of Police Department and posted in responsible post shown negligence intentionally. Therefore, I. Pir Shahab Ali Shah, District Police Officer, Jangu in exercise of the powers conferred upon me, award him major punishment of reversion from the "D" list Mead Constable to C-I Head Constable with immediate effect to the also not to be posted on a responsible post in future.

#### ORDER.

This order will dispose of a departmental appeal moved by Ex-Constable Akmal Khan No. 834 of Operation Staff Hangu against the punishment order, passed by DPO Hangu vide OB No. 35, dated 08.02.2021 whereby he was awarded major punishment of dismissal from service on the allegations of his long absence from lawful duty without any leave or prior permission, total absence comes about 64-days.

Comments as well as relevant record were requisitioned from DPO Hangu and perused. The appellant was also heard in person in O.R held in this office on 16.06.2021. During hearing the appellant did not advance any plausible explanation in his defense to prove his innocence.

Above in view, the undersigned reached to the conclusion that the allegations leveled against the appellant are fully proved however, keeping in view his long service and poor family background, the punishment of dismissal from service is hereby converted into major punishment of Compulsory Retirement from Service.

This order of mine will dispose off the departmental enquiry against Constable Akmal Khan No. 834 on the basis of allegations that he while posted at Police Station Thall was absented himself from official duty with effect from 03.08.2020 to 12.08.2020 (09 days) vide DD No.17 dated 03.08.2020, 24.08.2020 to 15.09.2020 (22 days) vide DD No. 26 dated 24.08.2020, 19.11.2020 to 22.11.2020 (04 days) vide DD No. 28, dated 19.11.2020, 10.12.2020 to 11.12.2020 (01 day) vide DD No.17, dated 10.12.2020, 26.12.2020 to 13.01.2021 (19 days) vide DD No. 13 dated 26.12.2020 and 27.01.2021 to till date vide DD No. 30, dated 27.01.2021 of P.S. Thall without any leave or prior permission from seniors. His habitual absence shown negligence, disinterest and amount to gross misconduct on his

He was served with Charge Sheets and Statement of Allegations vide No. 43/EC, dated 17.08.2020 for which he submitted reply to the Enquiry Officer. Mr. Nazir Khan, DSP City, Hangu was appointed as enquiry officer to conduct departmental enquiry against him. After completion of enquiry, the enquiry officer submitted the finding report on 08.09.2020 and recommended to be awarded major punishment, if agreed?

Thereafter, he was served with Final Show Cause Notice vide No. 206/EC, dated 24.09.2020 through DPO Karak vide this office Memo: No. 6418/EC, dated 17.11.2020, but he failed to submit his reply till to date. Time & again he was summoned to appear before the undersigned in orderly room held on 19.01.2021 & 03.02.2021, but he deliberately absented and did not bother to turn up in his defence.

Keeping in view of above and having gone through available record, the undersigned has come to the conclusion that defaulter Constable is habitual absentee, not taking interest in official job and does not take interest to appear before the undersigned in orderly room as well as to submit his reply to Final Show Cause Notice in self defence. Moreover, in such circumstances, his retention in Police Department is burden on public exchequer, therefore, I, Ikram Ullah, PSP, District Police Officer, Hangu in exercise of the powers conferred upon me, award him major punishment as Dismissal from the Service on account of his irresponsibility and long absence from official duty from the date of his absence with immediate effect.

### ORDER



This order of mine will dispose off the departmental enquiagainst Head Constable Akmal Khan No. 834 on the basis of allegations that he while posted at PS Thall Hangu in light of Learned Court of Judicial Magistrate/Civil Judge Thall, Hangu vide Order No. 07, Dated 07.03.2020, the case proper in shape of gold weighing 15 grams and 200 mg be returned to the petitioner/complainant Baseer-ud-Din s/o Qutab-ud-din r/o Moh: Noor Islam Thall vide FIR No. 558, dated 17.12.2015 u/s 380/34 PPC P.S Thall and conducted an enquiry against him through SDPO Hangu vide his office No. 2205/SDPO, dated 02.11.2020 regarding not handing over the case property to complainant. The same case property was taken into custody and kept it in his home. Consequently, he was granted 03 days casual leave for returning the case property vide DD No. 08 dated 28.09.2020 of P.S Thall, but in vain. Subsequently, he deliberately absented himself from lawful duty without any leave or prior permission from seniors till dated 01.10.2020 vide DD, No. 14 of P.S Thall. Later on, his brother namely Khalid Rehman s/o Sher Afzal r/o Takhti Nasrati District Karak produced a sealed box before the local Police of P.S Thall which the accused HC has kept it in cold storage in his home-Thereafter, the case property of gold weighing 15 grams and 200 mg has been handed over to the complainant/petitioner of aforesaid case in presence of his brother vide DD No. 05, dated 17.10.2020 of P.S Thall. Moreover, according to Register No. 19, sufficient case properties are still outstanding against him thus, SDPO Thall was directed to conduct a secret enquiry into the matter. Similarly, his above illegal act is clear violation of Police Disciplinary Rules, 1975 showing his disinterest, irresponsibility, non-professionalism and amount to gross misconduct on his part, which cannot be ignored.

He was served with charge sheet together-with statement of allegation under Police Disciplinary Rules. 1975 vide this office No.65/EC, dated 13.11.2020 for which he submitted his reply to Mr. Zahid-ur-Rehman, Inspector Legal, Hangu (Enquiry Officer). After completion of enquiry, the Enquiry Officer submitted his finding report dated 30.11.2020 and found him guilty. As such he kept the aforementioned case property (gold) in his house instead of PS Malkhana which now handed over to the actual owner by his brother upon the Court orders. Besides this, his such act shown negligence, irresponsibility & faithlessness which badly affected the reputation of entire Police force as well as violated Police Rules 22-4 to 22-8. Therefore, the Enquiry Officer recommended him to be awarded by major punishment

Moreover, he was summoned time & again to appea ... undersigned in orderly room held on 19.01.2021, but he deliberately turn up in the orderly room.

Keeping in view of above and having gone through available record, the undersigned has arrived at the conclusion that defaulter He Constable Akmal Khan No.834 being Moharrir of the P.S has violated the Po Rules 22-4 to 22-8 and misplaced the case properties as well as his act negligence, irresponsibility & faithlessness badly affected the reputation entire Police force. Therefore, I, Ikram Ullah Khan, PSP, District Police Office Hangu in exercise of the powers conferred upon me, disposed off the enquiry hand by awarding him major punishment of demotion from higher rank of Hea Constable to Constable with immediate effect. 
