

- 1) That, appellant is Posted at the post of Computer Operator in the respondent department and having above 9 year clean service record. And till date no complaint what so ever has been given to the respondent.
- 2) That, on dated:14/09/2018 respondent No.2 Issued instruction to all the superintendent of jail in Khyber Pakhtunhwa were Saturday and Sunday declared closed.(Copy of notification is annexed in 'A')

- 3) That, there are 12 Clerical Staff in the Central Prison Bannu were 4 are belong to IT Branch. But respondent No.3 made discrimination in Distribution in awarding duty on the closed days "Saturday and Sunday".
- 4) That after appellant is given direction to perform his duty on closed days "Saturday and Sunday" due to which petitioner made application for not awarding duty on closed days resultantly respondent No.3 made Complaint against appellant to respondent No.2 due to which send show case notice to the appellant for which reply is also submitted. **(Copies of the Show Case notice and reply is Annexed 'B' & 'C')**
- 5) That after without inquiry personal hearing and cross examination once again on dated 17/12/2021 disciplinary action is initiated once again statement of allegation is forward to the appellant for which appellant also submitted written defense but respondents without inquiry personal hearing without giving inquiry report and without cross examination on witness forward the inquiry and thus on dated 19/04/2022 impugned Minor punishment order issued against appellant. **(Copy of the Statement of allegation inquiry report and minor punishment is annexed 'D','E' & 'F')**
- 6) That appellant made departmental appeal on dated 23/05/2022 to the respondent No.1 but till date not decided hence approach this Honourable Service Tribunal enter alia the following grounds. **(Copies of service appeal, Covering letter & registry receipt are annexed as 'G','H' & 'I')**

GROUND:


- A) That, appellant is not treated according to law, rules and regulations and as per Judgment deliver by the Apex Courts.

- B) That, respondents made discrimination in awarding duties to the clerical staff on closed day.
- C) That, no inquiry is constituted nor personal hearing are made and proceeding against appellant is mala fide and color full exercise of power.
- D) That, Charge is not proved against appellant so the Whole proceeding is based on victimization.
- E) That, Punishment on appellant is stigma on his service record without misconduct and according to service law unlawful order of superior or not binding on subordinate.

It is, therefore, humbly prayed that on acceptance of instant service appeal the punishment order dated: 19/04/2022 may kindly be declared as illegal against law against Khyber Pakhtunhwa E & D Rules 2011 and appellant may kindly be given all back benefits.

As reported by Superintendent Central Prison Bannu vide his letter No. 7938-WE dated 06-12-2021 (copy enclosed) that the ministerial and computer staff are allotted duties on Saturday & Sunday on rotation basis every month. However, when you were allotted duties on Saturday & Sunday in rotation in every month but you refused to perform duty on Sunday, thus you have committed grave misconduct on his part.

2. For the reasons above, you appear to be guilty of inefficiency/misconduct under Rule-3 of the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 and have rendered yourself liable to all or any of the penalties specified in Rule-4 of the Rules ibid.
3. You are, therefore required to submit your written defense within seven (07) days of the receipt of this **Charge Sheet** to the Inquiry Officer, as the case may be.

It is submitted that as per your directions de-novo inquiry was conducted in which:

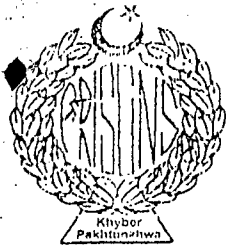
1. Statement of accused official Mr. Arshad Farooq has been obtained and placed as Annex-A.





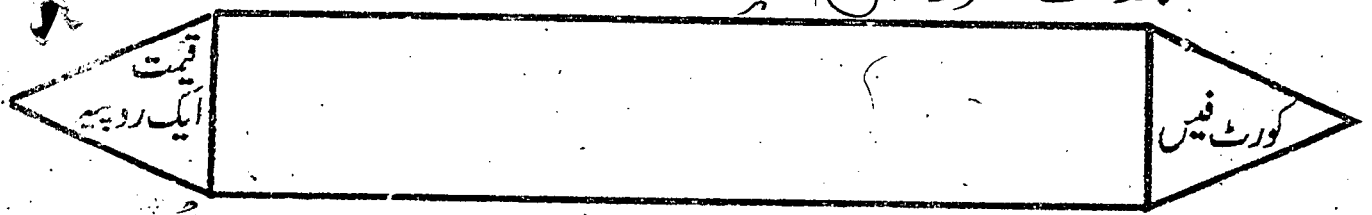
