

**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT-1974 AGAINST THE IMPUGNED NOTIFICATION DATED 22.10.2018 WHEREBY THE APPELLANT HAS BEEN GRANTED PROMOTION WITH IMMEDIATE EFFECT AND NOT FROM THE DATE WHEN THE COLLEAGUES & JUNIOR COLLEAGUES OF THE APPELLANT WERE PROMOTED TO THE POST OF S.S.S (BPS-18) I.E. W.E.F. 16.4.2015 TO AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER**

That on acceptance of this appeal the impugned notification dated 22.10.2018 may very kindly be modified/rectified to the extent of the appellant and granted Ante-dated promotion to the post of Senior Subject Specialist (BPS-18) from the date when appellant Colleagues & Junior Colleagues have been promoted to the post of Senior Subject Specialist (BPS-18) i.e. w.e.f. 16.4.2015 with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be granted in favor of the appellant.

**R/SHEWETH**

**ON FACTS:**

*Brief facts giving rise to the present appeal are as under:-*

- 1- That initially the appellant was appointed as Subject Specialist (BPS-17) on the proper recommendation of the NWFP Public Service Commission and is currently serving as Senior Subject Specialist

(BPS-18) and is performing his duties quiet efficiently and up to the entire satisfaction of his superiors. Copy of the appointment order is attached as annexure..... **A.**

2- That during service as Subject Specialist (BPS-17) the appellant was awarded with major penalty of removal from service vide order dated 03.06.2013 by the respondents. Copy of the Removal from service is attached as annexure ..... **B.**

3- That the appellant feeling aggrieved filed departmental appeal and then after filed Service Appeal No.1307/2013 which was allowed in favour of the appellant by reinstating of the appellant with all back benefits vide judgment dated 10.11.2015. That against the said judgment of the August Service Tribunal the respondents went in CPLA to the Apex Court which was dismissed vide judgment dated 20.6.2016. Copy of the August Service Tribunal Judgment & Apex Court Judgment are attached as annexure ..... **C & D.**

4- That in the meanwhile the colleagues and Junior colleagues of the appellant have been promoted to the post of S.S.S (BPS-18) vide Notification dated 16.04.2015. That the appellant later on in pursuance of the august service Tribunal Judgment and subsequent disposal of the CPLA by the Apex Court the respondents re-instated the appellant into service w.e.f 03.06.2013 i.e. with all back benefits vide order dated 24.08.2016. Copy of the promotion order dated 16.04.2015 & Reinstatement order dated 24.06.2016 are attached as annexure ..... **E & F.**

5- That subsequently the respondent department issued promotion Notification vide dated 22.10.2018 whereby the appellant has been promoted to the post of Senior Subject Specialist (BPS-18) with immediate effects and not from the date 16.04.2015 i.e. from the date when the colleagues and junior colleagues where promoted to the post of Senior Subject Specialist (BPS-18). Copy of the Promotion order dated 22.10.2018 is attached as annexure ..... **G.**

6- That the appellant feeling aggrieved from the impugned promotion Notification dated 22.10.2018 preferred departmental appeal to the appellate authority but the same has not been responded. Copy of the departmental appeal is attached as annexure ..... **H.**

7- That the appellant having no other remedy but to file this appeal on the following grounds amongst others.

## **GROUND:**

- A- That the impugned promotion Notification dated 22.10.2018 issued by the respondents whereby the appellant has been granted promotion to the post of senior subject specialist (BPS-18) with immediate effect rather than with retrospective effect i.e. w.e.f 16.04.2015 is against law, facts, and norms of natural justice and materials on record hence liable to be rectified/ modified.
- B- That the appellant has not been treated by the respondent department in accordance with law and rule on the subject noted above and as such violated Article 4 and 25 of the Constitution of the Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and malafide manner by not granting ante dated promotion to the appellant w.e.f 16.04.2015 i.e. from the date when colleagues and junior colleagues of the appellant have been promoted to the post of Senior Subject Specialist (BPS-18).
- D- That by not granting ante-dated promotion to the appellant by the respondents w.e.f 16.04.2015 to the post of Senior Subject Specialist (BPS-18) is violative of the judgments of the Service Tribunal and Supreme Court.
- E- That by not granting ante-dated promotion to the appellant by the respondents w.e.f 16.04.2015 to the post of Senior Subject Specialist (BPS-18) is against section-8 of Civil Servant Act-1973 read with rule-7 of the Appointment, Promotion and Transfer Rules-1989.
- F- That the issuance of impugned notification dated 22.10.2018 whereby the appellant has been promoted to the post of Senior Subject Specialist BPS-18 with immediate effect rather than with retrospective effect is against the norms of natural justice.
- G- That the impugned notification dated 22.10.2018 violating Article 38(e) of the Constitution of Pakistan 1973 which dictates that state is bound to reduce disparity in the income and earning of the individuals including persons in the various service of Pakistan.
- H- That appellant seeks permission to advance any other proof and grounds at the time of regular hearing.


### TERMS & CONDITIONS:

- 1- Their services will be considered regular but without pension or Gratuity in term of Section-19 of the NWFP Civil Servant Act, 1973 as amended vide NWFP Civil Servants (Amendment) Act, 2005. They will however be entitled to Contributory Provident Fund in such a manner and at such rates as prescribed by the Government.
- 2- Their services will be liable to termination on one month's notice from either side. In case of resignation without notice their two month's pay/allowances, shall be forfeited to Government.
- 3- The appointee should join his/her post within 7-days of the issue of this notification. 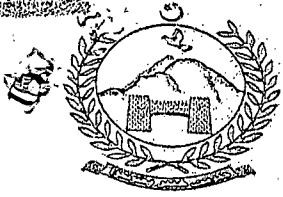

2. The appellant appointed as Subject Specialist  
(Pak Studies) vide order dated 04.10.2006, was  
proceeded under Khyber Pakhtunkhwa Government  
Servants (E&D) Rules, 2011 and removed from  
service vide impugned order dated 03.06.2013. His  
departmental appeal was also rejected vide order dated  
12.08.2013, hence this appeal under Section 4 of the  
Khyber Pakhtunkhwa Service Tribunal Act, 1974.

3. It was submitted by learned counsel for the  
appellant that after his appointment as Subject  
Specialist, the appellant was posted in Allama Iqbal  
Model High School; Sakhakot, Malakand wherefrom  
he was transferred to GHSS, Palai, Malakand. He was  
directed by EDO, E&SE, Batkhela to perform as

Drawing & Disbursing Officer vide order dated 23.10.200. Vide letter dated 27.10.2008, he showed his inability to perform as DDO and requested that the said duty may be assigned to head of some other schools as he was raw handed in the field of accounts. His this request slipped on deaf ears of the seniors. In the meanwhile vide order dated 05.04.2010 one Shah-e-Mulk SST was transferred from GHS Qadra (Gadoon) Swabi to GHSS Palai Malakand. For verification of this transfer order, there is a letter dated 08.04.2010 of the appellant addressed to the EDO (E&SE) Malakand with no response from the addressee. It so happened that in fact one Altaf Abdul Nasir had impersonated the said Shah-e-Mulk. Resultantly, salary of Shah-e-Mulk was withdrawn by the said Altaf Abdul Nasir. The said Altaf Abdul Nasir also who absconded later on. On this, the appellant reported the matter to the local police and when the said Altaf Abdul Nasir was later on arrested by the Anti-Corruption, so he confessed his guilt. However, in this background, the following charge sheet was issued to the appellant along with statement of allegations:-

"Misused your position and needlessly exercised your powers as Drawing & Disbursing Officer by drawing salaries on the basis of fake documents and caused pecuniary loss to the Govt. Exchequer and Private Funds of the schools without verification of the appointment/regularization/transfer order of the forger, Altaf Abdul Nasir, Junior Clerk who impersonated as Shah-e-Mulk, SET and

disappearance of the forger after disclosure of the fraud, by the District Accounts Officer Malakand with the help of Directorate E&SE."

M. Hayat Muhammad, Principal, GHSS Wartair, Malakand was appointed as Enquiry Officer in which responsibility was placed on the said Iltaf Abdul Nasir instead of the appellant. The competent authority, however, ignored this report and without issuance of show cause notice removed him from service.

4. Arguments heard and record perused.

5. The learned counsel for the appellant submitted that no malafide or involvement of the appellant is found on record to implicate him in this case. He further submitted that charge of DDO had been forced on the appellant against which decision, he had timely shown his inability but in vain. He further submitted that transfer order of Shah-e-Mulk was received by the appellant, who had sent the said order for verification to his senior but in vain. He further submitted that even the LPC of Shah-e-Mulk was sent from District Accounts Officer, Swabi but no action was taken against him. The learned counsel for the appellant stressed that the entire fraud was committed by Iltaf Abdul Nasir without malafide or involvement of the appellant that is why the enquiry officer has exonerated him from the charges. The learned counsel

agitated that opportunity of hearing has not been provided to the appellant which has resulted into miscarriage of justice. He requested that the appellant may be reinstated into service with all back benefits.

6. This appeal was resisted by the learned Government Pleader by stating that being DDO, the appellant was required to have exercised due care and caution. He submitted that since loss to government treasury has happened, therefore, the appellant was properly penalized. He requested that the appeal may be dismissed.

7. We have heard learned counsel for the parties and have perused the record.

8. A thorough perusal of the record reveals that the appellant was not found to be involved in the fraud committed by Iltaf Abdul Nasir. In this regard statement of Iltaf Abdul Nasir before the Anti-Corruption was narrated by the learned counsel for the appellant which shows that Iltaf Abdul Nasir had committed so many other frauds in so many other cases as well and the irony is that he was also an employee of the Education Department. It was not shown on behalf of the respondent department that somebody else also sans the appellant may have been



held liable for the fraud committed by Iltaf Abdul Nasir. That no final show cause notice was issued to him nor opportunity of personal hearing was given to the appellant. When there was no malafide or involvement in fraud of Iltaf Abdul Nasir and when the enquiry officer also found him innocent then imposition of major penalty of removal from service is also undoubtedly very harsh. The above aspects of the case were also not-taken <sup>note</sup> into account by the appellate authority. In such a situation, this Tribunal is of the considered view that the impugned orders passed by the competent authority as well as by the appellate authority both suffer from legal infirmity and have caused miscarriage of justice. For the said reasons both orders are set aside. The appellant is reinstated into service with back benefits. Parties are left to bear their own costs. File be consigned to the record.


ORDER

Ejaz Afzal Khan, J.- This petition for leave to appeal has arisen out of the judgment dated 10.11.2015 of the KPK Service Tribunal, Peshawar whereby it allowed the appeal filed by the respondent, set aside the orders of the authority and reinstated him in service with back benefits.

2. The learned Additional Advocate General, KPK appearing on behalf of the petitioner contended that where according to the record the respondent had been hand in glove with the principal accused, he could not have been exonerated in the inquiry and that the authority by examining the record rightly held him responsible and imposed on him the penalty of removal from service.

3. Learned ASC appearing on behalf of the respondent contended that when no misconduct was pinned on the respondent during the course of inquiry by the inquiry officer, the authority could not have taken a different view without issuing a show cause notice to him. The impugned judgment, the learned ASC added, being based on correct appraisal of the material on the record is not open to any exception.

4. We have gone through the record carefully and considered the submissions of the learned Addl. AG as well as learned ASC for the respondent.

5. The record reveals that the respondent was not held guilty during the course of inquiry. There is also nothing on the record to show that anything incriminating appeared against him during the course of inquiry. Where the respondent was not found guilty by the inquiry officer nor did anything incriminating appear against him during the course of inquiry, we are rather amazed to see as to how the authority could take a different view. The authority has the power to disagree with the finding handed down by the Inquiry Officer, but in that case it has to record reasons therefor or send the case back to the Inquiry Officer for de novo inquiry if the inquiry already held is defective or deficient. Without doing the either, we don't understand what dawned upon the authority which led it to hold otherwise. In the circumstances, we would not take a different view even on the basis of presumption when there is no such material on the record to justify it. We, thus, don't feel persuaded to interfere with the impugned judgment.

6. For the reason discussed above, this petition being without merit is dismissed and the leave asked for is refused.

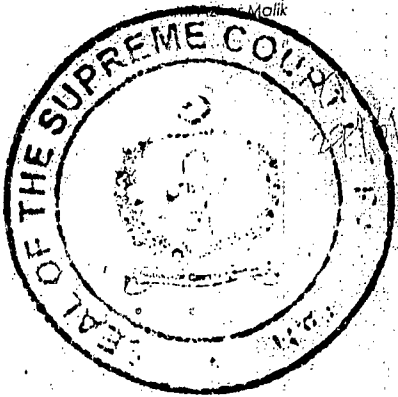
