JUDGMENTHAMID FAROOQ DURRANI, CHAIRMAN:-

1. The appellant submitted Writ Petition No. 2540 of 2018 before the Honourable Peshawar High Court Peshawar, wherein it was prayed that order/direction may please be issued to the effect that the respondent serving in the Teaching Cadre was not legally entitled to be transferred and posted against the post of Administrative/Management Cadre. Consequently, the transfer order dated 4.05.2018 be struck down. The Writ Petition was disposed of on 16.05.2018 with the direction to the office to transmit the original file to this Tribunal for disposal.

2. Learned counsel for the appellant heard and available record gone through.

3. The facts as claimed by the appellant are that she got promoted to BPS-17 in the year 2009 and was posted as Principal, Government Girls Centennial Model

School Swabi. That, she was transferred from the said school to Government Girls High School Gulshan Abad, Maneri Payan as Head Mistress on 01.04.2014. It is the grievance of the appellant that respondent No. 4 was transferred as Principal (BS-18) Government Girls Higher Secondary School, Gulshan Abad Maneri Swabi to which the appellant was entitled.

4. It is not denied that respondent No. 4 was already performing her duty in BS-18 and was working against BS-19 post at GGHSS Baja, Swabi when the impugned notification dated 04.05.2019 was issued. By virtue of notification she was transferred as Principal (BS-18) GGHSS Gulshan Abad Manerai, Swabi. The respondent belonged to the Teaching Cadre throughout and was posted to work as Principal, as such, her cadre was not changed. On the other hand, the appellant has not annexed any document on the record which could suggest that she was ever promoted to BS-18 before issuance of the impugned notification. Besides, a civil servant cannot claim a particular posting as of right under the rules.

5. It is also a fact that the appellant did not prefer any departmental appeal against the impugned notification and straightaway filed the Writ Petition before the High Court which was communicated to this Tribunal for disposal. Under the rules the appellant was obligated to have preferred a departmental appeal before moving a forum of competent jurisdiction for redressal of her grievance.

In the circumstances, the appeal in hand is found meritless and is hereby dismissed in limine. File be consigned to the record room.
