PRAYER:

On acceptance of the instant Service Appeal, this Hon'ble Tribunal may graciously be pleased to direct the respondents to grant the appellant his due right of selection grade from the dated of his regular entry into service as to his other colleagues have been granted.

Respectfully Sheweth:

Facts giving rise to the present Service Appeal are as under:

FACTS:

- 1. That appellant has been serving as SET's (Technical). He has been regularized against his post in the year, 1992 (Annexure-A). He has got longstanding service at his credit with unblemished and clean sheeted conduct record.
- 2. That the Government of Khyber Pakhtunkhwa vide Notification Endst: No. 323-403/A-258 dated 04/07/1987 (Annexure-B) has announced selection Grade (BPS-17) (Personal) in favour of SET (Technical) on the basis of 1/3 Formula.
- 3. That it is pertinent to mention here that respondent No. 2 vide his separate notification (Annexure- C&D) has awarded selection grade in favour of number of SET (Technical) with effect from the date of their regular appointment.

- 4. That it is also pertinent to mention here that respondent No. 3 vide notification dated 16/01/2008 has also awarded (selection grade) in favour of numbers of other SET (Technical) with effect from the date of their regular appointment as SET (Technical) (Annexure-E).
- 5. That the appellant has also entitle to treated at par with his colleagues, who have been awarded selection grade with effect from the date of their regular entry in service as SET (Technical) but the sanctioning authority have treated the appellant differently and has deprived the appellant from award of selection Grade.
- 6. That being aggrieved from the impugned notification, appellant preferred departmental appeal/ review (Annexure-G), but no heed has been paid to the legitimate request of the appellant till the date, hence the instant appeal inter alias on the following grounds:

GROUNDS:

A. That the respondents have not treated the appellant in accordance with law, rules and policy and acted in violation of Article 2 of the Constitution of Islamic Republic of Pakistan, 1973. Appellant was entitled to be awarded selection grade with effect from the date of his regular appoint as per spirit of policy,

but have been deprived of his legitimate right without any lawful justification, which is illegal, unlawful and against natural justice, therefore, this Hon'ble Tribunal has got the jurisdiction to interfere with the require the respondent to take exercise and award up-gradation/ selection grade in favour of the appellant with effect from the date of his regular entry into service as SET (Technical).

- B. That appellant has been discriminated selection grade in favour of other SET (Technical) have been awarded with effect from the date of their regular entry into service and whereas, appellant treated differently, which is against the provision of Article 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- C. That all public powers are in the nature of trust and public functionaries must act as repository of such trust. In the instant case, appellant had legitimate right to be awarded selection grade with effect from the date of his regular entry into service, but have been denied of the same, which violation of public trust.
- D. That appellant was entitled to be treated at par with his other colleagues and awarded up-gradation with effect from the date of his regular entry into service, but have been denied the same benefits, which has been awarded to his other colleagues. This act of the

respondents is against the spirit of law laid down by the August Supreme Court of Pakistan.

E. That appellant would like to seek the permission of this Hon'ble Tribunal to advance some more grounds at the time of hearing.

It is, therefore, humbly prayed that the appeal may kindly be accepted/ allowed as prayed for above.

Any other relief deem appropriate under the law and rules may also be graciously granted.

Respectfully Sheweth:-

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standai.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant service appeal is based on malafide intentions just to put extra pressure on the Respondents for gaining illegal service benefits.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the Appellant has been treated as per law, rules & Policy.
- 9 That the instant appeal is not maintainable in its present form.
- 10 That the appeal is bad for mis-joinder & non-joinder of the necessary parties.
- 11 That the instant Service Appeal is barred by law.
- 12 That the Appellant is not competent to file the instant appeal against the Respondents.
- 13 That the impugned Notification dated 16-2-2000 is legally competent.
- 14 That the scheme of grant of Selection Grade has been discontinued vide Notification dated 27-10-2001 by the Finance Department Govt: of Khyber Pakhtunkhwa.

ON FACTS.

That Para-I is incorrect & misleading on the grounds that the appellant has been granted graded pay vide office order dated May, 1998 in compliance of the judgment dated 23-9-1996 against the post of Workshop Instructor (WI) on the basis of his result declaration of his MA(Technical Education) whereas rest of para relates to the service period of the appellant, hence needs no comments. (copy of the said order attached as Annexure-A).

- 2 That Para-2 is incorrect & denied. The scheme of the grant of selection grade has been discontinued by the Finance Department Govt: Of Khyber Pakhtunkhwa, vide Notification No: FD(PRC) 1-1/2001 dated 27-10-2001, hence in terms of the above said Notification, the appellant is not entitled for the grant of selection grade against the above mentioned post (copy of the said Notification as Annexure-B).
- 3 That Para-3 is also incorrect & denied on the grounds that the scheme of the grant of selection grade has been discontinued vide the above said Notification attached as Annexure-B.
- 4 That Para-4 is incorrect & misleading. The appellant does not fall within the ambit & batch with those civil servants who have been allowed selection grade vide Notification dated 16-01-2008 by the Respondent Department.
- 5 That Para-5 is also incorrect & denied. The date of the service regularization oof the appellant is May, 1998, whereas the referred Notification dated 16-01-2008 is upto the batch of 1989, hence the appellant has been made not entitled for the grant of selection grade neither he can be treated at par with the those officials who have been granted / allowed selection grade in terms of the Notification dated 27-10-2011 issued by the Finance Department.
- 6 That Para-6 is also incorrect & misleading. The appellant has not filed any departmental appeal for the grant of selection grade against the above mentioned post of SET/SST in the light of above made submissions, however the Respondents further submits on the following grounds inter alia:-

ON GROUNDS.

- A Incorrect not admitted. The Respondents have acted as per law, rules & procedure and have not violated any kind of fundamental rights of the appellant in the instant case.

 Hence this ground is also liable to be rejected in the light of the Notification dated 27-10-2001 of the Finance Department in favour of the Respondents.
- B Incorrect & not admitted. The appellant is not entitled for the grant of selection grade in terms of the above referred Notification, nor he has been discriminated in the instant case by the Respondents.
- C Incorrect & denied. The statement of the appellant is without any cogent reason & proof in this ground, hence is liable to be dismissed.
- Incorrect & denied. The scheme of selection grade has been discontinued by the Govt: of Khyber Pakhtunkhwa, vide Notification No: FD(PRC) 1-1/2001 dated 27-10-2001 issued by the Govt: of Khyber Pakhtunkhwa, Finance Department. Hence the appellant is not entitled for the grant of the selection grade against the above mentioned post in the given circumstances.

Sir,

I am directed to state that the Governor of the NWFP has been pleased to sanction, with effect from December 1, 2001, a scheme of the Basic Pay Scales, Allowances and Pensions, 2001 for the Givil employees of the Government of NWFP in BPS 1 to BPS 22 as detailed below:-

PART I - BASIC PAY SCALES AND ALLIED MATTERS.

2. <u>BASIC PAY SCALES:</u> The existing Basic Pay Scales and the revised Basic Pay Scales are shown in Annexure-1 to this letter. The revised basic pay scales shall

replace the existing Basic Pay Scales, 1994, and shall be effective from 1st December, 2001.

- 3. <u>DISCONTINUATION OF ALLOWANCES</u>: The following allowances shall cease to be payable on introduction of the revised pay scales with effect from 01-12-2001:
 - i. Cost of Living Allowance to BPS 1 to BPS 22 @ 7% of basic pay.
 - ii. Adhoc relief of Rs. 300/-p.m. and Rs. 100/-p.m. to BPS 1 to BPS 16 (inclusive of BPS-17 by virtue of Move Over).
 - iii. Secretariat Allowance/Personal Allowance if any/Adhoc Relief as recompense for Secretariat/Personal Allowance.
- 4. <u>SPECIAL ADDITIONAL ALLOWANCE</u>:- Special Additional Allowance sanctioned vide Finance Department's letter No. FD(PRC)1-1/99 dated 26-7-1999 shall be frozen at the level drawn as on date of issue of this letter.
- 5. <u>INITIAL FIXATION OF PAY</u>: Pay of the employees in Government service on 30-11-2001 shall be fixed at the stage in the revised pay scales which is as many stages above the minimum as the stage occupied by him above the minimum of the 1994 Basic Pay Scale.
- 6. PAY FIXATION ON PROMOTION: The existing provisions regulating the fixation of pay in case of promotion from lower to a higher post shall continue to apply.

Pay of an existing employee drawing pay by move over shall be fixed with reference to the pay scale of the post for the time is held by him. In case the employee was drawing pay in Selection Grade, his pay will be fixed in the Selection Grade pay scale. The stage of fixation will be arrived at after allowing increments on notional basis in the original scale of the post or the Selection Grade, in 1994 Basic Pay Scales, upto the point of existing pay. Pay of the employees will then be fixed at the relevant stage in the revised pay scales 2001.

- The Autonomous/Semi Autonomous Bodies will have the option to adopt this pay package provided they have adopted in totality the Basic Pay Scale Scheme/Pension scheme and if their resources so permit as no additional grant will be provided by the Provincial Government. It will not be applicable to those employees of Bank of Khyber and Public Sectors Corporations and those employees who are governed by the Industrial Relations Ordinance 1969 and/or whose financial terms of service are settled through Collective Bargaining Agents. In case of Autonomous/Semi autonomous Bodies where employees are allowed different pay scales/allowances, the revision of the existing pay scales of their employees shall not be made without consultation of the Finance Department.
- All existing rules/orders on the subject shall be deemed to have been modified to the extent indicated above. All existing rules/orders not so modified shall continue in force under this scheme.

Facts giving rise to the present Service Appeal are as under:-

- That appellant has been serving as SET's (Technical). He has been regularized
 against his post in the year, 1992 (Annexure-A). He has got longstanding service
 at his credit with unblemished and clean sheeted conduct record.
- 2. That the Govt of Khyber Pakhtunkhwa vide Notification Endst: No.323-403/A-258 dated 04-07-1987 (Annexure-B) has announced selection Grade (BPS-17) (personal) in favour of SET (Technical) on the basis of 1/3 formula.
- 3. That it is pertinent to mention here that respondent No.2 vide his separate Notifications (Annexure- C & D) has awarded selection grade (Up-Gradation) in favour of number of SET (Tech:) with effect from the date of their regular appointment.
- 4. That it is also pertinent to mention here that respondent No.3 vide Notification dated 16-01-2008 has also awarded up-gradation (selection grade) in favour of numbers of other SET (Tech:) with effect from the date of their regular appointment as SET (Tech:) (Annexure-E).
- 5. That the appellant was also entitle to treated at par with his colleagues, who have been awarded selection grade with effect from the date of their regular entry in service as SET (Tech:), but the sanctioning authority have treated the appellant differently and has awarded up-gradation with immediate effect (Annexure-F) i.e with effect from 25-01-2010.

That being aggrieved from the impugned Notification, appellant preferred departmental appeal/review (Annexure-G), but no heed has been paid to the legitimate request of the appellant till the date, hence the instant appeal inter alias on the following grounds

GROUNDS:-

- A. That the respondents have not treated the appellant in accordance with law, rules and policy and acted in violation of Article 4 of the Constitution of Pakistan, 1973. Appellant was entitled to be awarded selection grade with effect from the date of his regular appoint as per spirit of policy, but have been deprived of his legitimate right without any lawful justification, which is illegal, unlawful and against natural justice, therefore, this Honorable Tribunal has got the jurisdiction to interfere with and require the respondent to take exercise and award upgradation/selection grade in favour of the appellant with effect from the date of his regular entry into service as SET (Tech:).
- B. That appellant has been discriminated; selection grade in favour of other SET (Tech:) have been awarded with effect from the date of their regular entry into service and whereas, appellant treated differently, which is against the provision of Article 25 and 27 of the Constitution of Pakistan, 1973.
- C. That all public powers are in the nature of trust and public functionaries must act as repository of such trust. In the instant case, appellant had legitimate right to be awarded selection grade with effect from the date of his regular entry into service, but have been denied of the same, which violation of public trust.
- D That appellant was entitled to be treated at par with his other colleagues and awarded up-gradation with effect from the date of his regular entry into service, but have been denied the same benefits, which has been awarded to his other colleagues. This act of the respondents is against the spirit of law laid down by the Honourable Supreme Court of Pakistan.

It is therefore, humbly prayed that the appeal may kindly be accepted/allowed as prayed for above.

Any other relief deem appropriate under the law and rules may also be graciously granted.

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/ locus standai.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant service appeal is based on malafide intentions just to put extra pressure on the Respondents for gaining illegal service benefits.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the Appellant has been treated as per law, rules & Policy.
- 9 That the instant appeal is not maintainable in its present form.
- 10 That the appeal is bad for mis-joinder & non-joinder of the necessary parties.
- 11 That the instant Service Appeal is barred by law.
- 12 That the Appellant is not competent to file the instant appeal against the Respondents.
- 13 That the impugned Notification dated 16-2-2000 is legally competent.

ON FACTS.

That Para-I is incorrect & misleading on the grounds that the appellant has been granted graded pay vide office order dated May, 1998 in compliance of the judgment dated 23-9-1996 against the post of Workshop Instructor (WI) on the basis of his result declaration of his MA(Technical Education) whereas rest of para relates to the service period of the appellant, hence needs no comments. (copy of the said order attached as Annexure-A).

- That Para-2 is incorrect & denied. The scheme of the grant of selection grade has been discontinued by the Finance Department Govt: Of Khyber Pakhtunkhwa, vide Notification No: FD(PRC) 1-1/2001 dated 27-10-2001, hence in terms of the above said Notification, the appellant is not entitled for the grant of selection grade against the above mentioned post (copy of the said Notification as Annexure-B).
- 3 That Para-3 is also incorrect & denied on the grounds that the scheme of the grant of selection grade has been discontinued vide the above said Notification attached as Annexure-B.
- 4 That Para-4 is incorrect & misleading. The appellant does not fall within the ambit & batch with those civil servants who have been allowed selection grade vide Notification dated 16-01-2008 by the Respondent Department.
- That Para-5 is also incorrect & denied. The date of the service regularization oof the appellant is May, 1998, whereas the referred Notification dated 16-01-2008 is upto the batch of 1989, hence the appellant has been made not entitled for the grant of selection grade neither he can be treated at par with the those officials who have been granted / allowed selection grade in terms of the Notification dated 27-10-2011 issued by the Finance Department.
- 6 That Para-6 is also incorrect & misleading. The appellant has not filed any departmental appeal for the grant of selection grade against the above mentioned post of SET/SST in the light of above made submissions, however the Respondents further submits on the following grounds inter alia:-

ON GROUNDS.

- A Incorrect not admitted. The Respondents have acted as per law, rules & procedure and have not violated any kind of fundamental rights of the appellant in the instant case.

 Hence this ground is also liable to be rejected in the light of the Notification dated 27-10-2001 of the Finance Department in favour of the Respondents.


