





Facts giving rise to the present appeal are as under:-

1. That appellant is the bonafide resident of the District Bajaur. Initially he was appointed as Junior Clerk then promoted to the post of upper division clerk and still holding the same post. He served the department for more than 35 years having unblemished service record. Now he is at the verge of retirement due in 2020 on the superannuation of age.
2. That on 12.07.2018 a notification (Annexure A) was issued by the respondent No.2 whereby appellant was transferred from the Irrigation Division Bajaur to Directorate of Irrigation and Hydel Power Division FATA Secretariat without cogent reason against which he filed departmental appeal on 04.08.2018 (Annexure B) which was not disposed off within statutory period of 90 days.

Hence this appeal is submitted on following grounds:-

GROUND:-

- A. That appellant was not treated in accordance with rules on subject and passed the impugned order in arbitrary manner. In spite of the facts that appellant is suffering from major disease of Gastro Pain and chest problem (Asthama) for the last 8 years and it is very difficult for him to work at other stations away from home and family. The medical papers are attached as Annexure C.
- B. That appellant is at the verge of retirement from service and according to rules and policy on subject a civil servant be transferred to home district when retirement is due within 2 years but the respondent No.1 ignored this legal right of appellant and passed the impugned order which is illegal and without lawful authority tented with malafide intention which is not sustainable and liable to be set aside.


- C. That the impugned order has been passed during the ban period in post by the Election Commission Islamabad for the purpose of General Election 2018 and election duty was also assigned to him as Assistant Presiding Officer which shows the malafide intention of the respondent No.2.

It is therefore humbly prayed that on acceptance of this appeal, the impugned order dated 12.07.2018 may kindly be set aside and appellant be graciously allowed to perform his duties at his home district till his retirement which is due in year 2020.

Any other relief as deemed appropriate may kindly be granted.
