# APPLICATION FOR EARLY HEARING IN THE MENTIONED EXECUTION PETITION

#### R/SHEWETH:

- 1- That the above mentioned Execution Petition for implementation of the judgment dated 15.09.2021 is pending adjudication before this august Tribunal which was fixed for hearing on 13.09.2022 but due to non-availability of the Honorable bench the date of hearing has been adjourned to 24.10.22.
- 2- That the Execution Petition of the judgment mentioned above is pending before this august Tribunal since 2021 but the respondents time and again strictly directed but inspite that they are not willing to implement the same judgment.
- 3- That inspite of clear directions of this august Tribunal in the judgment mentioned above to modify/rectify the promotion order dated 30.6.20 by including the names of appellants/petitioners but instead implementation of the judgment of this august Tribunal, the respondents conducted several PSB meetings in violation of the judgment of this august Tribunal the 1<sup>st</sup> on 02.12.2021, the 2<sup>nd</sup> on 07.04.2022 and the 3<sup>rd</sup> one on 06.07.2022 while promoted many juniors to the petitioners.
- 4- That the respondents time and again violated the judgment of this august Tribunal by conducting PSB meeting for promotion of further juniors of the petitioners but kept deaf ear on the directions of this august Tribunal.
- 5- That it is further added that it came into the knowledge of the petitioners that the respondents are bent to conducting PSB meeting in the near future for further promotion and if the same has been conducted the petitioner would face with further irreparable loss.
- 6- That the interest of justice demands that such like matter should be heard on an earlier date before the PSB meeting of the respondents to meet the ends of justice and also to meet the principles of access to justice.



It is, therefore, most humbly prayed that on acceptance of this application the above mentioned writ petition may very kindly be fixed for hearing as early as possible.
