

Through the instant appeal under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, the appellant has impugned order dated 28.04.2014 vide which the appellant was posted as DDEO(F) BPS-18 at Kohistan. Against the impugned order, the appellant filed departmental appeal on 04.05.2014 which has not been responded within the statutory period on 90 days, hence the present appeal on 28.08.2014. Counsel for the appellant argued that the impugned order has been passed in violation of transfer/posting policy as husband of the appellant is Government Officer serving as Public Prosecutor in Bannu. Counsel for the appellant submitted an application for interim relief and requested that the impugned order may be suspended. Notice of application should be issued to the respondents for reply/arguments.

Since the matter pertains to terms and conditions of service of the appellant, hence admit for regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, Notice be issued to the respondents for submission of written reply. To come up for written reply/comments on main appeal on 26.11.2014, as well as reply/arguments on application on 03.10.2014.



Copy of the Notification dated 21-3-2014 is filed herewith as Annex "B".

2. That the Respondent has invited applications from BPS-18 Teaching Cadre Officer of Elementary & Secondary Education

That in response to the ibid advertisement, the Appellant applied for her posting against management post of DDEO(F) in BPS-18 and was interviewed by the Placement Committee headed by the Respondent. It is pertinent to mention that during interview the Appellant has disclosed the fact that her spouse is serving as Senior Public Prosecutor (BPS-19) in the Govt of KP and is presently posted as Public Prosecutor in the Court of Special Judge Anti-Corruption (Southern Districts) at Bannu, as notified vide S. No. 5 of the Govt of KP (Home & Tribal Affairs Department's Notification dated 13-5-2013, besides the fact that she is domiciled of F.R. Bannu (FATA) and at present posted at GGHSS No. 2 Bannu.

Copy of the posting orders of the Appellant's Husband dated 13-5-2013 is filed herewith as Annex "D".

4. That it is pertinent to submit that despite the fact that posts of DDEO(F)/DEO(F) Bannu/Lakki Marwat/Karak were also vacant against which the appellant could have been adjusted easily as per Provincial Govt's **"Policy of posting of serving Husband/Wife in the same station"**, promulgated vide S&GAD (Regs Wing) letter dated 11-7-1998. As yet the Appellant was posted as DDEO(F) Kohistan with additional charge of DEO(F) Kohistan.

Copy of the Govt of NWFP (now KP) S&GAD letter dated 11-7-1998 is filed herewith and marked as Annex "E".

5. That since husband of the appellant is serving at Bannu and her 4 x Children are also school going at Bannu coupled with the fact that the Appellant is suffering from spinal cord disease and cannot undertake long journeys by road, therefore, the Appellant had to prefer her application dated 04-5-2014 for review of her posting in the light of provincial Govt's existing policy on posting/transfer of serving spouses on one and the same duty station. It is further pertinent to mention that the Hon'ble the Chief

It is pertinent to mention that during interview the Appellant has disclosed the fact that her spouse is serving as Senior Public Prosecutor (BPS-19) in the Govt of KP and is presently posted as Public Prosecutor in the Court of Special Judge Anti-Corruption (Southern District) at Bannu, as notified vide No 2 of the Govt of KP (Home & Tribal Affairs Department's Notification dated 13-2-2013, besides the fact that she is domiciled of F.R. That it is pertinent to submit that despite the fact that posts of DCEO(F)DEO(F) Bannu/Araki MarwatKarak were also vacant against which the appellant could have been adjusted easily as per Provincial Govt's "Policy of posting of serving husband/wife in the same station", promulgated vide S&GAD (Regs Wing) letter dated 11-7-1998. As yet the Appellant was posted as DCEO(F) Kohistan with additional charge of DEO(F) Kohistan

5. That since husband of the appellant is serving at Bannu and her 4 x children are also school going at Bannu coupled with the fact that the Appellant is suffering from spinal cord disease and cannot undertake long journeys by road, therefore, the Appellant had to prefer her application dated 04-5-2014 for review of her posting in the light of provincial Govt's existing policy on posting/transfer of serving spouses on one and the same duty station. Minister has also issued directions to the Respondent for cancellation/review of the impugned notification as per spouse policy, as reflected in CM Secretariat's letter No. SO-1/CMS/KPK/3-15/2014 dated 08-5-2014 and even No. dated 11-8-2014.

Copies of the CM Sectt's letters (1) dated 08-5-2014 and (2) dated 11-8-2014 are filed as Annex "F/1&2".

6. That even after issue of directive by the Hon'ble the Chief Minister to the Respondent for cancellation/review of the impugned posting order dated 28-4-2014 in the light of spouse policy, the representation/review petition of the Appellant is still pending disposal by the Respondent, even after lapse of the statutory period of 90 days. Hence the Appellant is compelled to prefer this appeal; inter alia; on the following grounds;-

GROUNDS

A. That the impugned Notification of posting of the Appellant as DDEO(F) Kohistan has been issued in total disregard of the provincial Govt's policy on posting/ transfer of serving spouses on one and the same duty station. Therefore, the impugned transfer order is bad in law and is required to be modified and brought in conformity with the existing policy of the provincial Govt.

B. That the impugned transfer order dated 28-4-2014 has been issued in flagrant violation of Rule: 5(5&6) of the KP Rules of Business-1985, which makes it personal obligation of a Secretary to the Provincial Govt to ensure that even the Minister Incharge of the concerned Department strictly comply with the existing policy. Therefore, the impugned transfer order dated 28-4-2014 needs serious visitation and modification for bringing it in conformity with the Rules of Business and the Provincial Govt's existing policy on posting/transfer of serving spouses.

C. That the Appellant has inalienable constitutional and fundamental rights of treatment in accordance with law and equal protection under the law as enshrined in Articles: 4, 25 & 27 of the Constitution of the Islamic Republic of Pakistan-1973 and since the posting/transfer policy enjoys the status of a valid law/rule enacted

by the rules making authority of the provincial Govt (under Section 26 of the KP Civil Servants Act-1973) for regulating the terms and conditions of service of the provincial Govt's employees, therefore, the Appellant is lawfully entitled to be treated in accordance with the existing policy of the Provincial Govt on posting/transfer of serving spouses and since the impugned transfer order of the appellant dated 28-4-2014 has been passed in flagrant violation of the said policy of the provincial Govt, therefore, the same is liable to be modified and brought in conformity with the existing policy.

PRAYER

7. In view of the above humble submissions, it is earnestly prayed that this Hon'ble Tribunal may graciously be pleased to direct that:-

- (a) The impugned transfer order of the Appellant dated 28-4-2014 shall be cancelled and brought in conformity with the provincial Govt's existing policy on posting/transfer of serving spouses.
- (b) The Appellant shall be posted as DDEO(F) Bannu.
- (c) As a matter of INTERIM RELIEF operation of the impugned transfer may please be held in abeyance to the extent of the Appellant, till final disposal of this Appeal.

Prayed accordingly in the interest of justice.

SUBJECT:- POLICY OF POSTING OF SERVING HUSBAND/WIFE
IN THE SAME STATION.

Sir,

In continuation of this Department's circular letter of even number, dated 20-5-1998, I am directed to say that the following policy of the Federal Govt with regard to the posting of husband and wife at one station of duty, has been adopted by the Provincial Govt of N-WFP in respect of its employees working in Govt Departments, Autonomous and Semi-Autonomous Bodies in the N-WFP:-

- (i) Where a request is made for posting at a different station in the same department/service/cadre in which an employee is already serving, the request may be accepted subject to availability of a post in the same PPS.
- (ii) If a request involves temporary deputation to another deptt; it may be processed in consultation with the concerned Deptt; and may be accepted on the prescribed terms of deputation subject to availability of a post in the same BPS.
- (iii) When a request is made for permanent transfer to/absorption in another department/agency, the request may be processed in consultation with the department concerned, subject to the condition that in the event of permanent transfer, seniority shall be determined in accordance with Section-8 of the N-WFP Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- (iv) If there is a tie between two or more Govt Servants for posting at the same station in the same department/unit of an organization, the Govt servant with greater length of service may be preferred.
- (v) Request for posting by a spouse facing serious medical problems may be accorded highest priority.
- (vi) Spouses already posted at one station, including those posted on deputation beyond the prescribed maximum period may normally not be disturbed without compelling reasons of public interest. Requests for extension of deputation period beyond the permissible limit may be considered with compassion if interests of public service would permit.

- (i) Posting of husband and wife at the same station should not be made by dislocation of any Government Servant already serving at a particular station unless his transfer is necessitated by compelling reasons of public interest or within the frame work of general policy of postings and transfers.
- (ii) The prescribed selection authority should be consulted in each case.



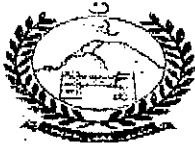

Parawise comments on & for behalf of Respondents No. 1.

Respectfully Sheweth,

The Respondents submit as under:-

Preliminary Objections:-

1. That the appellant has got no cause of action/ locus standi.
2. That the instant appeal is badly time barred.
3. That the appellant has concealed the material facts from this Hon 'able Tribunal, hence is liable to be dismissed on this score.
4. That the appellant has not come to this Hon 'able Tribunal with clean hands.
5. That the appellant has filed the instant appeal on malafide intention just to pressurize the Respondents for illegal service benefits.
6. That the present appeal is liable to be dismissed for mis-joinder & non joinder of necessary parties.
7. That the instant appeal is against the prevailing law and rules.
8. That the appellant is estopped by her own conduct to file the instant appeal.
9. That the instant appeal is not maintainable in its present form and also in the present circumstances of the issue.
10. That the transfer order dated 28-04-2014 is legally competent and is liable to be maintained in favour of the Respondent No. 1.
11. That this Hon'able Tribunal has got no jurisdiction to entertain the instant service appeal.
12. That the Competent Authority under the relevant provision of law has got jurisdiction to transfer and post a civil servant wherever her services against the mentioned post are required, being a provincial cadre post.

FACTS.

1. Para-1 needs no comments being relates to the Service record of the appellant.
2. Para-2 is correct that the respondent department through the Director E&SE, KPK, Peshawar has sought applications for the appointment against the above mentioned post vide advertisement dated 17-01-2014 published in the daily Ajj Peshawar.
3. Para-3 is incorrect and denied the appellant has not disclosed any kind of informations and facts regarding her husband working as a public prosecutor in the court of the Hon'able Special Judge Anti Corruption (Southern Distt: at Bannu) nor any such written proof regarding the alleged plea is available in the office of the Respondent No:1. meaning thereby the appellant is trying to


take shulter spouse policy justice to stick against her post on malafide intension by ignoring the fact that the post of the appellant is of Provincial Cadre post and can be post every where wherever her services are required by the competent authority against the above noted post in the interest of public service.

4. Para-4 is incorrect and denied, detail reply has been given in para-3, hence no further comments.
5. Para-5 is also incorrect and denied that the appellant has been treated as per law, rules and policy in the instant case.
6. Para-6 is also incorrect and denied, the appellant has been treated in the light of the relevant rules and policy as submitted in para-3 of the instant reply. However, the respondent submits on the following grounds inter-alia.

GROUND.

- A. Incorrect and denied: The notification dated 28-04-2014 of the Respondent No. 1 is legally competent and is liable to maintained in favour of the respondent department on the grounds that the appellant has been posted against the post of Dy: DDEO (F) Kohistan which is a management cadre post having no question of spouse policy are posting against the same in the parent/adjacent district of the appellant.
- B. Incorrect and denied, detail reply has been given in the facts of the instant reply, hence no comments.
- C. Incorrect and denied. The respondent No. 1 has acted as per law, rules and set criteria prior to the issuance of order/notification dated 28-04-2014 in favour of the appellant which is not only legal but is also liable to be maintained in favour of the respondent department in the interest of public service and Justice.
- D. Legal, however the respondent No. 1 seeks leave of this Hon'able Tribunal to advance and submit additional grounds in case law at the time of arguments before this Hon'able Bench on the dated fixed.

In view of the above made submissions, it is, therefore, most humbly requested that this Honourable Tribunal may very graciously be pleased to dismiss the appeal in hand with cost in favour of the Respondents.

REJOINDER TO THE PARAWISE COMMENTS

The Appellant above named respectfully submits her rejoinder to the parawise comments filed on behalf of the Respondent as under;-

1. That the contents of Para: 1 to 7 of the Preliminary Objections have not been corroborated. Therefore, the Respondents may not be allowed to advance any corroboration at the time of hearing of this Appeal as the same may take the counsel for the Appellant into surprise, which is not permissible under the law contained in Order-VIII, Rules; 2 to 6 of the Civil Procedure Code.

2. That in rejoinder to the contents of comments on Para: 3 of the facts and Ground "A" & "C" of the memo of Appeal, the Appellant respectfully submits that representation of the Appellant dated 04-5-2014 (already filed as Annex "A/2" with the memo of Appeal is sufficient falsify the contents of Para: 3 of the comments, while the Appellant respectfully draw kind attention of this Hon'ble Tribunal towards Para: VII, IX, X & XI of the Provincial Govt's latest/existing policy on posting/transfer of Provincial Cadre posts so as to falsify the contention of the Respondent to the effect that no question of Spouse Policy arise in the case of Management Cadre Posts of DDEO(F) etc, because the said policy prohibits only the posting/transfer of the posts of DCOs, DPOs(SP) and DSPs in the Districts of domicile, while Para: VII of the said policy allows the posting of executive/administrative officers in the Districts of their domicile. Moreover, Para: IX & X specifically allows posting of female officers at the station of posting of their husbands or residence of their parents. Therefore, the contention of the Respondent is totally whimsical, vexatious and unwarranted in view of the existing posting/transfer policy of Provincial Cadre Posts.

Hence the same may please be ignored. Moreover, both the posts of DEO(F) and DDEO(F) Bannu are still laying vacant while Paras: VII, IX & X of the posting/transfer policy specifically allows posting of the Appellant on the said vacant post(s) not only because of being resident of District Bannu but also because of the posting of her serving husband at Bannu. Hence the instant appeal merits to be allowed.
