SERVICE APPEAL U/S 4 OF SERVICE TRIBUNAL ACT, 1974.

APPEAL AGAINST THE ORDER OF UP-GRADATION / PROMOTION DATED 13/08/2013 AND 14/03/2013 WHEREBY THE JUNIOR COLLEAGUES OF APPELLANT WERE PROMOTED / UP-GRADATED PBS-12 TO 15 WHILE APPELLANT WAS ILLEGALLY, UNLAWFULLY AND DISCRIMINATELY IGNORED.

**Respectfully Sheweth:**

Appellant humbly submitted as under:-

1. The petitioner is appointed as PTC (Teacher) in the year 1987 in Tehsil Nowshera District Peshawar through appointment order dated 12/09/1987 of the District Education Officer,

*(Copy of the appointment order is attached.)*

2. That in the later on Nowshera and Charsadda were given the status of Districts and as such separated from District Peshawar and as such the petitioner remained in District Nowshera being

serving as a PTC Teacher at that time and as such remained out of the District Charsadda.

3. That in the year 1992 Director Primary Education NWFP issued transfer order No. 34/72 on 26/12/1992 whereby the petitioner was transferred from district Nowshera to District Charsadda while served for a period of five years and three months in Nowshera.
4. That after transfer of the petitioner to District Charsadda the service of the petitioner for a period of five years and three months has not been considered / included in the seniority of the petitioner for from BPS-12 to BPS-14 with the exclusion of more than five long years.
5. That in the year 2002 some of the PTC Teacher having the same scale i.e is BPS-12 have been transferred from District Peshawar to District Charsadda through transfer order No.4308/34 dated 23/01/2002 and the same have later on promoted from BPS-12 to BPS-15 by including the period served in District Peshawar vide order No.8169-8332 dated Oct 2013 and order 1465-1996 dated 14/03/2013.

6. That the appellant a filed a writ petition against the above orders of up-gradation / promotion but the Hon'able High Court Peshawar directed the appellant to file an appeal before the Service Tribunal of Khyber Pakhtunkhwa on the above discrimination. (Copy of the Hon'able High Court will be provide at the time of arguments.)
7. That if this Hon'able tribunal fined the appeal of the appellant due to the above reason the appeal of the appellant may be condoned according to law.
8. That feeling aggrieved from the illegal discrimination the petitioner filed a application to the respondents for redressal so that a application to the respondents for redressal so that the period spent in District Nowshera could be included and thereafter the petitioner be promoted according to seniority list but turned affairs to the claims of the petitioner and have never respondent. (Copy of the application alongwith endowment are attached.) hence the instant writ petition before this Hon'able court on the following grounds inter alia:-

referred above has already been promoted from BPS-12 to BPS-15 while the petitioner has been deprived of his promotion to BPS-15 on the ground of exclusion of the period of the service in District Nowshera (Peshawar).

D. That plaintiff was even otherwise, when the petitioner was appointed in year 1987, the present District Nowshera and District Charsadda was collectively part of one District i.e. Peshawar, hence the service i.e. five years and three months already served in Nowshera (Part of District Peshawar) can not be termed as service out of the District, hence the long referred service in Nowshera should have been considered and concluded in seniority of the petitioner in the time of promotion but the same fact has totally being ignored illegally by the responsible.

E. That the Hon'able High Court has held in numerous judgment that no one should be treated discriminately and every citizen has treated equally as per Article 25, and this view have also be adopted by this Hon'able court in W.P No. 428-P/2012, dated 19/06/2013 which is meanly based on the point of discrimination. (Copy of the W.P is attached.)

It is, therefore, humbly prayed that on acceptance of this appeal the respondents may please be directed to include the period of service of the petitioner in Nowshera (Part of District Peshawar) in his seniority and be promoted to BPS-15.

It is further prayed that the petitioner may also be treated equally to other employee of the Education Department (PTC Teacher) who have been promoted from BPS-12 to BPS-15.

That since there was a large scale discrimination between the Computer Operators of the Province of Khyber Pakhtunkhwa and other Provincial Governments and the Federal Government as referred to above, therefore, the Computer Operators of Civil Secretariat, Khyber Pakhtunkhwa time and again agitated against this discrimination and moved applications (*Annex:-H<sub>1</sub>-H<sub>4</sub>*) on 02.11.2009, 03.11.2009, 10.02.2010 and 17.03.2011 thereby bringing their grievances before the worthy Chief Minister, Chief Secretary and the Secretary Finance.
5. That in pursuance of the applications mentioned above, the Finance Department, vide letter dated 18.11.2009 (*Annex:-I*) asked for the Service Rules in respect of the Computer Operators from the Federal Government and other Provincial Governments and accordingly the same were provided to it by the Federal Government vide letter dated 09.01.2010 (*Annex:-J*) and Government of Sindh (*Annex:-K*) but later on the matter was thrown at the backburners without any positive conclusion.

7. That in the year 2007 the Government of Pakistan Finance Division Regulation Wing vide Office Memorandum dated 29.06.2007 (*Annex:-O*) upgraded the Clerical and Auditors posts w.e.f. 01.07.2007 as below:-

8. That, be that as it may, the Government of Khyber Pakhtunkhwa Planning & Development Department vide notification dated 10.10.1992 (*Annex:-R*) had appointed one Mr. Shakirullah as Computer Operator in BPS-16 as back as 20 years and similar is the case with another Computer Operator namely Muhammad Bashir vide Pay Roll (*Annex:-S*). Both of the above mentioned employees were subsequently promoted to BPS-17 vide Notification dated 08.10.2008 (*Annex:-T*).
9. That it will not be out of place to mention here that in the same Secretariat the Assistants in BPS-11 similarly appointed/promoted were subsequently upgraded to BPS-14 as would be evident from their Tentative Seniority List as stood on 30.04.2011 (*Annex:-U*) and even some of them were promoted as Superintendents in BPS-16 vide Notification dated 13.01.2012 (*Annex:-V*) while Computer Operators are still in BPS-12, for example Petitioner No. 0 namely Shakeel Ahmad was also appointed in the year 1989 as Key Punch Operator in BPS-10 and upgraded to BPS-12 in the year 1991 and still he is holding the same Pay Scale in BPS-12 with the sole change that his post was redesignated as Computer Operator.
10. That the acts and actions of Respondents and their refusal to upgrade the posts of petitioners is highly illegal, arbitrary, unconstitutional and hence petitioners being aggrieved of the same, having no other adequate and efficacious remedy, files this

constitutional petition inter-alia on the following grounds:-

Grounds:

- A. That Respondents have not treated petitioners in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully refused to grant up-gradations to petitioners in line with other Governments which is unjust, unfair and hence not sustainable in the eye of law.
- B. That the cases of petitioners and that of other Computer Operators similarly placed serving in identical circumstances in other three sister Provinces and Federal Governments are the same in as much as they are discharging the same duties and responsibilities. Since all the Federating Units and Federation are operating under the umbrella of the same Constitution, therefore, petitioners cannot be treated with a different yardstick and are thus also entitled to the enhanced pay-scales as allowed to others in other Governments.
- C. That the *Objective Resolution* which has been made as substantive part of the Constitution under Article 2A thereof and is considered as sheet-anchor of it provides for equality, social justice as enunciated by Islam and guarantees *Fundamental Rights* including equality of status, opportunity and before law, social, economic and political justice etc. thus the very scheme of Constitution casts a bounden responsibility on all and sundry.

about the equality and equal protection. Viewed from this angle the refusal on the part of the Respondents to equalize the position of petitioners with other similarly placed persons is an affront to the Resolution referred above and hence not sustainable.

D. That under Article 8 of the Constitution any law, any custom or usage having the force of law if repugnant to the Fundamental Rights is void to the extent of its inconsistency and State has been prohibited from making law which takes away or abridges such rights. Article 25 dictates that *all are equal before law and entitled to equal protection of law* which is also the basic concept of Islam under which all persons similarly placed in similar circumstances must be treated alike and when certain rights were declared to be available to one or more persons similarly placed then all such persons similarly placed with them would stand declared entitled to such rights. Thus in this backdrop of the matter petitioners have been highly discriminated inas much as the classification is not based upon reasonable differentia and therefore, the acts and actions of the Respondents militate against the concept of equality and equality in service as enshrined in Articles-25&27 of Constitution of Islamic Republic of Pakistan, 1973.

E. That in the same sequence the *Principles of Policy* incorporated in Chapter-2 of the Constitution which have also been made the responsibility of each organ and authority of the State to act upon it in so far as the same relate to the functions of the organs or authority, directs for the discouragement

inter-alia of the Provincial prejudices amongst the citizens; the promotion with special care of the educational and economic interest of the backward classes; for *promotion of social justice and for the eradication of social evils*; the *promotion of social and economic well being of the people including equality in earnings* of individuals in various classes of the service of Pakistan.

- F. That previously in year 2007 when the Federal Government announced the upgradation of the Ministerial Staff of the Federal Government, the Provincial Government of the Khyber Pakhtunkhwa soon thereafter within the next one month also announced upgradation to the Ministerial Staff throughout the Province in line with the Federal Government but in the instant case a different discriminatory treatment has been meted out to petitioners for no valid reasons.
- G. That even the Respondents in the two precedents referred to above have maintained two Computer Operators in (BPS-16) out of whom one was appointed 20 years ago and now both of them have been promoted to BPS-17 by the Respondent No.1 as has been referred in the Notification dated 08.10.2008, therefore, the refusal on the part of Respondents is not lawful, valid and as such not tenable under the law.
- H. That ground of regrettal posed by the Respondents is totally irrelevant and misplaced one because the office Memorandum dated 02.05.2011 ibid is in respect of Data Entry Operators and not Computer Operators as would be evident from the requisite qualification of Data Entry Operators and

Computer Operators being completely different from each other. The marked difference between the two is that whereas for Computer Operator B.Sc in Computer Science OR B.A in Science Subjects plus one year Diploma in Computer Science are the essential requirements while in case of Data Entry Operators B.A in Science subjects plus Key depression of 10,000 per hour are necessary.

- I. That being a Computer era, computer is the inevitable need and requirement of each and every office because without Computer the official business in the modern era is completely impossible, therefore, the Computer Operators operating computers in offices also require especial attention in view of the importance of their responsibilities but unfortunately the Computer Operators of the Province of Khyber Pakhtunkhwa have continuously been ignored without any lawful justification.

For the aforesaid reasons, it is therefore, humbly prayed that on acceptance of this writ petition, this Hon'ble Court may graciously be pleased to declare the acts and actions of the Respondents and their refusal to upgrade the posts of Computer Operators to BPS-16 as without lawful authority, of no legal effect and hence ineffective upon the rights of petitioners and this august Court may further be pleased to direct the Respondents to act in the matter in accordance with law and to upgrade the posts of Computer Operators of the petitioners to BPS-16 with grant of one Advance Increment with effect from the due date with all consequential back benefits.





MUSARRAT HILALI. J:- Petitioners, through instant petition, seek issuance of an appropriate writ directing the respondents to upgrade their posts from BPS-12 to BPS-16 with one advance increment with effect from the due date and to declare the refusal of respondents to upgrade the same as void ab initio, without lawful authority and of no legal effect.

2. The plea of the petitioners is that they have put in service for 8 to 23 years with no substantial change in their service line; that similarly placed employees serving in identical circumstances in the Federal Government as well as in the Provinces of Sindh, Punjab and Baluchistan are enjoying BPS-16 with identical qualification while the petitioners have been denied the same benefit for no valid reason despite the fact that some of the petitioners have

agitated this issue with the competent authority of Government of Khyber Pakhtunkhwa time and again but to no avail. It is alleged that the Planning and Development Department, Government of Khyber Pakhtunkhwa had appointed one Shakirullah and Muhammad Bashir, Computer Operators in BPS-16, who were subsequently promoted to BPS-17. Moreover, the posts of Clerks, Senior Clerks, Head Clerks, Auditors and Senior Auditors were subsequently upgraded from BPS-5 to BPS-7, 9 and 14, respectively while no such benefit was extended to the petitioners, which is unjust, illegal and arbitrary on the part of respondents.

3. It is contended by learned counsel for the petitioners that the petitioners have been discriminated as the nature of duties of Computer Operators in the Federal Government, Punjab, Sindh, Baluchistan and Khyber Pakhtunkhwa are same, similarly their qualification is also almost the same; that the employees working on the same post in Federal Government, Sindh, Punjab and Baluchistan are in BPS-16 whereas the petitioners with the same qualification performing the same duties have been placed in BPS-12. He referred to Notification dated 30<sup>th</sup> July, 2008 of Ministry of Information Technology (I.T. and Telecom Division), Islamabad, wherein, the post of Computer Operator has been

shown in BPS-16. Likewise, the Computer Operators of Auqaf, Religious Affairs, Zakat and Usher Department, Government of Sindh are shown in BPS-16. Further added that legitimate rights of the petitioners have been infringed, which is clear violation of Articles 25 and 38 of the Constitution of Islamic Republic of Pakistan, 1973. At the last leg of his submissions, the learned counsel prayed that the petitioners may be brought at par with the employees of other Provinces with the same qualification and discharging the same duties.

4. As against that learned AAG while resisting the petition in hand argued that the petitioners accepted the post in BPS-12, therefore, they can not claim BPS-16; that the initial appointment on the same post as per service rules of Sindh, Punjab and Baluchistan is still in BPS-12; that the Federal Government has downgraded the post of Computer Operator as and when vacated by the present incumbents. Federal Government, the Province of Sindh, Punjab and Baluchistan are enjoying BPS-16 with the same qualification and are discharging the same duties and responsibilities as that of Computer Operators serving in Khyber Pakhtunkhwa. When the job of petitioners is identical to the employees of the three Provinces and Federal Government then all shall be dealt with equally and they can not be treated discriminately. The denial of respondents to upgrade the post of petitioners was against the principle of equality as contained in various Articles of the Constitution.

6. It may be noted here that Article 38 (e) of the Constitution of Islamic Republic of Pakistan, 1973 ensures reduction of disparity, income and earning of individual including persons in the various classes of the service of Pakistan. Further, Article 25 also guarantees that all citizens are equal before law and are entitled to equal protection of law, thus, as guaranteed by the Constitution, the persons with similar qualification discharging identical duties shall be treated equally except on the basis of reasonable classifications, which is not the case in hand.

7. No doubt, equal protection does not envisage that every citizen be treated alike in all the circumstances but at the same time the mandate of the Constitution is ensuring

equality before the law that alike be treated alike. In the case of Government of Punjab through Secretary, Finance Department, Lahore Vs. Mubarak Ali Khan and 8 others (PLD 1993 SC 375), wherein, it was held in the following manner:-

*"The employees of the Federal Shariat Court and the Supreme Court of Pakistan have been allowed such an allowance. The High Court employees perform almost identical functions as to the employees of these other Courts perform. The employees of all the three Courts have been dealt with constitutionally by the same provisions reproduced above. In the circumstances, the High Court's employees cannot be discriminated against. The necessary provision of Secretariat Personal Allowance had to be made in respect of such employees as was made in the case of the Federal Shariat Court and the Supreme Court of Pakistan"*

8. Reference is also made to Daniel Murad Vs. Province of NWFP through Chief Secretary, Civil Secretariat, Peshawar and 2 others (2002 PLC (CS) 427), Dr. Naveeda Tufail Vs. Government of Punjab (2003 SCMR 291), Muhammad Munawwar Hussain Vs. Federation of Pakistan (2012 PLC (CS) 362), Qaisar Khan Vs. Chief Secretary, Government of Baluchistan (2001 PLC 1387), Amanullah Khan Yousafzai Vs. Federation of

Pakistan (2011 PLD Karachi 451), Jehanzeb Vs.

Government (unreported judgment), wherein, almost the same view was taken.

9. In the circumstances, the petitioners have been treated in violation of relevant provisions of the Constitution mentioned above.

10. The next argument of the learned AAG that the matter ~~relates to terms and conditions of service of the petitioners is not based~~ on legal hypothesis as up-gradation is movement from lower scale to a higher scale without passing through the criteria of promotional requirements. It merely confers a financial benefit by raising the scale of pay of the post without there being movement from a lower position to a high position. The petitioners have not complained about violation of any terms and conditions of their service rather their grievance is that they have been treated discriminately. Moreover, the controversy regarding the jurisdiction of this court is resolved by the Hon'ble Supreme Court of Pakistan in the case of I.A. Sherwani and others Vs. Government

of Pakistan (1991 SCMR 1041), wherein, it was held as under:-

*However, in the present case the petitioner's case is founded solely on the ground of discriminatory treatment in violation of Article 25 of the Constitution and not because of breach*

of any provision of The Civil Servant Act or any service rules".

11. The objection raised by learned Additional Advocate General on the acquiescence is of no avail to the respondents as they neither ask for their appointment by initial recruitment or by promotion but up-gradation of the post on the strength of equality guaranteed by Article 38 (3) of the Constitution.

For the reasons stated above, we allow this petition and direct the respondents to upgrade the post of the petitioners to BPS-16 with immediate effect with no order as to one advance increment. It is, however, clarified that the incumbents whose pay scale is being upgraded to BPS-16 as a consequence of this order will continue as such and their post will stand downgraded as and when vacated by the present incumbents while initial appointment on the same post as per service rules of Khyber Pakhtunkhwa like other Provinces of Punjab, Sindh and Baluchistan is still in BPS-12.



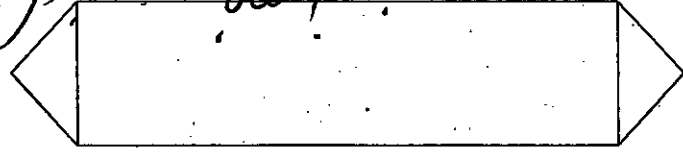
