




6. That prior to the current appeal, the appellant submitted an application to include the name of the appellant in the seniority list of Class IV on dated 05-01-2010. (Copy of letter No. 9327/4-E dated 05-01-2010 is attached as annexure "F")
7. That the appellant has recently come to know that tentative seniority list of Class IV has been issued by respondents, in which the name of the appellant was missing. (Copy of Tentative Seniority List is attached as annexure "G")
8. That the respondent No. 2 issued letter No. 80-E 450/ CE/C & WD Dated 12-04-2010 in which the category of Mate Class IV has been included for preparation of seniority list. Letter No. 80-E 450/ CE/C & WD Dated 12-04-2010 is attached as annexure "H"
9. That the appellant filed appeal to the respondent No. 2 on dated 06-06-2014 to include the name of the appellant in the seniority list, place the appellant in the seniority list and provide promotion to the appellant as per seniority list. (Copy of appeal dated 06-06-2014 is attached as annexure "I")
10. That the respondents rejected the appeal of the appellant through letter No. 575 dated 12-06-2014 and letter No. 1156/4E dated 19-06-2014 which was communicated to the appellant on 23-06-2014. (Copy of letters dated 12-06-2014 and 19-06-2014 are attached as annexure "J" & "K" respectively)

11. That the orders dated 12-06-2014 and 19-06-2014 of the respondents are liable to be set aside / cancelled and the appellant is entitled to include the name of the appellant in the seniority list and promotion as per seniority on the following grounds among others.


Grounds:

- i. That the appellant has kept unblemished record throughout his career and there is no adverse remarks against the appellant in the entire service.
- ii. That appellant is the most senior employee in C & W Department.
- iii. That some juniors have been included in the seniority list while the name of the appellant has been dropped without any reason.
- iv. That the respondents have already included some of the "Mate" in the seniority list and the respondents through their letters included the Mate category in the seniority list, therefore the appellant is also entitled for equal treatment and equal protection of law.
- v. That as per Government policy the category of Mate is dying cadre, therefore there is no other chance of seniority / promotion to the appellant as per Government policy, hence the name of the appellant if not included in the seniority list, the appellant will not be able to get promotion throughout his carrier.
- vi. That the appellant post is in dying cadre, therefore, the appellant is entitled to be included in the seniority list and given promotion as per policy.

- vii. That according to law, policy , rules & regulations of the department, the appellant is entitled to include his name in the seniority list and get promotion.
- viii. That if the name of the appellant is not included in the seniority list, the appellant will be deprived from his due promotion as per policy of the department.
- ix. That appellant will suffer irreparable loss which cannot be compensated at any cost, if the appellant was not included in the seniority list.
- x. That some others grounds may also be taken before the honorable tribunal at the time of arguments with permission of this honorable tribunal.

It is therefore, most humbly prayed that on acceptance of this appeal the appellant name may kindly be included in the seniority list of Class-IV and may kindly be given promotion as per seniority and policy of the department along with all back benefits.
