
Factual Objections

1. Para No. 1 pertains to record.
2. Para No. 2 is correct.
3. Para No. 3 of the instant petition is partially correct, however, it is further stated that the petitioner refused to take over charge in BPS-15 in the school where he was adjusted in BPS-15 due to interested .
4. Para No. 4 of the instant petition is partially correct, however, it is further stated that the petitioner refused to take over charge in BPS-15 in the school where he was adjusted in BPS-1 due to interested .
5. Incorrect. The petitioner was promoted twice times to BPS-15 but the petitioner forgo to take over charge twice times and for third time the petitioner was not entitled to be promoted to BPS-15 as he refused from promotion earlier twice times, however in the next round of promotion to CT. the petitioner was promoted to CT BPS-15 vide promotion order No. 54 25 /PST/Promotion/CT dated Karak the 21/09/2017 where his name is shown at S. No. 4 (Khan Gul). After getting promotion to C.T BPS-15, the petitioner was retired on superannuation vide sanction order No. 145-46 dated Karak the 04/01/2018. (Photocopy of promotion order dated 5420-25 /PST/Promotion/CT dated Karak the 21/09/2017 and retirement order are annexed as **Annexure "A & B"**).
7. Reply of Para No. 7 is that although the names mentioned in this para who were promoted but they refused only one time while the petitioner has refused to accept promotion two time.
8. Reply of this para given in Para No. 7
9. Incorrect. The petitioner has not availed alternate remedy to file departmental appeal before the appellate authority.

Objection on Grounds.

- a. Incorrect.
- b. Incorrect. The petitioner has refused to accept the promotion twice times, therefore, he was not entitled to be promoted to BPS-15 as PHST, however, the petitioner in next round of promotion he was promoted to CT BPS-15 .





4. That again on 13-05-2016 the petitioner was promoted to BPS-
15 on the basis of seniority cum fitness but the petitioner
refused to take charge second time due to domestic problems at
home.
5. That the respondent No.3 has issued promotion order in 2017
whereby the name of the petitioner was at serial number 01 but
the respondent No.3 has refused the name of the petitioner
without any reasons.
6. That 11-10-2013 one M.Islam refused to take charge of
promotion and again he was promoted on 24.02.2017.(Copy of
the order is annexed as "C").

7. That 11-03-2013 Taj Mallok, Aziz Ur Rehman, Khan Gul etc refused to take charge of promotion and again they were promoted on 27.05.2016.(Copy of the order is annexed as "D").
8. That 19-03-2013 Naseem Iqbal etc refused to take charge of promotion and again they were promoted on 31.12.2014 but refused to take charge and on 19-01-2015 he took the charge of the post.(Copy of the order is annexed as "E").
9. That being aggrieved, having no other remedy and dissatisfied by the actions and inactions, misuse of power, illegality, irregularity and excess of power of the respondents, petitioners seek the indulgence of this Hon,ble Court inter alia, on the following grounds;

GROUND S:

- A. That the impugned action of the respondent No.3 not promoted the petitioner on BPS-15 from the date of 19.01.2015 on the basis of seniority cum fitness of the respondent No.3 (District Education Officer male), Karak is void-ab-initio, illegal and is discriminatory in contravention of the provisions of the constitution of Pakistan, thus liable to be set aside.
- B. That the respondent No.3 have promoted the same cadre teacher which were low in the seniority list and they also refused to take charge of promotion twice but they were considered by the competent authority and the orders of promotion have been annexed with petition as annexure "C'D'E' and in the year 2015 the petitioner is at serial number 01 in the merit position of seniority list the respondent No.3 is not promoting the petitioner.
- C. That the article 4 and 25 of the constitution of Pakistan is very much clear and as per the verdicts of the apex court, when any relief is extended to similarly placed persons, the same shall also be extended to those who have even not litigant in case . Supreme Court contained in a judgment reported as 1996 SCMR 1185, the relevant portion whereof is re-produced below for ready reference.

"We may observe that if the tribunal or this court decides a point of law relating to the terms service of a civil servant which covers not only the case of the civil servant who litigated but also of other civil servants, who may have not taken any legal proceedings, in such a case, the dictates of justice and rule of good governance demand that the benefit of the above judgment be extended to other civil servants, who may not be parties to the above litigation

instead of compelling them to approach the Tribunal or any other legal forum".

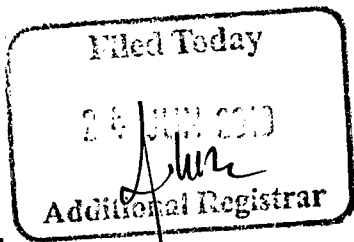
- D. The above view was re-iterated in **2005 PLC (CS) 368 followed in 2006 PLC (CS)11, SCMR 2009 Page-1.**
- E. That the respondent has ignored the position of the petitioner and used pick in choose mind which clearly shows favoritism while in other hand, the respondent has been promoted to bilge according to his own sweet will against the principle of equity and also violated the norms of justice.

It is, therefore, humbly prayed that on acceptance of this Writ Petition, the impugned action of the respondent being not promoted the petitioner to BPS-15 from the date 19.01.2015 may please be declared to be illegal, void-ab-initio and unsustainable and the respondents may further be directed to Performa Promoted the petitioner along with all back benefits in accordance with law .

Any other efficacious remedy may also be granted in favour of the petitioner.

4. Disposed of in view of above terms.


