

AGAINST THE NOTIFICATION DATED 23-05-2022
WHEREBY RESPONDENTS No. 4-6 BEING A JUNIORS
MOST WERE PROMOTED AS JUNIOR CLERK (BPS-
11) WHILE THE APPELLANT BEING SENIOR MOST
WAS IGNORED.**

Respectfully Sheweth;

Brief facts given rise to the instant appeal are as under:

1. That the appellant was appointed on dated 16-11-1987 and performed his duties to the entire satisfaction of his superiors and on many occasions the performance of the petitioner was duly appreciated.
2. That at the time of promotion, the appellant was placed at serial No. 55 (and on serial No. 4 of the eligible candidates) of the Seniority List while respondents No. 4-6 were much juniors in the seniority list.

(Copy of Seniority List is attached as Annex- A)

3. That the appellant thoroughly remained senior in the seniority list but all of a sudden the respondent No. 3 issued the Notification No. 9114-18/F.No.01/DEO(M)/ADO(s)/SEB, Dated 23-05-2022 whereby respondents No. 4-6 being a juniors were promoted while the appellant being a senior most was ignored. The appellant filed Departmental Representation against the illegal act which the respondents left undecided.

(Copy of Notification and Departmental Representation are attached as Annex- B & C)

4. That the impugned Notification is illegal, without jurisdiction, without lawful authority, based on favoritism, malafide and for ulterior motives.

5. That the respondents No. 4-6 have been promoted to BPS-11 and the appellant is still serving in BPS-04 while the respondent No. 4-6 were juniors to the appellant.
6. That the acts of the respondents are coram-non-judice, sheer violation of the fundamental rights of the appellant granted by the constitution of Islamic Republic of Pakistan, 1973 under Article-25, the same is against rules/ policy and well settled principles of justice as well.
7. That it will be in the interest of justice to place and promote the appellant like his other juniors have been promoted.
8. That the appellant has not been treated in accordance with the law, rules and promotion policy.
9. That the appellant filed the instant appeal pre-maturely but the same was returned thereafter maturity the appeal in hand.

10. That the appellant may be allowed to argue further grounds at the time of hearing of the instant appeal, with the kind permission of this Honourable Tribunal.



PRAYER:

- B. Direct** the respondents to promote the appellant from Chokidar (BPS-04) to Junior Clerk (BPS- 11) being eligible and most senior, with all back benefits since 23-05-2022 till issuing of Notification.

C. Any other relief which this Honorable Tribunal deems fit and proper in the circumstances may also be very kindly granted in favour of the appellant.






1. That the above noted service appeal is being filed before this Hon'ble Tribunal, in which no date of hearing has yet been fixed.

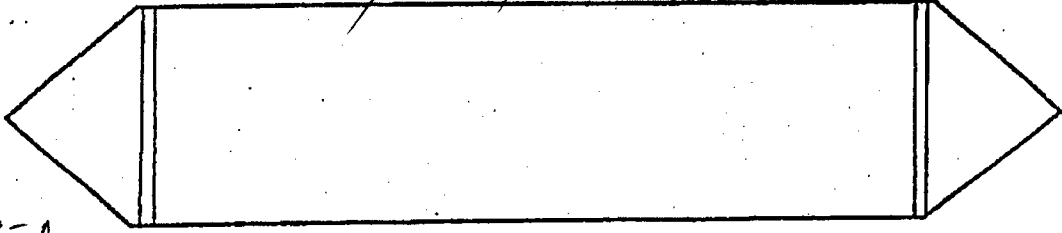
In this view of the matter, this appeal stands returned to the appellant being pre-mature. Office is directed to do the needful in accordance with law.
