Service Appeal under section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 against the impugned Transfer Order dated 09/09/2022 Where by the appellant has been prematurely and on political basis Transferred from the post of Tehsildar Tangai District Charsadda with direction to report to the office of Respondent No. 2 by the Commissioner Peshawar (Respondent No. 2) and Respondent No. 4 was posted as Tehsildar Tangi District Charsadda without any lawful authority, and impugned final order dated 15-09-2022 whereby departmental appeal of the appellant was filled by Respondent No. 1 through a non speaking order in utter violation of Law, Rules and Transfer/Posting policy of the Provincial Government.

## Prayers:

On acceptance of this Service Appeal, the impugned premature, illegal Transfer posting Order dated 09/09/2022 and final order dated 15-09-2022 may graciously be set aside and the appellant may kindly be retain on his previous place of posting i.e Tehsildar Tangai District Charsadda

#### Respectfully shewith:

# The appellant submits as under:

- That the appellant was initially appointed as Patwari and due to his devotion and performance, the appellant was promoted as Girdawar and then Naib Tehsildar however since his appointment the appellant performed his duty with great zeal, zest, honesty and to the entire satisfaction of respondents.
- 2. That though the appellant was a Girdawar however due to his honesty and performance the appellant was entrusted the duties of Naib



Tehsildar firstly in settlement at Abbottabad and thereafter was posted as Naib Tehsildar on revenue side.

- 3. That after regular promotion as Naib Tehsildar, the appellant was posted as Tehsildar (BS-16) against the vacant post of Tehsildar Tangai district Charsada vide order dated 06-06-2022. (Copy of the order dated 06-06-2022 is annex-A)
- 4. That The appellant was surprised to see that he was Prematurely Transferred vide impugned order dated 09/09/2022 and a blue eyed Mr Ajmal Khan (Brother of Mr. Riaz Khan Minister for C&W Department) was posted on his post as Tehsildar Tangai district Charsada which is violation of the transfer posting policy of the provincial Government. (Copy of the impugned order dated 09-09-2022 is annex-B)
- 5. That it is worth to mention that respondent No. 4 was promoted as Tehsildar on acting charge basis (ACB) and was posted at the disposal of Commissioner Malakand Division vide order dated 06-09-2022 however, being a blue eyed chap a corrigendum dated 06-09-2022 was issued whereby respondent No. 4 was placed at the disposal of Commissioner Peshawar Division instead of Commissioner Malakand Division which shows that being brother of Worthy Minister for C&W Department all the orders are political motivated and not issued in the public interest. (Copy of the orders are annex C & D)
- 6. That appellant feeling aggrieved from the impugned order dated 09-09-2022 filled a departmental appeal before respondent No 1 however the same was rejected /filled in a cursory manner vide a non-speaking order dated 15-09-2022. (Copy of the departmental appeal and order dated 15-09-2022 are annex-E & F)
- 7. That the appellant has no other adequate remedy against the impugned order dated 09/09/2022 and final order dated 15-09-2022 hence filing the instant Service Appeal on the following grounds;

# **GROUNDS:**

A. That the impugned orders dated 09/09/2022 and 15-09-2022 are against the law, rules Principles of Natural justice hence void ab initio not sustainable under the law.

B. That as per Transfer Posting Policy of Provincial Government normal tenure on a post for a civil servant is 2 years however the appellant has been made a rolling stone by transferring prematurely vide order date 09/09/2022 in utter violation of the ibid policy.

- C. That as per judgments of superior courts, the authority given to any official shall be exercised as a Public Trust and in accordance with law and rules however the impugned order is an example of colourful exercise of powers in violation of law and Rules.
- D. That the appellant is entitled to be treated equally in accordance with transfer posting policy however the appellant has been discriminated by transferring him prematurely which is violation of Article 4 and 25 of the constitution of Pakistan 1973.
- E. As per reported judgment of Supreme Court of Pakistan 2018 SCMR 1411(b), Section 10 of the Baluchistan Civil Servant Act 1974 did not prescribe a minimum period during which a civil servant must serve at his post, it did not mean that the government without assigning any reason could move a civil servant from the place he was posted to after a month or subject the civil servant to repeated postings in a short period of time because that would amount to punishing him such postings also adversely affected the public interest and resulted in the wastage of scarce resources and constituted bad governance.
- F. That the impugned orders are political motivated has been issued for facilitating brother of a Minister which is sufficient to prove that the impugned orders are not issued in public interest hence the impugned orders are liable to be set-aside on the sole ground.
- G. That by issuing the impugned pre-mature, political motivated orders the respondents violated dictum of the Apex Court in case of Anita Turab.
- H. That the appellant seeks permission of this honourable Tribunal to adduce other grounds during final hearing of the appeal.

It is therefore requested that the appeal may kindly be accepted as prayed for in the heading of the instant appeal.




