JUDGMENT

ROZINA REHMAN, MEMBER (J): Facts gleaned out from the memorandum of appeal are that appellant was appointed as Assistant Sub Inspector through Khyber Pakhtunkhwa Public Service Commission on 20th October, 2006. He was promoted as Officiating Sub Inspector and he performed the duties of an S.H.O in different police stations. His batchmates were promoted but the appellant was neither posted to complete his period of S.H.O ship nor was promoted

with his batchmates despite repeated requests to his high-ups. Lastly, he was confirmed in the rank of S.I on 05.01.2017 and his name was placed on list "F" but with immediate effect. After confirmation, he filed departmental appeal but to no avail, hence the instant service appeal.

Learned counsel for appellant contended that the appellant was initially appointed as Assistant Sub Inspector on 20th October, 2006 and was confirmed in rank of A.S.I vide notification dated 01.01.2010. That in a D.P.C Meeting, other colleagues of the appellant were confirmed whereas the case of appellant was not considered. He submitted that the appellant was confirmed in the rank of S.I on 05.01.2017 but with immediate effect instead of confirming him from the date when his other colleagues were confirmed. Learned counsel further argued that appellant was treated in a discriminatory manner as some other Officiating Sub Inspectors who were deferred for want of deficiency, were confirmed with those colleagues who had been confirmed earlier. He submitted that there is nothing on file which could show any sort of bad entry on the record of the appellant and that he was never superseded. He submitted that in case of deferment for want of any deficiency, seniority is not affected and this is the legal right of the appellant to be confirmed from the date when his other colleagues were confirmed. He contended that such act of the respondents was discriminatory and against the law as the appellant was not treated in accordance with law and his rights guaranteed under the Constitution were badly violated. Reliance was

placed on the judgments of this Tribunal in Service Appeal No. 79/2019; 407/2011; 1227/2013 and 197/2016, wherein, in similar nature cases, relief was granted by this Tribunal. He, therefore, requested for placing the name of the appellant in the confirmation list with his colleagues by ante dating his confirmation to meet the ends of justice with all back benefits.

- 3. Conversely, learned A.A.G submitted that the appellant was provided with several opportunities to show efficiency and good work in the discharge of his official duty as S.H.O but he failed to perform his duty up to the satisfaction of his seniors. He submitted hat he was suspended and was dealt with departmentally on account of inefficiency and misuse of official authority. He contended that confirmation in the rank of S.I is subject to qualifying the laid down criteria and the appellant on the fulfillment of said pre-requisite criteria, under Rule 13.10(2) was confirmed in the rank of S.I without any discrimination.
- 4. Perusal of record would reveal that appellant appointed/recruited as an A.S.I upon the recommendation of Khyber Pakhtunkhwa Public Service Commission. He alongwith batchmates/colleagues, was confirmed in the rank of A.S.I vide notification dated 01.01.2010 and his name was brought on promotion list "E" w.e.f 25.09.2006. Name of the appellant finds mention at Serial No.4, whereas, his colleagues Johar Shah, Abdur Rasheed and Khalid Khan have been placed at Serial No.9, 13 and 14 respectively. His above-mentioned colleagues were confirmed in the

rank of S.I w.e.f 14.03.2012 vide notification dated 10.09.2012, whereas, the appellant was confirmed in the rank of S.I with immediate effect vide notification dated 05.01.2017. There is nothing on file which could show that he was superseded rather he was not considered on the ground of not completing a period of one year as an Officiating Sub Inspector in independent charge of a Police Station in a district. The issue relating to confirmation of the appellant as Sub Inspector from the date when his colleagues were confirmed, holds ground as it was not within the authority of the appellant to post himself as an S.H.O of an independent Police Station. We did not find anything adverse on record except deferment to substantiate his confirmation on later date. It is established from the prevailing rules that civil servant selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se seniority as in the lower post.

5. For the above-mentioned reasons, we are constrained to accept the present appeal with directions to the respondents to place the name of appellant in the confirmation list with his batchmates as Sub Inspector w.e.f 14.03.2012 when his colleagues were confirmed in the rank of S.I and accordingly revise the seniority list with all consequential benefits. Parties are left to bear their own costs. File be consigned to the record room.

The Appellant humbly submits as under:-

1) That the Appellant was appointed in police department, Khyber Pakhtunkhwa as Assistant Sub Inspector in 20th October, 2006 through Public Service Commission and allotted No 135-P.

- That the Appellant after joining his service, rendered valuable service to the police department and performed his duty vigilantly with full zeal and devotion.
- 3) That the Appellant after good service and honest officer, the police promoted as appreciating Sub Inspector rank, allotted No 674-P on 01-01-2010 and performed his duty with full zeal and devotion; and during the said period as Sub Inspector, the Appellant remained four times as SHO in different police stations for a period of 10 month and 15 days.

(Copy of promotion order (1/1/2010) is attached as Annex "D")

4) That the Appellant completed his upper college course along with his batch mates in the year 2011.

(Copy of the course completion certificate is attached as Annex 'E').

5) That the Appellant being SHO Gulbahar was allegedly suspended on account of a fake inquiry and was charge sheeted vide office No 0.13 No 321 dated 06-04-2015. The Appellant was kept suspended for a long period i.e, 15 months although the Appellant sought remedies form concerned but to no avail. Later on, on 06-04-2015, the Appellant's appeal was accepted and he was re-instated in his position and his suspension period was treated as duty.

(Copy of re-instatement order & suspension order attached as Annex "F" & "F-1").

6) That after re-instatement of the Appellant, as his mandatory period of SHO/CIO was short of 1 month and 15 days, he was neither posted to complete his period nor was he promoted with batch mates in DPC'S 2014, 2015 and 2016. The Appellant approached his high ups time and again during these periods but to no avail. At last, on 05-01-2017, the department included Appellant's name in DPC and approved his confirmation in the rank of SI and placed his name on list F. He was allocated new belt number P/21.

(Copy of Confirmation is attached as Annex "G")

7) That the Appellant's colleagues and batch mates all of them have been promoted to the inspector rank. Moreover, many of junior officers than the Appellant have also been promoted to the rank of inspector BPS-16 thus ignoring the Appellant is a gross violation of the law, constitution and his basic rights.

(Copies of notifications of promotion to the rank of inspector BPS-16, attached as Annex H, H-1, H-2, H-3, H-4).

8) That it is relevant to mention here that the Appellant's colleagues/batch mates have also been further confirmed on 19/10/2015 and 15/04/2016 as Inspectors and more of them are working as acting SDPOs (DSPs) in various branches, while depriving the Appellant from his back dated (lawful) promotion will push the Appellant more Juniors then his course mates.

(Copies of confirmation dated 19/10/2015 & 15/04/2016 are attached as Annex "I" & "I-1")

- 9) That it is pertinent to mention here that the Appellant was kept more than 3 years without posting and without confirmation thus hanging his carrier and service without remedies. And later on including him in 2017 DPC, confirming him as SI and placing his name on list F with the same criteria as was before, is neglecting and violation of the law in the part of the department. The Appellant might be promoted in 2014 because he had the same criteria fulfilled as he had in 2017.
- 10) That after confirmation of the Appellant, he moved and application for departmental appeal for instant promotion and seniority, but that too gone in vain

(Copy of departmental appeal attached as Annex "J").

11) That the Appellant finding no other way of remedy approaches this honorable tribunal and seeks permission to adduce other grounds during course of arguments.

Prayer:-

It is therefore, most humbly prayed that on acceptance of this appeal, the respondents 1 and 2 may kindly be directed to promote the Appellant instantly and to designate his seniority with collages of his batch 2006, in service with all back benefits.

Any other relief which deemed appropriate and just in the circumstances of the case may also be extended in the favor of the Appellant. Γ

Therefore, do justice and issue necessary orders for the sake of its assets and appellant's carrier

PRELIMINARY OBJECTIONS.

- 1. That the appeal is badly time barred.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 3. That the appellant has not come to this Tribunal with clean hands.
- 4. That the appellant has no cause of action.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.
- 6. That the appellant concealed the material facts from Honorable Tribunal.
- 7. That the appellant got no locus standi.
- 8. That the appeal is not maintainable in its present form.
- 9. That there is no final order as required by section 4 of the K.P service Tribunal Act 1974.

FACTS:-

- 1- Para No.1 relates to record, hence needs no comments.
- 2- Para No. 2 is incorrect and misleading. Actually appellant was provided several opportunities as SHO to show efficiency and good work in the discharge of his official duty but to no avail and failed to perform his duty upto the satisfaction of his seniors. Subsequently his slackness led to his suspension and he was dealt with departmentally on account of inefficacy and misuse of his official authority.
- 3- Para No. 3 is correct to the extent that he was given a variety of choice postings as SHO at various occasions but he was unable to perform his duty devotedly and with dedication, therefore in the larger interest of general public he was closed to Police Lines from Key posting of SHO and placed under suspension on the charge mentioned therein.
- 4- Para No. 4 relates to record, hence needs no comments.
- Para No. 5 is totally incorrect. Actually on the charges of misuse of official authority and gross misconduct he was placed under suspension and an enquiry against him was also initiated by the competent authority.
- 6- Para No. 6 is incorrect. As explained in the preceding paras he was posted as SHO several times but he could not come up to the expectation of his seniors and failed to perform satisfactorily as SHO of a Police Station. However, it is worth clarifying that

- confirmation in the rank of SI is subject to qualifying the laid down criteria and the appellant on fulfillment of said pre-requisite criteria under Police Rules 13.10(2) was confirmed in the rank of SI on his own merit without any discrimination.
- 7- Para No. 7 is incorrect. No violation of law has ever been carried out by the replying respondents and so far as promotion from the rank of SI to Inspector is concerned the same is purely made after observing the said criteria Rules 13.10(2) of Police Rules 1934. Hence his claim for promotion with his colleagues is not justified under the existing law/rules.
- 8- Para No. 8 is incorrect and devoid of merit as explained in the preceding paras.
- 9- Para No. 9 is incorrect, as explained above confirmation in the rank of SI is strictly followed under Police Rules 10.3(2) and standing orders issued by the competent authority in the best interest of the department.
- 10- Para No. 10 is incorrect. His departmental appeal was not based on reasonable grounds, therefore not considered by the appellate authority.
- 11- Replying respondent also seek permission for raising additional grounds at the time of arguments.






