

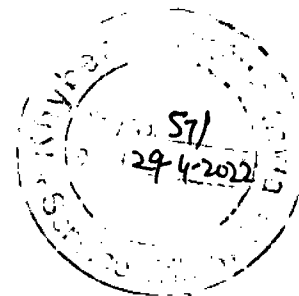

1. That the appellant has filed the instant appeal in this Honourable Tribunal to antedate his appointment w.e.f 28.12.2006 by modifying his appointment notification dated 21.04.2007 with further direction to confirm the appellant in the rank of ASI w.e.f 28.12.2006, S.I w.e.f 13.09.2012 and inspector w.e.f 19.10.2015 when his batch mates and juniors were confirmed in the rank of ASI, SI and inspector respectively by revising his seniority in the rank of ASI, SI and Inspector.
2. 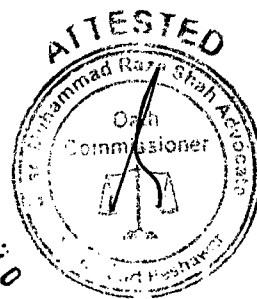

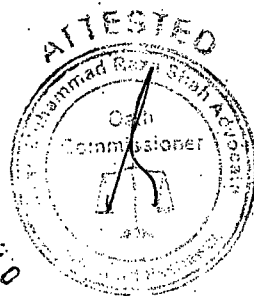

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY KINDLY BE DIRECTED TO ANTEDATE THE APPOINTMENT OF THE APPELLANT W.E.F 28.12.2006 BY MODIFYING HIS APPOINTMENT NOTIFICATION DATED 21.04.2007 WITH FURTHER DIRECTION TO CONFIRM THE APPELLANT IN THE RANK OF ASI, W.E.F 28.12.2006 S.I W.E.F 13.09.2012 AND INSPECTOR W.E.F 19.10.2015 WHEN HIS BATCHE MATES AND JUNIORS WERE CONFIRMED IN THE RANK OF ASI,

SI, AND INSPECTOR RESPECTIVELY BY REVISING HIS SENIORITY IN THE RANK OF ASI, SI, AND INSPECTOR.

RESPECTFULLY SHEWETH:

FACTS.

1. That the appellant applied for the post of ASI through KP Public Service Commission against 19% quota reserved for in service graduate Constable/Head Constable, however one of the candidate namely Mukkaram Shah has filed writ petition No.787/2006 in the Honourable High Court Peshawar for direction to the respondents to call him for interview along with interim relief. The said writ petition was fixed on 14.06.2006. The Honourable Court called comments and withhold recommendation of one of the advertised seat. **(Copies of writ petition and order sheet dated 14.06.2006 are attached as Annexure-A&B)**
2. That in the pursuance of advertisement, the Commission issued the recommendation on 19.07.2006 of ASI against 19% quota reserved for in service graduate Constable/Head Constable and mentioned in that recommendation, that the Commission has withhold recommendation on one post of the Peshawar Region by order of the Peshawar High Court, Peshawar issued on 14.06.2006 in Writ Petition No.787/2006. That recommendations were approved through a memo dated 28.12.2006 and in the pursuance of that approval, they were appointed with effect from 28.12.2006 vide notification dated 05.01.2007, however, due to the withhold of one of the post by Commission on the order of the Honourable Court, the name of the appellant was not mentioned in that recommendation and appointment order. **(Copies of recommendation dated 19.07.2006, memo dated 28.12.2006 and notification dated 05.01.2007 are attached as Annexure-C,D&E)**
3. That the case of the Mukkaram Shah was dismissed by the Honourable Peshawar High Court on 18.01.2007, on which the KP Public Service Commission wrote a letter dated 06.03.2007 to provide service record of the appellant for recommendation and on the recommendation of KP Public Service Commission, the appointment of the appellant was approved as ASI against the 19% quota reserved for in service graduate Constable/Head Constable through memo dated 17.04.2007 and in pursuance of that approval, the appellant was appointed as ASI against 19% quota reserved for in service graduate Constable/Head Constable w.e.f 17.04.2007 vide notification dated 21.04.2007, despite the fact that the batchmates of the appellant were appointed on 28.12.2006 and his recommendation and appointment were delayed due to the reason of withholding of one post by the

Commission on the direction of the Honourable Court in writ petition No.787/2006. **(Copies of judgment dated 18.01.2007, letter dated 06.03.2007, memo dated 17.04.2007 and notification dated 21.04.2007 are attached as Annexure- F,G,H&I)**

4. That due not appointing the appellant along with batchmates w.e.f 28.12.2006, his colleagues and juniors were confirmed in the rank of ASI from the date appointment i.e 28.12.2006 and also brought their name on list "E" vide notification dated 01.01.2010 and in that notification it was clearly mentioned that PASIs of Shuhada sons shall stand juniors from the PASIs appointed through Public Service Commission, while the appellant was confirmed in the rank of ASI w.e.f 17.04.2007 through notification dated 20.01.2011 and then his name in list "E" was revised through another notification dated 07.08.2020. The colleagues and juniors to the appellant were then confirmed in the rank of SI w.e.f 13.09.2012 vide notification 10.10.2012 and further confirmed in the rank of Inspector through notification dated 19.10.2015, while the appellant was confirmed vide notification dated 01.10.2014 with immediate effect and was then confirmed in the rank of inspector on 10.04.2016. The colleagues and juniors to the appellant were promoted to the rank of DSP on 29.11.2018, while the appellant is still working on the post of Inspector. **(Copies of notification dated 01.01.2010, notification dated 20.01.2011, notification dated 07.08.2020, notification dated 10.10.2012, notification dated 19.10.2015, notification 01.10.2014, notification dated 10.04.2016 and notification dated 29.11.2018 are attached as Annexure-J,K,L,M, N,O,P&Q)**
5. That as the appellant has deprived from his legal right of appointment with his batchmates and juniors w.e.f 28.12.2006 and also confirmation/promotion to the rank of ASI, SI and Inspector along with his batchmates and Juniors, therefore the appellant file departmental appeal on 02.09.2021, which was not responded within the statutory period of ninety days. **(Copy of departmental appeal is attached as Annexure-R)**
6. That the appellant has no other remedy except to file the instant appeal for redressal of his grievance on the following grounds amongst others.

GROUND:-


- A) That not taking action on the departmental appeal of the appellant and not appointing the appellant with his batchmates w.e.f 28.12.2006 and not confirming him in the rank of ASI w.e.f 28.12.2006 with batchmates and juniors and brought his name in list "E" with batchmates and juniors, SI w.e.f 13.09.2012 and brought his name in

list "F" with batchmates and juniors and not confirming him in the rank of Inspector w.e.f 19.10.2015 are against the law, rules, facts, norms of justice and material on record, therefore not tenable.

- B) That the appellant was not recommended along with other candidates by KP Public service Commission on 19.07.2006 due to the reason of withholding of one post by Commission on the order of the Honourable Court in writ petition No.787/2006 filed by Mukkaram Shah, which was dismissed by the Honourable Court on 17.01.2007 on which the KP Public Service Commission wrote a letter dated 06.03.2007 to provide service record of the appellant for recommendation and on the recommendation of KP Public Service Commission the appointment of the appellant was approved as ASI against the 19% quota reserved for in service graduate Constable/Head Constable through memo dated 17.04.2007 and in pursuance of that approval, the appellant was appointed as ASI against 19% quota reserved for in service graduate Constable/Head Constable w.e.f 17.04.2007 vide notification dated 21.04.2007, despite the fact that the batchmates of the appellant were appointed on 28.12.2006 and his recommendation and appointment were delayed due to the reason of withholding of one post by Commission on the order of the Honourable Court in writ petition No.787/2006, which means that the appellant is entitle to be appointed with his batchmates w.e.f 28.12.2006 and also entitle to be confirmed in the rank of ASI, SI and Inspector along with his batchmates and juniors.
- C) That the name of the appellant was not recommended on 19.07.2006 along with his batchmates and also not appointed along with his batchmates as P/ASI with effect from 28.12.2006 in notification dated 05.01.2007 due to the reason of withholding of one post by Commission on the order of the Honourable Court in writ petition No.787/2006, which means that the appellant has been punished for no fault on his part by not appointing him along with his batchmates due to stay granted.
- D) That due to not appointing the appellant with his batchmates in memo dated w.e.f 28.12.2006, the appellant has been deprived from his legal right of confirmation in the rank of ASI w.e.f 28.12.2006, SI w.e.f 13.09.2012 and Inspector w.e.f 19.10.2015, which is against the norms of justice and fair play.
- E) That it was clearly mentioned in the notification dated 01.01.2010 that P/ASIs of Shuhada Sons shall be stand junior from the P/ASIs appointed through Public Service Commission, but despite that P/ASIs of Shuhada Sons were kept senior than the appellant and were confirmed earlier than the appellant in the rank of ASI, SI and Inspector, which is violation of the memo dated 01.01.2010.

- F) That according to Rule 13:18 of Police Rules, it was the legal right of the appellant to be confirmed as SI after the lapse of the period of two (02) years, but in the case of the appellant the said rule was not observed.
- G) That the appellant has not been treated in accordance with law and rules and has been deprived from his legal right of appointment w.e.f 28.12.2006 along with his batchmates and confirmation to the rank of ASI, SI and Inspector with his batchmates and juniors.
- H) That due to not appointing the appellant with his batchmates, his batchmates and juniors were promoted to the rank of DSP in the year 2018, while the appellant is still working on the post of Inspector.
- I) That the appellant seeks permission of this Honourable Tribunal to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

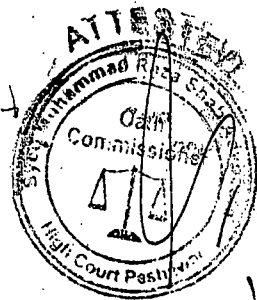

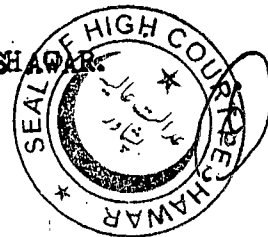



EJAZ AFZAL KHAN, J.- Petitioner through the

instant petition has impugned the letter No.33539 dated 19.5.2006 whereby he has been debarred from competing for the posts of A.S.Is to be filled by promotion.

2. The learned counsel appearing on behalf of the petitioner contended that when the petitioner is part and parcel of the police establishment under Order XXII of 2002, he is bound to be considered for promotion regardless altogether of the fact that he is working as a Head Constable in Islamabad, especially when no such distinction has been made in the advertisement inviting applications for the posts of A.S.Is.

3. The learned DAG appearing on behalf of the respondents contended that petitioner has been labouring under misconception by applying for the

said post and so have been the person processing his application inspite of the fact that these posts were meant to be filled by promotion in the provincial cadre.

4. We have gone through the record and considered the submissions of the learned counsel for the parties.

5. A perusal of the relevant rules would reveal that these posts are meant for departmental promotion from amongst the constables employed within the province. It has absolutely nothing to do with Head Constables or Constables working else where. Though in the advertisement, no distinction has been made but it cannot be taken to over-ride the clear cut rules promulgated by the Provincial Government. When seen in this back ground, we do not think that a case for interference has been made out.

6. For the reasons discussed above, this petition being misconceived is dismissed in limine.



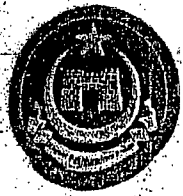

(3) That the appellant was confirmed in the rank of PASIs, vide No. 1066-E1 dated 20.01.2011 w.e.f 17.04.2007 and brought my name on promotion list "E" w.e.f 20.01.2011, which effect my seniority with my other colleagues and most my junior officers become senior. Latter on upon my application the CCPO revised my E- list seniority in light of judgment passed by PHC in writ petition No.3720-P/2018 title Qazi Muhammad Arif Vs Govt of KPk w.e.f 17.04.2007 instead 20.01.2011. In this period most of my junior officers becomes senior.


(4) That according to police rules the appellant was required to have confirmed as sub inspector after satisfactory service of two years but was not confirmed for the reason that I have not been posted as SHO/OII for one year, while my other colleagues including even junior to me were conformed in the rank of Sub inspectors depriving the appellant vide No.1722 dated 10.10.2012. But finally the appellant was confirmed in the rank of SI vide No.13011 dated 01.10.2014 instead of 10.10.2012 notification. Between these two notifications most of the junior officers become senior to me, which suffer my seniority.

Grounds

- A. That fundamental right as per Article 4 of the constitution of the appellant of treatment according to law has been violated.
- B. That the appellant has been deprived of his legal and due rights without any omission or commission on his part, as posted as SHO/OII is not prerogative the appellant rather the same is within the domain of CCPO.
- C. That the appellant never refused of his appointment as SHO/OII, thus there is no fault on his part for not being posted as SHO/OII, and thus the appellant could not be punished when there is no fault on his part.
- D. That the appellant time and again requested for his posting as SHO/OII but every time he was denied such posting for reasons best known to the department while his other colleagues were allowed such posting, the appellant is thus discriminated.
- E. That even confirmation was allowed to those working similarly with the appellant, denial in respect of the appellant, is as such not tenable in the eyes of law.
- F. That even antedated confirmation as sub inspector has been allowed by the Honorable KP service tribunal in many service appeals including service appeal No.107/11 titled as "Nasir khan vs. PPO" , service appeal No. 1264/12 decided on 31..01.2013 service appeal No.37/11 decided on 03.04.2013 and service appeal No. 1021/15 title as "Fazal Dad VS PPO" decided on 25.04.2017 . the appellant as such is entitled to antedated confirmation as sub inspector w.e.f 10.10.2012 (copy of judgments dated 25/4/17 in service appeal No.1011/15 is enclosed as annexure H)
- G. That the appellants having more than 11 years of service with unblemished service record, as evident from his ACRs/Peers'

It is pertinent to mention here that applicant has already submitted an application in response to CCPO letter No. 10738 Dated 06.07.2021 upon which W/CCPO refer the case to DPC, but no outcome till to date.

It is therefore requested that in light of Public service commission merit of order and on acceptance of this application the appellant my kindly be confirmed as sub inspector w.e.f 10/10/12 i.e from the date when his colleagues / junior to him were confirmed as sub inspectors with due seniority in list "F" with all back benefit, and also placed the name of appellant below the name of his colleague "Turab khan s/o Nawab khan r/o Peshawar" as per Public service commission seniority list.
