The instant appeal has been filed by the appellant under Section-4 of KPK Service Tribunal Act, 1974 against the impugned seniority list dated 28.06.2012 and impugned promotion order dated 22.07.2013, whereby seniority of the appellant has been ignored and promoted junior clerks in violation of rules and law. He prayed that on acceptance of this appeal, the impugned seniority list dated 28.06.2012 and promotion order dated 22.07.2013 may kindly be declared illegal, unlawful, null and void, by setting aside the same, and the appellant may be promoted as Senior Clerk with all back benefits.</p> <p>3. Brief facts giving rise to the instant appeal are that the appellant was initially appointed as constable in the Police Department vide order dated 14.05.2001, thereafter the appellant was absorbed alongwith 25 others as Junior Clerks in the same department vide notification dated 12.06.2009, after observing legal and codal</p>

formalities. That on the same day of absorption/posting of the appellant, another notification dated 12.06.2009 was also issued by respondent No.1, whereby 57 fresh candidates were also appointed as junior clerks. That the respondent No.1 issued the impugned seniority list, where the appellant alongwith 25 others absorbed junior clerks were placed after 57 freshly appointed junior clerks in the impugned seniority list, which is against the law, rules and regulation. The appellant was mistakenly placed at serial No.322 instead of 257 in the impugned seniority list. The respondent No.1 should have placed the appellant at serial No. 257 in the impugned seniority list as per rules and regulations and notifications issued by the respondents, but not doing so, committed irregularities, violation of rules and irregularities, therefore, is ineffective on the rights of the appellant. That feeling aggrieved from the impugned order of seniority list, the appellant filed departmental appeal before respondent No.1 for considering the appellant for promotion and seniority. The respondent No.1 directed to respondent No.5 to provide attested copies of the arrival report of the appellant and duly submitted vide office letter dated 06.09.2012. That the respondent No.1 issued an impugned promotion order dated 22.07.2013 on the basis of impugned seniority list by ignoring the grievances of the appellant. That appellant filed another departmental appeal before the respondent No.1 to which the reply was received vide letter dated 10.10.2013, whereby the appellant name will be included in the next DPC, however the time and date has not been mentioned, which is also uncertain and lame excuse in nature, hence the instant present appeal.

4. Learned counsel for the appellant argued that impugned seniority list and promotion of the private respondents as Senior

Clerks was illegal, against the law and void ab-initio as it was not done according to the notification of absorption of the appellant wherein it was clearly laid down that appellant was absorbed with effect from the date of actual report to duty. He further argued that appellant assumed duties earlier in the day on 12.06.2009 and further contended that he was older in age to respondent No.7 and on this count also he deserved to be placed ahead of respondent No.7 who was at S.No.257 in the final seniority list dated 21.12.2011. He further argued that appellant was senior than respondent No.7 to 19 therefore both the seniority list showing him behind the respondents and impugned notification dated 22.07.2013 of promotion of respondents was also unlawful, unreasonable, discriminatory and in conflict of the service rules and law applicable to the case therefore was liable to be struck down.

5. In the instant case the respondents failed to submit written reply inspite of repeated directions by the Tribunal and arguments were heard ex-parte. The learned Sr. GP however argued on the basis of available record who contended that private respondents were appointed as Junior Clerks whereas the appellant amongst other was absorbed as Junior Clerk from the post of Constable though on the same date. He contended that plea of the appellant for treating him senior than the private respondents on the basis of submission of arrival report or on the basis of the date of birth being older in age from private respondent No.7 did not carry any substance. Moreover, he argued that the appellant did not file departmental appeal within the prescribed time against the impugned seniority list dated 31.12.2011 but it was made on 11.07.2012. He contended that since departmental appeal of the appellant was time barred hence the present service

appeal in the Tribunal was incompetent and not maintainable under the law. He prayed that the appeal being barred by time and being devoid of merits may be dismissed.


6. We have heard arguments of the learned counsel for the parties and also perused the record.

7. From perusal of the record, it transpired that the appellant amongst others was elevated from the post of Constable/Naib Qasid and absorbed as Junior Clerk in the Police Department with the clear condition that they will not be confirmed as Junior Clerk nor will be considered for further promotion till they passed type test/departmental training etc during the period of their service as Junior clerk failing which their services were to be dispensed with. The appellant agitated the fixing of seniority as Junior Clerk behind those who were inducted on the basis of initial recruitment on the plea of having submitted arrival report for duty earlier than the private respondent and being older in age than directly recruited Junior Clerks. He however failed to convince the departmental authority for want of support from the relevant rules and also failed to pursue the case further at the relevant forum in the stipulated period of time. It reveals from the record that the appellant could not produce any credible evidence of law/rules in support of his plea for better seniority viz-a-viz the private respondents as there is no law/rules which allows for absorption in a cadre or post what to speak of seniority of such absorbees against those appointed otherwise. Moreover, under the policy of government officials absorbed/merged from other cadres or service groups are placed at the bottom of the seniority list under the policy of the Government. We therefore see very little force in the arguments of the counsel for the appellant for

preference in seniority against the junior clerks appointed through initial recruitment mere on the strength of arrival report or on the basis of old age. It is also not disputed that the appellant failed to agitate the issue of his seniority before the departmental authority within the stipulated period and also failed to agitate their case before the competent forum. The Tribunal is therefore of the considered view that the appeal besides being barred by time is also devoid of any merits. The same is therefore dismissed accordingly. Parties are left to bear their own costs. File be consigned to the record.

Appellant with counsel present and heard. The learned counsel for the appellant, inter-alia, contended that having been appointed as Junior Clerk (BPS-7) from the rank of Constable/ Naib Qasid vide notification dated 12.6.2009, the appellant was placed junior in the seniority list as it stood on 31.12.2011 vide endorsement dated 28.6.2012, as against Junior Clerks, 57 in number, appointed vide Notification of the even date i.e. 12.6.2009; where against the appellant preferred representation to the Provincial Police Officer (PPO), KPK and the representation was still in process, as the appellant was required to submit his arrival report, when all of a sudden a notification thereby promoting the directly recruited Junior Clerks as officiating Senior Clerks (BPS-9) was issued on 22.7.2013. According to the learned counsel, the appellant again preferred representation against the said notification on 6.8.2013, and the reply he received from the appellate authority vide memo dated 10.10.2013 was to the effect that name of the appellant be included in the next DPC. The appellant has also placed on file another memo dated 19.12.2013 whereby the appellate authority further informed the appellant through the Regional Police Officer, Malakand Region, Swat that name of the appellant was at S.No.236 while DPC considered candidates from S.No.1 to 222. It is against this latest communication that the appellant lodged this appeal. The learned counsel for the appellant further contended that the promotions were made against the actual seniority position and without preparation and circulation of final seniority list after objections were raised by the appellant to the seniority circulated vide endorsement dated 28.6.2013. The points raised at the Bar need consideration. Admit, subject to all legal objections, including limitation. Process fee & security be deposited within 10 days. Thereafter, notices be issued to the respondents for written reply/comments at camp court Swat on 5.5.2014.





*Prayer:*

*On acceptance of this appeal, the impugned Seniority list Endst: No. 23054-89/E-III dated 28/06/2013 and promotion order Notification No.17477/E-III dated 22/07/2013, may kindly be declared illegal, unlawful, null and void, by setting aside the same, and the appellant may be promoted as Senior Clerk with all back benefits. Any other remedy, which is just, appropriate and efficacious may also be granted in favour of appellant, though not specifically prayed for.*

*Respectfully Sheweth:*

*The appellant submits as under:*

1. *That the appellant was initially appointed as constable in Police Department vide order No. 65 dated 14/05/2001, thereafter the appellant was absorbed along with 25 others as junior clerks in the same department vide notification No. 14697/E-III dated 12/06/2009, after observing legal and codal formalities. (Copy of appointment as constable is attached annexure A, while copy of absorption as junior clerk is annexure B).*

2. That on the same day of absorption / posting of the appellant, another notification No. 14667/E-III dated 12/06/2009 was also issued by respondent No. 1, whereby 57 fresh candidates were also appointed as junior clerks. (Copy of appointment of 57 candidates is annexure C).
3. That the respondent No. 1 issued the impugned seniority list, whereby the appellant along with 25 others absorbed junior clerks were placed after 57 freshly appointed junior clerks in the impugned seniority list, which is against the law, rules and regulation. The appellant was mistakenly placed at serial No. 382 instead of 257 in the impugned seniority list. The respondent No. 1 should have placed the appellant at serial No. 257 in the impugned seniority list as per rules and regulations and notifications issued by the respondents, but not doing so, committed irregularities, violation of rules and regulations, therefore, is ineffective on the rights of the appellant. (Copy of impugned seniority list is attached as annexure D).
4. That feeling aggrieved from the impugned order of seniority list, the appellant filed departmental appeal before respondent No. 1 for considering the appellant for promotion and seniority. The respondent No. 1 directed to respondent No. 5 to provide attested copies of the "approval report" of the appellant and duly submitted vide office letter No. 5984-E dated 06/09/2012.

(Copy of departmental appeal is annexure E, while copy of office letter is annexure F).

5. That the respondent No. 1 issued an impugned promotion order dated 22/07/2013 on the basis of impugned seniority list by ignoring the grievances of the appellant, which is against the law, rules, regulations, therefore, is ineffective on the rights of the appellant and is liable to be set aside. (Copy of impugned promotion order dated 22/07/2013 is attached as annexure G).
6. That the appellant feeling aggrieved from the unjust, unlawful, unfair decision / impugned order, filed another departmental appeal before the respondent No. 1, to which the reply was received vide letter No. 25437 dated 10/10/2013, whereby the appellant name will be included in the next DPC, however the time and date has not been mentioned, which is also uncertain and lame excuse in nature. (Copy of appeal / representation is annexure H, while reply to letter is annexure I).
7. That being aggrieved from the order made on application for personal appearance to Respondent No. 1 for explaining the appellant case regarding seniority and promotion but this time the appellant has not been given opportunity to explain his matter before Respondent No. 1. (Order is attached as annexure J)
8. That feeling aggrieved from the decision of respondent No. 1 and impugned seniority list and promotion order, the appellant filed the instant appeal on the following amongst other grounds inter alia.

GROUNDS:-

- a. That the impugned promotion order and seniority list is illegal, against the law and void ab-inito. As the impugned seniority list should have been made by notification dated 19/06/2009, in which it is clearly mentioned that "Absorbed as junior clerk in BPS-07 (3530-190-8850) in NWFP Police with effect from the date of they actually reports for duty to the place of posting, but not doing so, the impugned promotion order and seniority list illegal, against the law, as the appellant is senior on the basis of, assuming early his duty on 13/12/2009, date of birth 16/09/1982 and on the basis of notification dated 19/06/2009.
- b. That the name of the appellant should have been required to be placed at serial No. 257 before the name of the respondent No. 7, as the appellant is senior on the basis of assuming as early on duty, date of birth and by notification dated 19/06/2009, but the respondent placed the appellant on serial No. 322 after the respondent No. 8, which is illegal, against the law, rules and regulations, favourable to some junior clerks and is based on political influence and discrimination.

- c. That the appellant was also due for promotion as Offg: senior clerk before the respondent No. 7 at serial No. 56, but the respondents No. 1 to 4 unlawfully, illegally, without any jurisdiction promoted respondent No. 7 to senior clerks through the impugned notification No. 17477/E-III dated 22/07/2013.
- d. That as per merit, the respondents No. 7 to 19 were absolutely not entitled to be placed senior than the appellant in the impugned seniority list, therefore, not sustainable and liable to be revised accordingly. (Arrival report of appellant is annexure K, while arrival report of respondent No. 12 is annexure L).
- e. That the appellant is senior than the respondents No. 7 to 19 and is entitled to be placed before them in the impugned seniority list and is liable to be promoted as senior clerk. Similarly the appellant is also entitled to be promoted as Offg: senior clerk.
- f. That ends of justice negates the action of the respondents No. 1 to 6.

- g. *That the impugned promotion order and seniority list has not been made according to law, policy or rules, but is tainted with malafide against the promotion, posting and transfer policy.*
- h. *That both the notifications herein are unreasonable, discriminatory and conflict of the service rules and law applicable to the case, therefore, is liable to be struck down.*
- i. *That the impugned policy is illogical, the junior clerks have been edge over the appellant, which is against the principles of natural justice and law.*
- j. *That the impugned notifications are also inconsistent with fundamental rights granted under the Constitution of Pakistan 1973.*
- k. *That the appellant has legitimate right of promotion as "senior clerk" but he has been deprived of his legitimate right by respondent No. 1 to 6.*

- l. That some grounds may be argued at the time of hearing with the prior permission of this Hon'ble Court.

It is, therefore, humbly prayed that on acceptance of this appeal, the impugned Seniority list Endst: No. 23054-89/E-III dated 28/06/2013 and promotion order Notification No.17477/E-III dated 22/07/2013, may kindly be declared illegal, unlawful, null and void, by setting aside the same, and the appellant may be promoted as Senior Clerk with all back benefits. Any other remedy, which is just, appropriate and efficacious may also be granted in favour of appellant, though not specifically prayed for.
