JUDGMENT:

SALAH-UD-DIN, MEMBER:- Briefly stated the facts as alleged by the appellant in his appeal are that he was appointed as Mali against a regular post, vide order dated 31.12.1983 and was promoted as Ward Orderly (BPS-02) vide Notification dated 26.12.1984. The department, however kept paying monthly salary to the appellant for the post of Mali instead of Ward Orderly. On agitating the matter before the competent Authority, arrears bill for an amount of Rs. 7385/- was prepared and sent to the District Accounts Office, however the same was returned with the remarks that proper reasons for late submission of arrears bill may please be quoted and as the claim is more than 10 years



old, therefore, sanction for investigation may please be got from the competent Authority and the bill may be then resubmitted. Vide letter dated 30.11.1996, the service book of the appellant alongwith arrears bill was returned to the Medical Superintendent DHQ Hospital Lakki Marwat with the observations that proper replies in columns, especially columns No. 4, 5, 6, 7 & 8 of proforma for investigation of arrears, were not recorded and the nonpayment certificate was also left blank. Similarly, Director General Health Services also wrote letter dated 08.12.1996 to the Secretary Health Department Peshawar for grant of sanction for the investigation of arrears claim of the appellant but the matter was thereafter kept on the back burner without any fruitful result. The appellant filed departmental representation to the DHO Lakki Marwat but the same was not responded, hence the instant service appeal.



2. Notices were issued to the respondents, who submitted their comments, wherein they refuted the assertions made by the appellant in his appeal.

3. Learned counsel for the appellant has contended that the appellant was though promoted to the post of Ward Orderly vide order dated 26.12.1984 and an entry in this respect was also duly recorded in his service book but he is still being paid salary of the post of Mali. He next contended that the department itself realized its mistake, therefore, an arrears bill amounting to Rs. 7385/- was prepared and sent to the District Accounts Office on 01.09.1996, however the same was returned to the department with certain observations,

which were not complied by the department and the bill was not resubmitted for its payment. He next contended that the respondents did not fulfill their legal responsibility and their non serious attitude has kept the appellant deprived from receiving his due monthly salary.

4. On the other hand, learned Assistant Advocate General for the respondents has contended that the promotion order of the appellant is bogus and the entry of his promotion in service book is also fake. He next contended that the matter pertains to the year 1984, while the appellant filed departmental appeal in the year 2013, which is badly time barred. He also contended that the appellant is still being shown as Mali as per relevant column of his service book, which also indicates that he was not at all promoted to the post of Ward Orderly.



5. Arguments heard and record perused.

6. A perusal of the record would show that the appellant is claiming that he was appointed as Mali and was promoted to the post of Ward Orderly vide order dated 26.12.1984 but he is still being paid the salary of Mali. The respondents in their comments have alleged that the very order of promotion of the appellant to the post of Ward Orderly is fake and the entry recorded regarding promotion of the appellant in his service book is also bogus. While going through the record, it has been observed that the submission of arrears bill of Rs. 7385/- to the District Account Office has not been specifically denied by the respondents in their comments. Similarly, in respect of


the matter in issue, the then D.G Health Services wrote letter dated 30.11.1996 to the then Medical Superintendent DHQ Hospital Lakki Marwat, while another letter dated 08.12.1996 was written to the then Secretary to Government of NWFP (now Khyber Pakhtunkhwa) Health Department Peshawar. Respondents were required to have resolved the issue, however it appears that the matter was then kept on back burner, without any logical conclusion of the same.

7. In view of the above discussion, the matter in issue is remitted back to the competent Authority with the directions to resolve the same in accordance with law/rules within a period of one month of receipt of copy of this judgment, failing which it shall be considered that the appellant was duly promoted to the post of Ward Orderly and is entitled to all financial as well as other benefits pertaining to the said post. The appeal in hand is disposed of accordingly. Parties are left to be their own costs. File be consigned to the record room.

Respectfully Sheweth:

1. That appellant was appointed as Mali against the regular post vide order dated 31.12.1983 and was promoted to the post of Ward Orderly BPS-02 vide order dated 26.12.1984. (Copies as annex "A")
2. That after promotion to the post of Ward Orderly BPS-02, the monthly salaries was enhanced but the department was paying monthly salaries of BPS-01 of Mali and since 1984 till 1996 appellant was made entitled for payment of the arrears of BPS-02 as Rs. 7385/-. (Copy as annex "B")
3. That appellant agitated the matter regarding the payment of arrears and thereafter arrear bill was finalized for Rs 7385/- but the District Account Office returned the same to

the department with the remarks that proper reason for late submission may please be quoted. The claim is more than ten years old, therefore, sanction of investigation may please be got from the competent authority and resubmitted of this please. (Copy as annex "C")

4. That on 30.11.1996, R. No. 2 wrote letter to Medical Superintendent, Lakki Marwat that proper replies to the column in proforma for investigation of arrear claim have not been recorded to ask the authority as to why it had not been taken up in time. (Copy as annex "D")
5. That on 08.12.1996, R. No. 2 wrote letter to R. No. 3 to give necessary sanction to investigation of arrears in favour of appellant. Thereafter the matter was threw in a waste box. (Copy as annex "E")
6. That every year annual increment was granted to appellant beside enhancement of monthly salary from time to time recorded in the service book but no fruit full action was then taken. (Copy as annex "F")
7. That on 20.11.2013, appellant submitted representation before R. No. 1 to make payment of the arrears mentioned above but the same met dead response till date. (Copy as annex "G")


Hence this appeal, inter alia, on the following grounds:-

GRUNDS:

- a. That since 1984 till date, the claim of the appellant was admitted correct by the respondents but the same was not acted upon.
- b. That payment of the arrears is not bounty but is a vested right of appellant to receive the same from the department.

- c. That the matter was delayed by the respondents for no legal reason but due to malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, respondents be directed to pay forthwith Rs. 7385/- and Rs. 50,000/- total Rs. 57,385/-, or as the case may be, to appellant hence forthwith, with such other relief as may be deemed proper and just in circumstances of the case.

JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS 1-3

ON FACTS


1. Incorrect. The promotion order Dated: 26-12-1984 submitted by appellant (Annex-A) is also bogus due to the following reasons.
 - a. Office of the District Health Officer Lakki Marwat was not functioning in 1984. As a result of bifurcation from DHO Office Bannu. It started functioning in 1993. Respondent No.1 requested DHO Bannu to verify the said promotion order (Annex-B), who (DHO Bannu) could not verify it and replied that it was not available on record (Annex-C)
 - b. Signature of District Health Officer and Initial of clerk under signature of District Health Officer are bogus and do not coincide with their other signatures, in the same service book of the official. Original service book of appellant will be produced at the time of arguments.
 - c. Dispatch No. 6446 is wrong. It should be 6446-48 as copies are forwarded to 03 people.
 - d. E-1 file shown in order is again wrong. E-1 is of gazetted / officers file name and not of Class-IV. For Class-IV E-9 file is maintained.
 - e. In the said promotion order Mr. Ayub Khan Official at serial No. 2 has been shown promoted to Behishti but it is not promotion order but only transfer to vacant post of official at serial No. 1. It also reflects that the said order was bogus.


- f) The entry at page 11 of memo of appeal copy and at page 03 of original service book of the appellant as "Promoted as W/O in BPS-02 vide: DHO Bannu No. 6446/E-9 Dated: 26-12-1984" is "BOGUS" and made by appellant himself through unfair means afterwards.
- g) Moreover there is technical flaw in calculation. If this shown promotion entry was correct, then appellant would have been allowed and given "Annual Increment" w.e.f. 01-12-1984 as he claims his 1st appointment on 31-12-1983. So annual increment was due on 01-12-1984 but that was not entered in service book / Page 10 of the memo of appeal copy. As promotion entry was bogus, therefore appellant was not awarded annual increment, which was due on 01-12-1984.
- h) If promotion entry was correct, then the pay fixation party would have awarded BPS-02 but not. Refer to pay fixation party report on 01-06-1987, 01-06-1991 (Page 04 at original service book) (Annex-D). When BPS-02 was not awarded and BPS-01 continued, why appellant did not claim arrear bill at that time? Again as per pay fixation report on 01-06-1994 and on 01-12-2001 (Both on Page 14 of service book) (Annex-E). Again BPS-01 continued and BPS-02 not awarded. Again appellant didn't claim arrear bill. All this reflects that the alleged promotion order was fake and bogus.
- 2) As replied in above para.
- 3) Partially correct to the extent that District Accounts Officer asked for "Sanction of investigation" from the department while remaining para pertains to record.
- 4) As replied in para 1.
- 5) Incorrect. The letter referred by appellant is neither annexed by the appellant with the memo of appeal, nor the same is available on our office record. Hence subject to proof.
- 6) Incorrect. Annual increment of BPS-01 already drawn. As appellant did not deserve BPS-02, so was not given that much arrears.
- 7) Incorrect. Representation is not present on our record. Appellant says he was appointed on 31-12-1984 and at the same time says he was promoted as ward orderly on 26-12-1984. It means his promotion was done before his initial appointment which is impossible.


GROUND:

- a. Incorrect, as explained in para No. 1 above.
- b. Incorrect. The appellant promotion order is fake and made by him through unfair means which creates no right in his favor.
- c. Incorrect. It is false allegation by the appellant. Respondents had no malafide intention but legal constraints didn't allow them for undue payment.

In light of the above and other facts & grounds, it is most humbly solicited that the appeal in hand may very graciously be dismissed.
