Mr. Arif Jan, Advocate for the appellant present. preliminary arguments heard.

Learned counsel for the appellant at the outset of his arguments contended that the appellant is basically aggrieved of the impugned revised final seniority list of Forest Guard (BS-08) dated 31.12.2019 issued on 24.08.2020. The appellant preferred departmental appeal against the impugned seniority list on 28.10.2021 which was not decided within the stipulated statutory period whereafter, the instant service appeal was instituted in the Service Tribunal on 22.02.2022. It was further argued that the appellant has been discriminated and the impugned seniority list is based on malafide intention. The Service Tribunal has already admitted a similar nature case of Tahir Ayub, Forest Guard against the same seniority list on 15.10.2021 and the respondents have been restrained from finalization of the promotion cases from Forester to Deputy Ranger. He therefore, requested that the instant service appeal may also be admitted with the same treatment by issuing an order for restraining the respondents from considering the case of promotion in the becoming DPC on the basis of impugned revised final seniority list.

Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to the respondents for submission of written reply/comments on 09.08.2022 before S.B. Alongwith the service appeal, there is an application for restraining the respondents from considering the case of promotion in the upcoming DPC to the next higher post/grade of respondents No. 5 to 11 on the basis of impugned revised seniority list. In the meanwhile, the respondents shall not finalize the promotion to the post in subjudice before the Tribunal.







**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA  
SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNE  
REVISED FINAL SENIORITY LIST DATED 31-12-2019 OF FOREST  
GUARDS BPS-08 IN SIRAN FOREST DIVISION MANSEHRA  
ISSUED VIDE LETTER/ORDER DATED 24-08-2020 AGAINST  
WHICH DEPARTMENTAL APPEAL HAS BEEN FILED, BUT THE  
SAME HAS NOT BEEN DECIDED WITHIN THE PRESCRIBED  
STATUTORY PERIOD.**

**Respectfully Sheweth:**

1. That the Appellant was initially appointed as Forest Guard on  
9-5-1987 and was adjusted in a project where after the  
appellant was regularly posted in the year, 2000 in Siran  
Forest Div where as the appellant performing his duties  
honestly and up to the entire satisfaction of his superiors.

2. That Respondent No-4 maintained the final seniority list of Forest Guards BPS-08 in Siran Forest Division Mansehra as it stood on 31-12-2019 vide letter dated 24-08-2020 illegally and falsely where in the appellant was shown at S.No-8 but here it is worth mentioned that prior to the above, the appellant was once shown at S. No-2, 3 and 7 which is absolutely illegal and unlawful against which the appellant filed departmental appeal which has not yet been decided within the prescribed period. (Copies of Final Seniority list/revised seniority list along with departmental appeal are attached as ANNEX-A, B, C and D respectively).
  
3. That the action and inaction of Respondents by way of depriving/ignoring the appellant from his lawful right of seniority being senior most in the seniority list is against the Law, facts and principles of justice on grounds inter alia as follows:

**GROUND:**

- A. Because the actions and inactions of the Respondents by way of maintaining the final seniority list of Forest Guards BPS-08 vide letter dated 24-08-2020 effecting from 31-12-2019 (Herein after impugned up to the extent of appellant grievances) is patently illegal, unlawful, without lawful authority, of no legal effect and ineffective upon the rights of appellant being false and maintained wrongly, hence the respondents be directed to act in accordance with Law and to revise and finalize the correct and proper seniority list securing the lawful rights of the appellant being the senior most in the seniority list of Forest Guards.
  
- B. Because the appellant have been transferred to siran Division in the year, 2000 but the respondent No-4 intentionally placed respondent No-5 to 11 senior then the appellant which is wrong and needs correction moreover this unlawful act of the respondents also invites the consideration of this Hon'ble Tribunal.
  
- C. Because the respondents themselves violated their own guidelines and directive of high ups on the subject matter, hence intentionally adopted the policy of "pick and

**choose**" thus this act of the respondents is against the existing laws and policies.

- D. Because the date of appointment/adjustment have been shown in the impugned seniority as 9-5-1987 but even then falsely been mentioned at S.No-8 without any reason and justification thus needs correction with the direction to the respondents to abide by Law and rules and regulation governing the subject matter.
- E. Because the respondents 5 to 11 are junior most then the appellant but have been placed senior in the impugned seniority list just to deprive the appellant from his vested right of promotion along with other service benefits, hence this act of the respondents is amounts to abuse of powers/authority which is against the norms of justice.
- F. Because the respondent No-4 maintained the impugned list in hasty manner, without perusal of relevant record just to show performance to the high ups but in fact, the appellant suffered with irreparable losses which will not be count in shape of coins.
- G. Because the continuity of seniority position of the appellant in all the previous seniority list created vested right in his favor which could not taken away under the principle of locus ponitentiae.
- H. Because any other ground which has not been mentioned may also be permitted to rise at the time of hearing.

**It is therefore respectfully submitted that on acceptance of the instant Appeal,**

- 1. This Hon'ble Tribunal may graciously be please to declare the impugned seniority list illegal, unlawful and to be set aside.**
- 2. Direct the respondents to prepare the correct revised final seniority list placing therein the appellant being senior most against his respective position.**


