

2. On the last date, direction was issued to the respondent department for production of the record including charge report, LPC and attendance register regarding Appellant's availing of the promotion at GPS Wajhun District D.I.Khan. It is significant to point out for future convenience that why the need for production of said record has arisen. During previous hearing, the parties were found extremely irreconcilable as to the timeline of Appellant's promotion to the post of SPST BPS-14. However, both the parties are short of tangible proof to make the settlement possible by exclusion of stance of one of them. The clue of said record was taken from the enquiry report relied upon by the respondents. Therefore, they were directed to produce said record to rebut the claim of appellant, which they have not produced as directed.

3. Today, during the proceedings, Service Book of the appellant has been produced before us. Four entries in the service book are worth reference. The first in four is meant to give effect to promotion of the appellant as SPST BPS-14 w.e.f. 15.02.2013 made vide DEO (M) D.I.Khan endorsement No. 1652-59 dated 04.03.2013 and bears the signature and stamp of SDEO (M) Kulachi. The second one describes promotion/transfer of Appellant to the post of SPST BPS-14 but with two dates one as 04.03.2013 with overwriting and encircled while the other date is 26.08.2013 and this entry bears similar signature and stamp as mentioned before. The third entry is under signature and stamp of the District Accounts Officer, D.I.Khan regarding fixation of the pay w.e.f. 15.02.2013 to 31.10.2013 due to promotion to BPS-14. The fourth entry relates to award of promotion to the appellant in BPS-14 vide DEO (M) D.I.Khan endorsement No. 7006-10 dated 26.08.2013 under same signature and stamp of SDEO (Male) Kulachi. There is another entry besides the afore-named four entries in the Service Book which relates to passing of B.Ed examination by the appellant from Sarhad University of Science and Information Technology Peshawar on 05.03.2018. We have also noted from the annexures on record that the appellant has annexed only one computerized salary slip pertaining to November, 2013 with his

memorandum of appeal. And why not others, is best known to him. Noticeably, the appellant arose to claim promotion from 15.03.2013 after acquiring B.Ed qualification entitling him for promotion to SST post.


4. Dispute before us is that the appellant claims his promotion from the first entry in his service book as described above and accordingly he was given promotion by order dated 04.03.2013 retrospectively w.e.f 15.02.2013 but second entry is ambiguous because of two dates of the promotion one with overwriting as 04.03.2013 and the other as 26.08.2013. Third entry relates to the pay fixation in next higher scale from 15.02.2013 in compatibility with the first entry. Surprisingly, according to the fourth entry in service book, the appellant was again promoted in the same scale vide a subsequent order dated 26.08.2013. As against claim of the appellant, the respondent department claims that the appellant did not avail the first promotion made vide order dated 04.03.2013 but despite opportunity given the department has not been able to produce any tangible document showing refusal of the appellant on record about availing the first promotion. It is a matter of law that if a government servant forgoes promotion, he cannot be promoted subsequently for four years. If according to the claim of the respondent department, the appellant had refused to avail promotion, then how it became possible for the department to grant him promotion again after few months of refusal of the appellant. The department also got conducted an enquiry as to conflict of the said two promotion orders and according to the copy of the enquiry report available on file, the subsequent promotion of the appellant was found duly availed. However, the appellant claims that he availed the first promotion and he came into knowledge of second promotion in the year 2018 where-against he filed departmental appeal and then came to this Tribunal with this service appeal. In view of discussion herein before, there is a lot about administrative and financial mismanagement to be dug out through a proper probe by some higher authorities. Responsibility is to be fixed by the higher competent authorities as to mismanagement and misadministration in the case of promotion of the appellant after inquiry. We are not able to decide the present appeal conclusively unless the factual controversy about promotion order in conflict is settled by a fact finding inquiry at departmental level. Therefore, in order to meet the needs of justice and to prevent the process of the abuse of Tribunal, we

The said record is shown to have been annexed with the inquiry report as annexure-III but was not annexed with the comments of respondents in addition to the copy of inquiry report. The representative in attendance today has stated at the bar that the record shown as annexure-III in para-D of the inquiry report is not available in the office but at the same time he stated that it may be available in the sub-office in Kulachi. It would be in the interest of justice to give another chance to the department for production of said record. Case to come up on 26.11.2021 before the D.B at Camp Court D.I.Khan.

It was contended by the learned counsel for the appellant that the appellant was serving in Education Department as Primary School Teacher. It was further contended that the appellant was promoted from the post of Primary School Teacher (BPS-12) to the post of Senior Primary School Teacher (BPS-14) by the competent authority on the recommendation of Departmental Promotion Committee vide order dated 04.03.2013. It was further contended that again Departmental Promotion Committee was constituted and the appellant was again shown promoted from the post of Primary School Teacher (BPS-12) to the post of Senior Primary School Teacher (BPS-14) vide order dated 26.08.2013. It was further contended that when the appellant applied for promotion from the post of Senior Primary School Teacher (PS-14) to the post of Primary School Head Teacher (BPS-15) than the appellant was told that he has been promoted in the August 2013 therefore, his length of service is not completed. It was further contended that the appellant was promoted to the post of Senior Primary School Teacher (BPS-14) on 04.03.2013 but the respondent-department has wrongly shown his promotion from the post of Primary School Teacher (BPS-12) to the post of Senior Primary School Teacher (BPS-14) on second time vide order dated 26.08.2013. It was further contended that the appellant filed departmental appeal but the same was rejected vide order dated 08.08.2014 hence, the present service appeal. It was further contended that since the appellant was already promoted to the post of Senior Primary School Teacher (BPS-14) therefore, the promotion order of the appellant on 26.08.2013 was not proper and the respondent-department is bound to consider his promotion from the date of first promotion i.e 04.03.2013.

Brief facts giving rise to instant appeal are as under:-

- 1- That the appellant is law abiding citizen of Pakistan a resident of Mohallah Ibrahimzai Kulachi, Tehsil Kulachi District Dera Ismail Khan. Copy of computerized National I.D card is enclosed as **Annexure "A"**.
- 2- That the qualification of the appellant is as under:
 - i. SSC from BISE Peshawar in the year 1986 Annual.
 - ii. Intermediate from BISE Peshawar in the year 1989 Annual.
 - iii. B.A from Gomal University D.I.Khan in the year 1992.
 - iv. P.T.C from R.D.E Peshawar in Session 1993-94.
 - v. Diploma in Associate Engineering Mechanical Technology.
 - vi. Senior Diploma in Physical Education.
 - vii. M.Sc Health & Physical education.


Copy of service book is enclosed as **Annexure "B"**.
- 3- That the appellant was appointed as P.T.C Teacher in BPS-07 vide order No. 1586-1604 dated 30/06/1996 and posted at Government Primary School Haroon Abad, Kulachi, Tehsil Kulachi District Dera Ismail Khan. Copy of appointment order is enclosed as **Annexure "C"**.
- 4- That in compliance with appointment order the appellant joined the service and performing his duties regularly without any complaint, during service the appellant promoted in BPS-12 and then according to the order of respondent No. 3 bearing order No. 1660-65 dated 04/03/2013 the appellant was promoted in BPS-14. Copy of order is enclosed as **Annexure "D"**.
- 5- That the appellant fulfilled all requirements of promotion in BPS-14 since promoted dated 04/03/2013 and the appellant collect the salary of

BPS-15 as Senior Primary School Teacher. Copy of statement of salary is enclosed as Annexure "E".

6- That the respondents / education Department inadvertently listed name of the appellant in an other departmental promotion committee (DPC) through order No. 7006-10 dated 26/08/2013 at serial No. 5 in BPS-14, but actually the appellant was already promoted in BPS-14 since 04/03/2013 and enlist the name o appellant in subsequent promotion committee in August 26/08/2013 inadvertently. Copy of order dated 26/08/2013 is enclosed as Annexure "F".

7- That further promotion of the appellant is due from January 2018 and the posts of BPS Grade-15 are vacant in office of Education DIKhan and in this respect the appellant submitted relevant document for due promotion according to seniority since 04/03/2013 but the respondent / education Department refused to promote the appellant with the verbal direction that the appellant is not entitle for promotion on the basis of letter No. 1660-65 dated 04/03/2013 but they stated that the appellant is entitled to promotion on the basis of letter No. 7006-10 dated 26/08/2013.

 8- That aggrieved with the verbal refusal of promotion to BPS-15 the appellant filed departmental appeal to the D.E.O DIKhan through proper channel and on the appeal of the appellant the respondent appointed inquiry committee comprising by the principal namely Muhammad Nadeem Principal Government Higher Secondary School No. 3, DIKhan as a Chairman where one Muhammad Iqbal Principal Government High School Umer Khel, DIKHan as a member to conduct the inquiry and submit the report of conclusion to the D.E.O (Male), DIKhan, and on the basis of inquiry report / conclusion the D.E.O (Male), DIKhan through letter No. 24350 dated 08/08/2018 rejected the appeal of the appellant. Copy of appeal, inquiry report, and order are enclosed as Annexure "G, H & I" respectively.

9- That the letter No. 2430 dated 08/08/2018 issued by the D.E.O, Dikhan was received to the appellant on 16/08/2018, hence the appeal is within time.

10- That the appellant feeling aggrieved from the impugned orders of the respondents authority, hence the instant service appeal on the following grounds:-

GROUND:-

a) That act of the respondents and refusal of promotion of appellant from BPS-14 to BPS-15 on the basis of seniority 04/03/2013 is against the law, facts, record and against the norms of justice.

b) That the act of refusal of promotion of the respondents particularly respondent No. 3 is illegal and with material irregularity.

c) That the act of refusal of promotion of appellant is result of misreading and nonreading of the record.

d) That it is crystal clear from the record that the appellant was promoted BPS-12 to BPS-14 through letter No. 1660-65 dated 04/03/2013 at serial No. 268 and the appellant is entitle for further promotion according to the said letter.

e) That the respondents not took into consideration that the insertion or enlisted the name of appellant in subsequent Departmental Promotion Committee is inadvertently and not binding effect on the rights of the appellant, hence the appellant was already promoted to BPS-14 through letter No. 1660-65 dated 04/03/2013 and said letter in fact in Departmental record and the name of other employees from serial No. 269 to 604 in letter dated 04/03/2013 were junior than appellant and it is further respectfully submitted that employees mentioned at serial No. 1 to 4 in promotion letter dated 2608/2018 are also junior than appellant, so the refusal of promotion of the appellant not sustainable in the eyes of law.


- l) That whole the inquiry proceeding conducted by inquiry committee is also against law and justice and the report of the inquiry committee is also against law and fact, against the record and without lawful authority.
- g) That conclusion para of inquiry committee accede their jurisdiction.
- h) That the whole procedure adopted by respondents on departmental appeal of the appellant is also against law and fact because the D.E.O never issue show cause notice to appellant nor given an opportunity of personal hearing to appellant and the appellant was condemn unheard which is against the Islamic jurisprudence as well as Constitutional of Islamic Republic of Pakistan.
- i) That the Counsel of the Appellant may very graciously be allowed to add further grounds during the course of arguments.

It is therefore, humbly prayed that by the acceptance of the appeal, the respondents be directed that the appellant is entitle for further promotion to BPS (Grade)-15 on the basis of letter No. 1660-65 dated 04/03/2013 with all back benefits.

COMMENTS ON BEHALF OF RESPONDENTS

Preliminary Objections

- 1) That the appellant has got no cause of action / locus standi.
- 2) That the appellant has not come to Honourable Tribunal with clean hands.
- 3) That the appellant has filed the service appeal on malafide objectives.
- 4) That the instant appeal is against the prevailing laws and rules.
- 5) That the appeal is barred by doctrine of leeches.
- 6) That the instant appeal is illegal and against the facts and on grounds circumstances.
- 7) That the service appeal is not maintainable in its present form.
- 8) That the appellant has concealed material facts from Honourable Tribunal.
- 9) That the service appeal is not maintainable in its present form.

Objections on facts

- 1) No comments.
- 2) Para pertains to the academic and professional qualification of the appellant hence no comments.
- 3) Para pertains to the first appointment of the appellant hence no comments.
- 4) Para is correct to the extent that appellant has got up-gradation from BPS-07 to BPS-12 and then the appellant was promoted in BPS-14 vide order dated 04.03.2013. The appellant did not assume the charge of the post of SPST (BPS-14) hence appellant has got no cause of action.
- 5) Incorrect and not admitted. The appellant did not assume the charge of the post of SPST BPS-14, therefore he was not entitled for the financial benefits of the BPS-14, and furthermore the annexure E reflects the salary of the appellant for the month of November 2013 because appellant was promoted to BPS-14 in the month of Aug 2013, The appellant did not assume the charge of the promoted post SPST BPS-14 in the month of March 2013. **(inquiry report is annexed as annexure)**
- 6) Incorrect / not admitted. Strongly denied. The appellant was promoted in BPS-14 dated 04.03.2013 but he did not avail the promotion. In the next **Departmental Promotion Committee** the appellant was promoted in BPS-14 on 16.08.2013, whereas the seniority position of the appellant was changed due to his non-joining of promotion in the month of March 2013. The appellant become junior from those who were promoted in the month of March 2013.
- 7) Incorrect and not admitted. The act of the respondents was according to law, as the appellant did not join his promotion in the month of **March 2013**, therefore he becomes junior to his colleagues, and those who were accepted the promotion in the month of March 2013.
- 8) Incorrect not admitted. The pray of the appellant was totally illegal and liable to be dismiss because he availed his promotion **vide order No. 7006-10 dated 26.08.2013** and also directed to SDEO(M)Kulachi to become vigilant and perform duties properly in the future.
- 9) No comments.

- 10) Due to above mentioned circumstances, the service appeal of appellant may be dismissed with cost because the respondent department has treated the appellant according to law, rule and policies of the government. The appellant was promoted to the post of **SPST BPS-14 dated 2.08.2013** and appellant has accepted the said post. Therefore it is requested to this Honourable Tribunal to dismiss the service appeal of the appellant.

Objections on grounds
