

(Copies Annexure-"E to F").


(VII) That the Appellant seeks leave of Honourable Tribunal to urge further grounds, deemed necessary.





SUBJECT: **DEPARTMENTAL APPEAL THROUGH PROPER CHANNEL AGAINST THE JOINT ORDER PASSED BY YOUR WORTHY OFFICE VIDE NOTIFICATION NO. SO(ADMN) E&T/1-26/2021/4663-25 DATED 01-SEP-2021, IN WHICH, APPELLANT WAS PLACED AT SERIAL NO. 24 AND ORDERED TO TRANSFERRED FROM HIS PRESENTLY RETAINED POST ETO, AT SWABI DISTRICT TO POST AT NORTH WAZIRISTAN.**

Respectfully Sheweth:

1. That no doubt appellant served worthy department of excise and taxation with all most half of his entire life with zeal and zest, and abilities & capabilities of his own, therefore, going to be retired in April 2023.
2. That if the background of the creditability and service of the appellant may look bird eye, the appellant also achieved more than his prescribed target given by the department, he achieved more than 100% target in previous posting, which ultimately revealed that appellant certainly served the department in the for flung backward areas of the country i.e. Chitral, Buner, Malakand etc and never agitated his transfer report or to avail any departmental as well as legal remedy against any

transfer order of his own, therefore it can be safely stated that the appellant did his best effort in favour of his parent department by keeping priority, against any personal as well as private indulgence, so in this respect the parent department of the appellant is also required to act not only in accordance with the law but in favour of the appellant also, while considering unlimited era of his unblemished service.

3. That according to the prescribed usual manner of transfer of any higher cadre officer of the esteemed department of excise and taxation, any officer cannot be transferred to any other destination of duty within the prescribed time of 2 years positively, however it is pertinent to mention here that appellant retained his transferred appearance on 01.11.2019, so on this score, it is settled that the impugned transfer order to the extent of the appellant has not fulfilled the prescribed era, hence it is liable to be recalled.
4. It is required to keep under worth consideration that applicant is exactly by birth as well as by forefather belonging to the specified area of District Mardan, adjacent to the area, wherein presently before the impugned order of transfer, appellant is performing his official obligation at ETO office Swabi by achieving more than his given task by the department he gain 119% target in the office of ETO Swabi, therefore, by invoking your authoritative supervision being head of the department, on 23.07.2021 an application was submitted on the

part of the appellant, for transfer of his own from district swabi to District Mardan, which is still pending under adjudication before your appropriate exclusive authority, but in adverse of the same, the impugned general order of transfer dated 01.09.2021 was arrived.

5. Since it is admitted fact that appellant after fulfillment of almost 34 years of his unlimited, unblemished era of his service, has attained over and above age enough, therefore, surviving with the different chronic disease i.e. diabetes etc, furthermore being the sole guardian of his family it is required to look impugned transfer order, to the extent of the appellant transfer only, that the wife and the son of the appellant is also suffering with the current pandemic chronic COVID-19, therefore none is here to look after her, therefore, the request of the appellant is required to considered even on the humanitarian basis. **(Copy of medical documentation is attached herewith)**

It is, therefore, requested that in the light of above legal as well factual circumstances, the transfer order to the extent of the appellant only may graciously please be recalled.

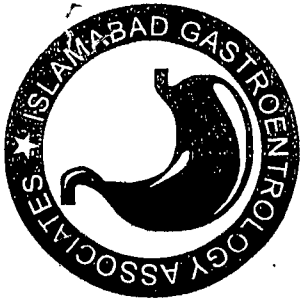

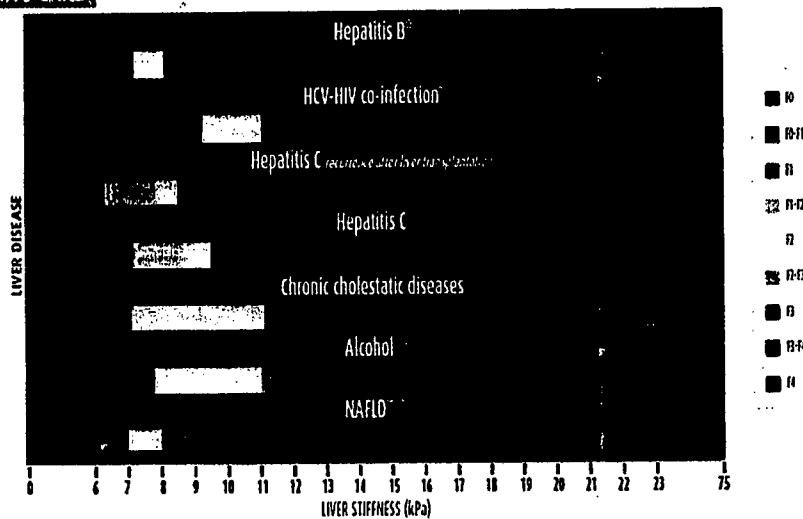


