

Counsel for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant while opining his arguments pointed out that there have been two cadres of Junior Instructors (BS-15) i.e, Diploma holders and Degree holders and their respective seniority list have been issued/circulated separately. The appellant being Degree holder was standing at serial No. 1 of the seniority lists of Degree holders circulated on 31.12.2016, 13.12.2017 and 31.12.2018. However, joint seniority list of the Diploma and Degree holders was issued/circulated for the first time on 18.04.2019 as a result of which the appellant was placed at serial No.41 of the impugned seniority list. He preferred departmental appeal and then service appeal No. 1133/2019 which is pending for adjudication in the Service Tribunal. It is quit astonishing that another joint seniority list (tentative) of Trade Instructors BS-15 (yet another cadre of vocational Education was clubbed) was circulated on 21.02.2020 reflecting the appellant at serial No. 14<sup>which was</sup> objected for correction through a departmental appeal dated 16.07.2020. However, it was not finalized/responded within the statutory period, hence, the instant service appeal in hand submitted on 30.12.2020. Learned counsel for the appellant was confronted with a pertinent question regarding limitation, he argued that the disputed/impugned seniority list has been issued with malafide intension affecting and violating the legal and vested rights of the appellant. It is a recurring cause of action due to which his promotion has been suffered and effected adversely.

Points raised need consideration. The appeal is provisionally admitted to regular hearing, subject to all just and legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time or extension of time is not sought, the office shall submit the file with a report of non-compliance. File to come up for arguments on 25.01.2022 before the D.B.






**APPEAL APPEAL U/S 4 OF THE KPK SERVICE TRIBUNAL ACT 1974 AGAINST THE FINAL SENIORITY OF INSTRUCTORS/TRADE INSTRUCTORS BPS-15 VOCATIONAL CADRE KPK TECHNICAL AND VOCATIONAL TRAINING AUTHORITY ISSUED VIDE LETTER DATED 08-06-2020 AGAINST WHICH DEPARTMENTAL APPEAL OF THE APPELLANT DATED 16-07-2020 HAS NOT BEEN RESPONDED SO FAR DESPITE THE LAPSE OF MORE THAN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:-**

On acceptance of this appeal the impugned Final Seniority List of Instructors/Trade Instructors BPS-15 Vocational Cadre KPK Technical and Vocational Training Authority Issued Vide Letter Dated 08-06-2020 to the extent of the appellant may kindly be set aside and respondents may kindly be directed to issue separate Final Seniority List Of Instructors (Male) Diploma Holders and Degree Holders (BPS-15) (Technical Subjects) and maintain/restore the Seniority of the appellant on Poly Technic Degree holders side with effect from the date his seniority has been disturbed with all back benefits.

**Respectfully Submitted:-**

1. That the appellant is highly qualified, has acquired his B. Tech (Hons) Degree on 12-02-2012 and consequent to Advertisement No 1/2008, was appointed as Trade Instructor (BPS-11) on 10-03-2011 and since then he performed his duties with honesty and full devotion and to the entire satisfaction of his high ups.

2. That the post of Trade Instructor was initially upgraded from 2014 and then from the date of appointment of the appellant and the appellant is presently serving as Junior Instructor (BPS-15) at Govt. College of Technology Tangi District Charsadda.
3. That since long, respondents used to Notify separate Seniority Lists of Junior Instructors holding Diploma and those Junior Instructors holding Degree. **(Copies of separate Seniority Lists of Diploma Holders & that of the Degree Holders are enclosed as Annexure A & B).**
4. That as per duly notified Seniority Lists of the year 2014 to 2018 of the Junior Instructors Degree Holders the appellant stands at the top of the Seniority list, as evident from the same.
5. That Vide Letter dated 23-04-2019 joint Tentative Seniority List of Junior Instructors Degree Holders and Diploma Holders was issued wherein the appellant name was placed at Serial No 41 instead of Serial 1. The appellant filed representation against the said joint Seniority List on 30-04-2019, however vide Notification dated 24-05-2019 respondents notified joint Final Seniority List of Junior Instructors Degree Holders and Diploma Holders wherein the appellant name was placed at Serial No 42 instead of Serial 1. The appellant after exhausting departmental remedy filed Service Appeal No.1133/2019 which is ripe for arguments. **(Copy of Tentative Seniority List & Final seniority List is enclosed as Annexure C & D).**
6. That vide Letter dated 21-02-2020 Tentative Seniority List of Trade Instructors BPS-15 Male in KPK Technical Education and Vocational Training Authority was circulated wherein the appellate was placed at Serial No 14, the appellant objected the same on 14-03-2020, however instead of redressing the grievances of the appellant malafidely Final seniority of List Trade Instructors BPS-15 Male in KPK Technical Education and Vocational Training Authority was circulated vide Letter dated 08-06-2020 against which the appellant was placed at serial No 12. **(Copy of Tentative seniority List, Representation dated 14-03-2020 & Final seniority List is enclosed as Annexure E, F & G):**
7. That the appellant preferred representation on 16-07-2020 which has not been responded so far despite the lapse of more than the



statutory period of ninety days. **(Copy of Representation is enclosed as Annexure H).**

8. That this action of the respondents of including name of the appellant in the Final Seniority List of vocational cadre issued vide Letter dated 08-06-2020 instead of Poly Technic side Degree holders thereby depriving the appellant of his due seniority is against the law, facts and principles of justice on grounds inter-alia as follows:-

**GROUND:-**

- A. That the omissions and commissions of the respondents are illegal and void ab-initio.
- B. That mandatory provisions of law have been violated by the respondents and the appellant is not treated according to law and rules governing the subject.
- C. That the respondents used to issue/notify separate Seniority Lists of Degree Holders and Diploma Holders from the year 2014 to 2018, as evident from the Seniority Lists in which the appellant was placed at the top of the Seniority List and as such was to be promoted in the quota reserved for the Degree Holders.
- D. That the respondents have deprived the appellant of his due seniority firstly by issuing joint Seniority List of the Degree Holders and Diploma Holders and then by placing his name in the Final seniority List of Vocational cadre.
- E. That valuable rights had accrued in favor of the appellant from which he could not be deprived and more particularly at the whims of someone.
- F. That the malafide on part of the respondents is floating on surface of the covering letter dated 08-06-2020 which has been given effect till 16-06-2020 in violation of all norms of justice.
- G. That the appellant has been deprived of his due seniority without any omission and commission on his part.
- H. That this action of the respondents of issuing joint seniority list and placing the name of the appellant in Poly Technic Degree holders, is based on malafide aimed at benefitting their nears and dears.

- I. That the law as well as rules is very much clear on the point and respondents have violated the law and principles of natural justice for reasons best known to them.
- J. That ten Lecturers have been promoted from the promotion quota/Degree Holders, vide Order dated 25-01-2018 and also evident from the Seniority List of 2017, thus the posts of Lecturers have fallen vacant in the reserved quota and the appellant as such was entitled to be promoted on the same.
- K. That the respondents have issued joint seniority list without any change and amendment in law and rules, and then illegally fixed the seniority of the appellant with the Seniority of vocational cadre.
- L. That the appellant has about ten years of service with unblemished service record.

**It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for.**

**Any other relief deemed appropriate in the circumstances of the case and not specifically asked for may also be granted in favor of the appellant.**
