

1. That, the appellant was appointed as untrained PTC teachers on 22.11.1994, whereas one Ali Munsif shown at serial No.84 of Annexure was also appointed as untrained PTC teacher. (The copy of appointment order is attached as Annexure "A").

2. That, the then D.E.O. passed an order, whereby, the services of the appellant and others were not found in accordance with law and therefore, his service was dispensed away. **(The copy of order is attached as Annexure "B")**.
3. That, the appellant and others impugned the said order of dispensing away of their services before the Honourable Peshawar High Court Circuit Bench Abbottabad, and during the hearing of the writ petition, it was agreed that the appellant and others would not press the writ petition provided that the processes be concluded within a period of 3 months and till then the appellant and others were allowed to continue their services. **(The judgment of the Honourable Court is attached as Annexure "C")**.
4. That, the D.E.O. Mansehra passed an order in the light of the judgment of the Honourable High Court circuit bench Abbottabad in writ petition No.49/97 and 61/97 and allowed thee appellant and others to continue their services till further order. **(The copy of order is attached as Annexure "D")**.
5. That, D.E.O. Manserha passed an order of appointment of trained P.T.C. candidates of P.S.46 and the appellant and the others were replaced, although they were fully qualified, eligible and were entitled to be appointed like others who were appointed being trained teachers. **(The copy of order is attached as Annexure "E")**.

6. That, the appellant was appointed by respondent NO.1 vide order dated: 25.07.1997. **(The copy of order is annexed as Annexure "F")**.
7. That, D.E.O. Mansehra has passed an order vide which the services of Munawar, Nazir Ahmed and Muhammad Haroon were regularized from the dates of their initial appointments. **(The copy order NO: 2485-2626/I-Volume-III/94 is attached as Annexure "G")**.
8. That, the appellant had left no stone unturned in getting his service regularized and in this respect the appellant has submitted diverse applications, but his grievance was not redressed by respondent NO.1 **(The copy of applications are attached as Annexure" H")**.
9. That, the appellant filed a writ petition before the Honourable Peshawar High Court, Circuit Bench Abbottabad and the Honouable Bench passed an order directing respondent No.2 to consider the case of appellant on merits within a period of one month and in case of refusal to pass a speaking order which should also be communicated to the appellant. **(copy of order of Honourable Court is attached as Annexure "I")**.

GROUND

- A. That, the reluctance/refusal of the respondents to count their services or to treat their appointments from the year 1994 is

arbitrary, therefore, respondent No.1 is under an obligation to treat the appellant at par with other who were extended the benefits.

- B. That, the respondent No.1 has not followed the law relating to the appointments and regularization as some of the PTC teachers, their services were regularized, whereas, such benefit was not extended to the appellant.
- C. That, the appellant and others were fully eligible and to be appointed as trained teachers in 1997, but others were appointed at the cost of appellant and others who were terminated and others were appointed.
- D. That, respondent No.1 has not applied his independent mind rather has acted in a manner which is neither warranted by law rather it is against all the norms of law and the Constitution of the Country.
- E. That, respondents NO.1&2 have observed sheer discrimination; on one hand Munawar, Nazir Ahmed and Muhammad Haroon, were regularized from the date of their initial appointment dated: 1994, whereas, the said treatment was never meted to the appellant.





TERMS AND CONDITIONS

1. They should submit their charge reports to all concerned.
2. Their appointment is purely on temporary basis and liable for termination at any stage without assigning any reason.
3. Their appointment is subject to the verification of their original Academic and and Professional certificates/documents. Their original Academic and Professional certificates should be checked thoroughly before handing over the charge and should not be handed over the charge if their original certificates are not found correct.
4. No one should be handed over charge if he is below 18 years and above 30 years in case of the candidates relating to Zone III and 27 years of others.
5. Their pay will not be drawn untill they produce age and Health certificate from Medical Superintendent DHQ Hospital Mansehra.
6. They will be governed under prescribed service rules framed by the Government of NWFP.
