Counsel for the appellant present. Preliminary arguments have been heard.

According to underlying fact among others, the department as per notification dated 24.07.2014 granted promotion to the holders of post of Subject Specialists for which the appellant was eligible but ignored by the respondents in disregard to the ratio of quota of 50% by promotion on the basis of seniority cum fitness from the relevant subject and 50% by initial recruitment. Addedly it has been contended that due to different Regularization of services Acts promulgated by Government of Khyber Pakhtunkhwa, many contract employees were regularized which adversely affected the promotion right of not only the appellant but also of other teachers. It has been urged that the appellant being employee of the respondent department is serving for more than 30 years and thus has right for promotion. Points raised need consideration. Subject to all legal and factual objections, this appeal is admitted for full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 22.02.2022 before the D.B.



***Appeal u/s 4 of the KP Service Tribunal Act, 1974 that the appellant is serving the education department since 1989 and thus he is entitled for promotion to the higher post, but the respondents illegally allowed promotion to the junior of appellant and denied the promotion to the appellant without any lawful excuse.***

**PRAYER**

***On acceptance of this appeal, the respondents may please be directed to consider the appellant for promotion to BPS-17 i.e. Subject Specialist from date***

**on which he was eligible and fit with all back benefits.**

**RESPECTFULLY SHEWETH;**

Brief facts of the case are as under:-

- 1) That the appellant is a teacher in the Education Department of Govt. of Khyber Pakhtunkhwa and is working on the post of SPST (BPS-14). (Copy of appointment order is Annex "A")
- 2) That the appellant has the qualification of MA alongwith PTC, CT, B.Ed, M.Ed etc. (Copies of education documents are Annex "B")
- 3) That as per notification dated 24.07.2014, the promotion to the post of Subject Specialist for which the appellant is eligible, but ignored by respondents, should be made on the ratio of 50% by promotion on the basis of seniority-cum-fitness from relevant subject and 50% by initial recruitment.

It may be mentioned here that due to different regularization Acts promulgated by the Govt. of Khyber Pakhtunkhwa, so many contract employees were regularized, which adversely effected the promotion rights of not only of the appellant, but of other teachers. (Copy of the notification dated 24.07.2014 is Annex "C")

- 4) That the respondents promoted and regularized juniors to the appellant and thus the appellant and another approached the hon'ble Peshawar High Court through WP No.393-P/2018, which was disposed-off vide judgment dated 21.01.2021. (Copy of the judgment dated 21.01.2021 is Annex "D")

- 5) That the respondents promoted junior employees to the appellant as reflected in the seniority list attached herewith as Annex "E"
- 6) That the appellant approaches the respondents through appeals, but all in vain. (Copy of appeals is Annex "F")
- 7) That the appellant is aggrieved of the illegal actions of the respondents by promoting juniors to the appellant on the higher post, which effected the rights of appellant and thus approaches this hon'ble Tribunal for the following amongst other grounds:-



GROUNDS:

- a. That the appellant being the employee of respondents' department and is working for more than 30 years and thus has the right of promotion, but the respondents in order to infringed the rights of appellant promoted juniors to the appellant by superseding him and thus the respondents needs to be directed to consider the appellant for promotion to the next higher grade for which he is eligible.
- b. That the appellant was discriminated by respondents for not promoting him as other similarly placed colleagues of appellant were promoted on their turn, but the same treatment was not extended to the appellant by respondents.
- c. That the prospect of promotion and other benefits, which are the legal rights of appellant have been violated by respondents, by not granting promotion to the appellant and thus they needs to be directed to do the needful in a short possible time frame.

- d. That the appellant has got all legal rights to be accommodated/ promoted to the higher posts i.e. Subject Specialist (BPS-17), but the respondents in clear violation of the law on the subject promoted juniors to the petitioner.
- e. That the fundamental rights of appellant have been violated by the respondents against the clear provision of law and constitution.

It is, therefore, prayed by accepting the instant appeal, the respondents may please be directed to consider the appellant for promotion to BPS-17 i.e. Subject Specialist from date on which he was eligible and fit with all back benefits.

- 1) That the petitioners are teachers in the Education Department of Govt. of KPK and are working on the

post of SPST (BPS-14) & SCT (BPS-16) as given in the heading of the writ petition. (Copies of appointment orders are Annex "A")

- 2) That the above mentioned cadre were eligible and entitled to apply for the post of subject specialist (BPS-17) in the previous years i.e. 2007, but the respondents denied the petitioners even to apply for the same on the ground of being permanent civil servant, so they cannot apply for SS (BPS-17) and put a condition on them that they have to resigned from their permanent posts and then they can apply for the same.
- 3) That the only qualification for the post of SS (BPS-17) was MA/ MSc 2<sup>nd</sup> Division, with B.Ed or M.Ed, which the petitioners have already got their master and professional degree in 1<sup>st</sup> division. (Copies of educational documents are attached as Annex "B")
- 4) That as per notification No.SO(PE)4-5/SS RC/Meeting/ 2013/ Teaching Cadre dated 24.07.2014, the promotion to the post of subject specialist BPS-17 should be made on the ratio of 50% by promotion on the basis of seniority-cum-fitness for the relevant subject and 50% by initial recruitment. (Copy of the notification is Annex "C")

It may be mentioned here that through the above mentioned notification dated 24.07.2014, the notification No.SO(G)S&LD/1-28/2009/Vol-II, dated 09.04.2004, notification No.So(G)S&L/1-69/06/Vol-I/DPE/LIB dated 13.11.2007 and notification

- 5) That the procedure as laid down above was adopted by Education Department for appointment/promotion of the posts of subject specialist (BPS-17) and thus every one in service employee in the teaching cadre would get his promotion according to the laid down procedure.
- 6) That an Ordinance No.VIII of 2009 dated 24.09.2009, which was later on converted into NWFP Now KPK Act No.XVI, 2009 namely "The KPK Employees (Regulation of Service) Act, 2009 dated 24.11.2009" was passed for regularization of the service of those employees, who were appointed on Adhoc or Contract basis.
- 7) That prior to the promulgation of above mentioned Act, it was a practice in the respondents department that instead of considering the permanent teachers for promotion to the posts of SET (BPS-16) and SS (BPS-17) the respondents would advertise the said posts on Adhoc/ Contract basis on open merit on temporary basis initially for a period of six months or one year by Public Service Commission or Departmental Selection or promotion Committee.

It may be mentioned here that normally the respondents would not considered the regular Govt. Servants for these short termed contract

appointments. (Copy of such kind of advertisement is Annex "D").

- 8) That even the above mentioned condition some of the teachers applied for the said posts of SET and SS etc, but they were not considered by the respondents department being permitted teachers.
- 9) That due to the Act 2009, all those teachers were regularized even though the respondents didn't adopt any legal procedure for their appointments on Adhoc/ Contract basis and thus hundreds and thousands of teachers, who had/ have more than 20 years' of service experience at their credit were ignored.
- 10) That the only authority, which could appoint the employees in BPS-16 or above is KPK Public Service Commission (respondent No.5), but the respondents in order to accommodate and obliged their own blue eyed persons and political workers illegally and unlawfully appoint those person on the posts of BPS-16 and above.
- 11) That those employees/ teachers, who were regularized in BPS-16 and 17 were further promoted to the posts of BPS-18 & some to BPS-19, but all those teachers, who were eligible and fit for promotion to the posts of SET or Subject Specialist (BPS-17) are still working as SPST, SCT, CT etc and the respondents are taking no steps to clear the blockage already created by regularized candidates in order to consider the teachers for the

- 12) That although the above mentioned Act of 2009 is beneficial through which thousands of employees including teachers in different cadre were regularized, but it adversely affected the rights of petitioners, furthermore, the inaction/ actions of respondents not to abide by the notification of 24.07.2014 i.e. 50% quota by promotion to washing out the blockage made due to the regularization of Teachers in BPS-16 & 17 due to which the valuable rights of petitioners to the prospect of their promotions to the higher cadre i.e. Subject Specialist (BPS-17) effected and thus the petitioners are aggrieved of the above actions of respondents and having no other adequate and efficacious remedy, approaches this Hon'ble Court for the following amongst other grounds:-

### GROUNDS

- a) That since the promulgation of Regularization Act, 2009, thousands of teachers were regularized even though they were not appointed in accordance with law, which adversely affected the promotion prospects of petitioners and other similarly placed teachers, but the inaction/ not clearing the

- c) That the petitioners being the employees of respondents department and are working for more than 20 years and thus have their prior promotion right over all new appointments to be made on the posts of SS (BPS-17) and thus the respondents needs to be directed to consider the petitioners for the post of Subject Specialist (BPS-17) whenever the posts become vacant or created in their respective districts.
- d) That the petitioners alongwith other similarly placed teachers were discriminated by not considering them or stopping them to participate/ applying for the posts of SET, SS

etc in previous years, which was against the law, which the petitioners are now reaping in the shape of their miseries of not getting promotion to the post of Subject Specialist (BPS-17) as those who were appointed made such huge blockage, which the respondents are least interested to clear or washed out.

- e) That the prospect of promotion and other benefits, which were and are the legal rights of petitioners have been violated by the respondents by not clearing the blockage made due to the Regularization of Teachers through the Act of 2009, which is a clear violation of the fundamental rights of petitioners and thus the same needs to be declared as null and void.



MUHAMMAD NAEEM ANWAR, J.- Sartaj and Mian

Midrar Ullah Kakakhel, the petitioners, have filed the instant petition under Article 199 of the Constitution of the Islamic Republic of Pakistan, 1973, with the following prayers:-

- i. Keep in abeyance the notification dated 24.07.2014 or any further policy in respect of filling up the vacancies of all cadre in education department especially the posts of SS (BPS-17) due to the blockage made through the Regularization Act, 2009 under which hundreds and thousands of teachers in different cadres were regularized by depriving the petitioners and alike teachers of their prospects of promotion and other benefits in order to bring a balance in fresh appoint and promotion quota,
- ii. Consider the petitioners for promotion to the post of BPS-17 i.e., subject specialist, if they are otherwise eligible and fit for the same on priority basis,
- iii. Direct the respondents to work out the blockage of promotion quota since the promulgation of KPK Employees (Regularization of Service) act. No. XVI, 2009 in teaching cadre to the effect of i.e. how much promotion done and how much teachers were appointed on different posts,

**iv.** The Act of 2009 being a beneficial Act/Law whether that could and would be used as non-beneficial for the in-service teachers/employees and if not why the rights of in-service Govt. employees should be curtailed or infringed as far as all the rights of service are concern i.e., promotion seniority, back benefits, pensionary benefits etc.

**v.** Why the regularized candidates were put higher on seniority list and they have further been promoted by respondents to higher grades posts/cadre, which amounts to clear violation of not only of the Act of 2009, but also of the settled principles of law.

2. As per contents of the petition, petitioner No. 1 is performing duty as SPST (BPS-14), while petitioner No.2 is performing his duty as SCT (BPS-16) in the respondents' department. The grievance of the petitioners are that they were eligible to apply for the post of Subject Specialist (BPS-17) in year, 2007, but the respondents did not allow them on the ground of being permanent employees, thus, they were discriminated by not considering them to apply for the subject posts, which act of the respondents was against the law, as the petitioners are reaping in the shape of their miseries of not getting promotion to the post of Subject Specialist as those who were appointed on contract basis and, subsequently, regularized made such huge blockage, which the respondents are not interested to clear it, whereas according to the notification dated 24.07.2014, the posts of Subject Specialist are to be filled in on the ratio of 50% by promotion and 50% by initial recruitment through respondent.

No.5, however, the respondents are not doing what they are required by law to do. According to them, they being employees of respondents' department working for more than 20 years are entitled to be promoted to the post of Subject Specialist (BPS-17), therefore, asked for directing the respondents to consider them for promotion to the post of Subject Specialist (BPS-17) whenever the posts become vacant or created in their respective Districts and, as such, filed the instant petition for issuance of the desired writ.

3. In response to the notice, respondents No. 1 and 2 submitted their Para-wise comments, wherein they stated that the posts of Subject Specialist were purely on contract basis hence, the in-service teachers were barred not to apply for the said post as the petitioners have an opportunity of promotion and up gradation on the basis of their respective seniority cum fitness. They further stated that the petitioners have suppressed material facts from the court as they along with their other colleagues had filed identical writ petitions and the respondents have complied with the order/directions of this court dated 26.01.2015 passed in COC No. 157-P/2015 in writ petition No. 2905/2009.

4. Arguments heard and record perused.

5. Earlier, identical writ petitions were filed by the PSTs, CTs, DMs, PETs, ATs, TTs, Qaris and SETs, serving in the Education Department in different Schools, before this court which were disposed of vide consolidated judgment dated

26.01.2015, rendered in W.P No. 2905/2009 in the following terms:-

(i) "The Act, XVI of 2009, commonly known as (Regularization Of Services) Act, 2009 is held as beneficial and remedial legislation, to which no interference is advisable hence, upheld.

(ii) Official respondents are directed to work out the backlog of the promotion quota as per above mentioned example, within 30 days and consider the in service employees, till the backlog is washed out, till then there would be complete ban on fresh recruitments."

Subsequently, a contempt of court petition bearing No. 157-P/2015 was filed which too was disposed of on 10.11.2015 in the following terms:-

"Learned AAG produced district wise detail of in service teachers both (male/Female) which were promoted during the month of June and July 2015 and stated at the bar that 2,725 employees/teachers have been promoted and 1766 have been regularized as directed this court in its judgment dated 26.1.2015, further stated that the judgment of this court has been complied with in letter and spirit.

2. Learned counsel for the petitioners when confronted with the assertion of learned AAG he straight away conceded and states that the COC has served its purpose.

3. In view of above the instant COC has served its purpose and as such deposed of accordingly."

6. Apart from the above, the petitioners, admittedly, are civil servants and the matter raised relates to the terms and conditions of service which cannot be agitated in writ jurisdiction in view of the bar contained in Article 212 of the Constitution of the Islamic Republic of Pakistan, 1973 as it has consistently been held by the Apex Court that the matter relating to the terms and condition of service can be urged

before the departmental authority and then the Service Tribunal and this Court, while exercising its jurisdiction under Article 199 of the Constitution of Islamic Republic of Pakistan, can't step-in, therefore, in view of the above, the petition being without any merit is hereby dismissed.




