



Respectfully Sheweth,

1. That the Appellant has been appointed as Constable on 25.12.2014 with respondent department.
2. That the appellant performed his duty regularly and with full devotion and no complaint whatsoever has been made against the appellant.
3. That the appellant was busy in his study process for master from Agriculture University Peshawar due to which the appellant was unable to perform his duty with respondent department.
4. That a show cause notice has been issued against the appellant on 15.02.2021 by the respondent department which has been properly replied by the appellant. (Copy of show cause notice and reply are attached as annexure "A & B" respectively).
5. That due to the reason mention in para-3 the appellant has been awarded major punishment of dismissal from service as well as recovery of salary on 02.04.2021 by

the respondent department. (Copy of dismissal order is attached as annexure "C").

6. That against the said impugned order the appellant submitted departmental appeal on 03.04.2021 which has not been decided within the statutory period of 90 days. (Copy of departmental appeal is attached as annexure "D").
7. That feeling aggrieved the Appellant prefers the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:-

GROUND:-

- A. That the impugned order dated 02/04/2021 is void and ab-initio order because it has been passed without fulfilling codal formalities in this respect the appellant relied upon a judgment reported on 2007 SCMR Page 834.
- B. That no charge sheet and statement of allegation has been issued or served to the appellant, which is a clear cut violation of Rule-6 (A) (B) of police Rules-1975.
- C. That the impugned order is also void because no regular or departmental inquiry was conducted against the appellant which is

mandatory before imposing the major penalty and no opportunity of personal hearing and defense has been provided to the appellant relied upon a judgment reported on 2003 PLC (CS) Page 365 on 2021 PLC (CS) page 235 as well as judgment of this Tribunal in service appeal No. 1181/2018 decided on 17.09.2021.

D. It is a well settled principle of law no one can be condemned unheard because it is against the natural justice of law in this respect the appellant relied upon a judgment reported on 2008 SCMR page:678.

E. That no opportunity of cross examination has been provided to the appellant. In this respect the appellant relied upon a judgment reported on 2016 SCMR Page 108.

F. That no specification of absentee has been mentioned in the impugned order and so concerned the absence of the appellant, it was not intentionally but due to the reason mentioned in the above para.

G. That any other ground not raised here may graciously be allowed to be raised at the time

full of arguments on the instant service appeal.

It is therefore, most humbly prayed that on acceptance of this appeal the impugned orders dated 02/04/2021, may kindly be set aside and the appellant may kindly be reinstated in service along with all back benefits. 
