

COMMENTS ON BEHALF OF RESPONDENTS NO.1&2

PRELIMINARY OBJECTIONS.

1. That the appeal is barred by law as an employee posted in OPS cannot claim seniority from the date he remained posted in OPS.
2. The appellant has no locus standi to bring the present Service Appeal.
3. The appeal is bad for non-joinder/mis-joinder of necessary parties.
4. That the appellant has no cause of action.
5. That the appellant is estopped to file the present appeal.

ON FACTS

1. Incorrect. The appellant was basically Assistant of District Swabi who was posted as Head Clerk Revenue Shangla in OPS on 21.04.2005 against the rules. Naib Tehsildar was/is a divisional cadre post against which the promotion is to be made from amongst the officials having domicile of the same division/district through Departmental Promotion Committee. Posting in OPS is mere a posting issued to meet exigency of work in public interest. The services of the appellant were regularized through Departmental Promotion Committee with immediate effect according to Rules which is a proper forum for promotion.
2. Incorrect. In light of the Judgment of Service Tribunal M/S Haider Hussain and Qaiser Naz were promoted as Naib Tehsildar vide order dated 14.03.2009 (Annexure – A) through proper Departmental Promotion Committee and they were given seniority from their regular promotion on the basis of Judgment of Service Tribunal Khyber Pakhtunkhwa. (Seniority List of 2009 attached with appeal page 17-21 of the annexure-D).
3. Correct. M/S Haider Hussain and Qaiser Naz were promoted as Tehsildar on their own turn being senior most Naib Tehsildars and now they have been promoted as PMS officer BPS – 17.
4. Incorrect. The appellant misinterpreted the Judgment of Apex Supreme Court. The Judgment of Apex Supreme Court is not applicable in the instant case. As official posted in OPS cannot claim Seniority for the period he remained posted in OPS.
5. Correct to the extent that the name of appellant was inadvertently shown at S.No. 25 of the tentative Seniority list which was rectified in final Seniority List, to which the appellant did not object.
6. Incorrect. Final Seniority List of Naib Tehsildar was revised according to section 8(4) of KPK Civil Servant Act, 1973 on 10.08.2010 by rectifying the wrong entries found in the Seniority List issued on 30.06.2010 by the Competent Authority.

Correct to the extent that on the direction of Competent Authority the Seniority List was rechecked and it was found that some Naib-Tehsildars were given seniority of the period they remained posted in OPS, therefore Seniority List was revised and the official along with his other colleagues were placed at proper place and given them seniority from the date of their regular promotion.

8. Incorrect. Under political pressure, the appellant, a junior Assistant, as the name of appellant reflect at S. No: 6 of the seniority list of Assistants, of Mardan Division (Annexure – B) was posted District Revenue Accountant OPS in Shangla against the rules.
9. No comments.
10. The Judgments of Apex Court were / are always honored by the Department which has acted strictly in accordance with law and superior court judgments. The judgment of Superior Court pertains to Acting Charge Basis, while the appellant wants its application on OPS appointments, which is illegal.
11. Incorrect. The order was not issued in light of the Judgment of Peshawar High Court but it was an Administrative order and was against the rules. As according to section 8(4) of Civil Servant Act, 1973 seniority in a post service or cadre to which a Civil Servant is promoted shall take effect from the date of regular appointment to that post. Therefore the so-called regularization order was coram non-judice and not according to law.
12. Correct. Both the order dated 01.10.2009 and 05.11.2010 being void and illegal; therefore the Competent Authority rightly rejected the application of the appellant for seniority w.e.f the date he remained posted in OPS.
13. Under the Civil Servant (Appeal) Rules 1986, appeal against orders of Secretary lies to Chief Secretary. Therefore the appellant has not fulfilled the precondition for filing of appeal before the Service Tribunal.

GROUND.


- A. Incorrect. An error can be rectified by the Competent Authority at any time.
- B. As at para – 10 of the facts.
- C. Incorrect. An illegal order can any time be revised and error can be removed by the Competent Authority.
- D. Incorrect. As in A and C of the grounds.
- E. Incorrect. The appellant remained posted as Naib Tehsildar OPS w.e.f 21.04.2005 till 01.10.2009 therefore he cannot claim the seniority of the period he remained posted in OPS.
- F. Incorrect. All the promotions were made according to Rules through proper Departmental Promotion Committee and no one has promoted illegally. The appellant is also required to wait for his turn.
- G. The appellant speaks the language through which he obtained illegal orders from a person in his favour, whose acts/orders are being enquired by NAB.
- H. Incorrect.
- I. Incorrect. M/S Haider Hussain and Qaiser Naz were promoted in ACB through proper procedure while the appellant was posted in OPS which cannot be counted towards seniority.

Correct to the extent that the then Senior Member, Board of Revenue has given seniority to the officials through administrative order against the rules. The illegal order cannot be quoted as precedent.

PRAYER

- i) The seniority was issued and rectified according to Civil Servant Act, 1973
- ii) The Judgment of Apex Supreme Court of Pakistan is not applicable in the case of applicant. The order dated 01.10.2009 cannot be implemented being illegal / void and against the norms of Rules.
- iii) No junior was promoted. All promotions were made according to Rules and merits. The wrong doing of a person can be rectified at any time by the Competent Authority.

In view of the above, the appeal has no merits and may be dismissed with costs.

COMMENTS ON BEHALF OF RESPONDENTS NO.1&2

PRELIMINARY OBJECTIONS.

1. That the appeal is barred by law as an employee posted in OPS cannot claim seniority from the date he remained posted in OPS.
2. The appellant has no locus standi to bring the present Service Appeal.
3. The appeal is bad for non-joinder/mis-joinder of necessary parties.
4. That the appellant has no cause of action.
5. That the appellant is estopped to file the present appeal.

ON FACTS

1. Incorrect. The appellant was basically Assistant of District Swabi who was posted as Head Clerk Revenue Shangla in OPS on 21.04.2005 against the rules. Naib Tehsildar was/is a divisional cadre post against which the promotion is to be made from amongst the officials having domicile of the same division/district through Departmental Promotion Committee. Posting in OPS is mere a posting issued to meet exigency of work in public interest. The services of the appellant were regularized through Departmental Promotion Committee with immediate effect according to Rules which is a proper forum for promotion.
2. Incorrect. In light of the Judgment of Service Tribunal M/S Haider Hussain and Qaiser Naz were promoted as Naib Tehsildar vide order dated 14.03.2009 (Annexure – A) through proper Departmental Promotion Committee and they were given seniority from their regular promotion on the basis of Judgment of Service Tribunal Khyber Pakhtunkhwa. (Seniority List of 2009 attached with appeal page 17-21 of the annexure-D).
3. Correct. M/S Haider Hussain and Qaiser Naz were promoted as Tehsildar on their own turn being senior most Naib Tehsildars and now they have been promoted as PMS officer BPS – 17.
4. Incorrect. The appellant misinterpreted the Judgment of Apex Supreme Court. The Judgment of Apex Supreme Court is not applicable in the instant case. As official posted in OPS cannot claim Seniority for the period he remained posted in OPS.
5. Correct to the extent that the name of appellant was inadvertently shown at S.No. 25 of the tentative Seniority list which was rectified in final Seniority List, to which the appellant did not object.
6. Incorrect. Final Seniority List of Naib Tehsildar was revised according to section 8(4) of KPK Civil Servant Act,1973 on 10.08.2010 by rectifying the wrong entries found in the Seniority List issued on 30.06.2010 by the Competent Authority.

7. Correct to the extent that on the direction of Competent Authority the Seniority List was rechecked and it was found that some Naib Tehsildars were given seniority of the period they remained posted in OPS, therefore Seniority List was revised and the official alongwith his other colleagues were placed at proper place and given them seniority from the date of their regular promotion.
8. Incorrect. Under political pressure, the appellant, a junior Assistant, as the name of appellant reflect at S. No. 6 of the seniority list of Assistants, of Mardan Division (Annexure – B) was posted District Revenue Accountant OPS in Shangla against the rules.
9. No comments.
10. The Judgments of Apex Court were / are always honored by the Department which has acted strictly in accordance with law and superior court judgments. The judgment of Superior Court pertains to Acting Charge Basis, while the appellant wants its application on OPS appointments, which is illegal.
11. Incorrect. The order was not issued in light of the Judgment of Peshawar High Court but it was an Administrative order and was against the rules. As according to section 8(4) of Civil Servant Act, 1973 seniority in a post service or cadre to which a Civil Servant is promoted shall take effect from the date of regular appointment to that post. Therefore the so-called regularization order was corum non-judice and not according to law.
12. Correct. Both the order dated 01.10.2009 and 05.11.2010 being void and illegal; therefore the Competent Authority rightly rejected the application of the appellant for seniority w.e.f the date he remained posted in OPS.
13. Under the Civil Servant (Appeal) Rules, 1986, appeal against orders of Secretary lies to Chief Secretary. Therefore the appellant has not fulfilled the precondition for filing of appeal before the Service Tribunal.

GROUND.


- A. Incorrect. An error can be rectified by the Competent Authority at any time.
- B. As at para – 10 of the facts.
- C. Incorrect. An illegal order can any time be revised and error can be removed by the Competent Authority.
- D. Incorrect. As in A and C of the grounds.
- E. Incorrect. The appellant remained posted as Naib Tehsildar OPS w.e.f 21.04.2005 till 01.10.2009 therefore he cannot claim the seniority of the period he remained posted in OPS.
- F. Incorrect. All the promotions were made according to Rules through proper Departmental Promotion Committee and no one has promoted illegally. The appellant is also required to wait for his turn.
- G. The appellant speaks the language through which he obtained illegal orders from a person in his favour, whose acts/orders are being enquired by NAB.
- H. Incorrect.
- I. Incorrect. M/S Haider Hussain and Qaiser Naz were promoted in ACB through proper procedure while the appellant was posted in OPS which cannot be counted towards seniority.

J Correct to the extent that the then Senior Member, Board of Revenue has given seniority to the officials through administrative order against the rules. The illegal order cannot be quoted as precedent.

PRAYER

- i) The seniority was issued and rectified according to Civil Servant Act, 1973
- ii) The Judgment of Apex Supreme Court of Pakistan is not applicable in the case of applicant. The order dated 01.10.2009 cannot be implemented being illegal / void and against the norms of Rules.
- iii) No junior was promoted. All promotions were made according to Rules and merits. The wrong doing of a person can be rectified at any time by the Competent Authority.

In view of the above, the appeal has no merits and may be dismissed with costs.

3. The appeal is bad for non-joinder/mis-joinder of necessary parties.
4. That the appellant has no cause of action.
5. That the appellant is estopped to file the present appeal.

ON FACTS


1. Incorrect. The appellant was basically Assistant of District Swabi who was posted as Naib Tehsildar Dir Upper on 19.08.2006 against the rules. Naib Tehsildar was/is a divisional cadre post against which the promotion is to be made from amongst the officials having domicile of the same division/district through Departmental Promotion Committee. Posting in OPS is mere a posting issued to meet exigency of work in public interest. The services of the appellant were regularized through Departmental Promotion Committee with immediate effect according to Rules which is a proper forum for promotion.
2. Incorrect. In light of the Judgment of Service Tribunal M/S Haider Hussain and Qaiser Naz were promoted as Naib Tehsildar vide order dated 14.03.2009 (Annexure – A) through proper Departmental Promotion Committee and they were given seniority from their regular promotion on the basis of Judgment of Service Tribunal Khyber Pakhtunkhwa. (Seniority List of 2009 attached with appeal page 12-16 of the annexure-D).
3. Correct. M/S Haider Hussain and Qaiser Naz were promoted as Tehsildar on their own turn being senior most Naib Tehsildars and now they have been promoted as PMS officer BPS – 17.
4. Incorrect. The appellant misinterpreted the Judgment of Apex Supreme Court. The Judgment of Apex Supreme Court is not applicable in the instant case. As official posted in OPS cannot claim Seniority for the period he remained posted in OPS.
5. Correct to the extent that the name of appellant was inadvertently shown at S.No. 30 of the tentative Seniority list which was rectified in final Seniority List, to which the appellant did not object.
6. Incorrect. Final Seniority List of Naib Tehsildar was revised according to section 8(4) of KPK Civil Servant Act, 1973 on 10.08.2010 by rectifying the wrong entries found in the Seniority List issued on 30.06.2010 by the Competent Authority.

J Incorrect. The respondent No.6 was earlier promoted as Naib Tehsildar on 8.2.2005 in his own pay & scale then promoted to the post of Naib Tehsildar on Acting Charge Basis on 10.5.2008 by the Competent Authority on the recommendation of Departmental Promotion Committee and later on promoted on regular basis by the Competent Authority to the same very post on 02.5.2009 through the Departmental Promotion Committee. Subsequently, the respondent (Nek Muhammad) filed departmental appeal before the Senior Member, Board of Revenue for granting seniority w.e.f. 10.5.2008 instead of 02.5.2009. On acceptance of appeal, the undersigned was granted seniority w.e.f. 10.5.2008 by the appellate authority.

PRAYER


- i) The seniority was issued and rectified according to Civil Servant Act, 1973
- ii) The Judgment of Apex Supreme Court of Pakistan is not applicable in the case of applicant. The order dated 01.10.2009 cannot be implemented being illegal / void and against the norms of Rules.

Naib Tehsildar was/is a divisional cadre post against which the promotion is to be made from amongst the officials having domicile of the same division/district through Departmental Promotion Committee. Posting in OPS is mere a posting issued to meet exigency of work in public interest. The services of the appellant were regularized through Departmental Promotion Committee with immediate effect according to Rules which is a proper forum for promotion.
2. Incorrect. In light of the Judgment of Service Tribunal M/S Haider Hussain and Qaiser Naz were promoted as Naib Tehsildar vide order dated 14.03.2009 (Annexure – A) through proper Departmental Promotion Committee and they were given seniority from their regular promotion on the basis of Judgment of Service Tribunal Khyber Pakhtunkhwa. (Seniority List of 2009 attached with appeal page 12-16 of the annexure-D).
3. Correct. M/S Haider Hussain and Qaiser Naz were promoted as Tehsildar on their own turn being senior most Naib Tehsildars and now they have been promoted as PMS officer BPS – 17.
4. Incorrect. The appellant misinterpreted the Judgment of Apex Supreme Court. The Judgment of Apex Supreme Court is not applicable in the instant case. As official posted in OPS cannot claim Seniority for the period he remained posted in OPS.
5. Correct to the extent that the name of appellant was inadvertently shown at S.No. 30 of the tentative Seniority list which was rectified in final Seniority List, to which the appellant did not object.
6. Incorrect. Final Seniority List of Naib Tehsildar was revised according to section 8(4) of KPK Civil Servant Act, 1973 on 10.08.2010 by rectifying the wrong entries found in the Seniority List issued on 30.06.2010 by the Competent Authority.

7. Correct to the extent that on the direction of Competent Authority the Seniority List was rechecked and it was found that some Naib Tehsildars were given seniority of the period they remained posted in OPS, therefore Seniority List was revised and the official along with his other colleagues were placed at proper place and given them seniority from the date of their regular promotion.
8. Incorrect. Under political pressure, the appellant, a junior Assistant, as the name of appellant reflect at S.No. 7 of the seniority list of Assistants of Mardan Division (Annexure - B), was posted as Naib Tehsildar in OPS. Dir Upper against the rules.
9. No comments.
10. The Judgments of Apex Court were / are always honored by the Department. The judgment of Superior Court pertains to Acting Charge Basis, while the appellant wants its application on OPS appointments, which is illegal.
11. Incorrect. The order was not issued in light of the Judgment of Peshawar High Court but it was an Administrative order and was against the rules. As according to section 8(4) of Civil Servant Act, 1973 seniority in a post service or cadre to which a Civil Servant is promoted shall take effect from the date of regular appointment to that post. Therefore the so-called regularization order was coram non-judice and not according to law.
12. Correct. Both the order dated 01.10.2009 and 05.11.2010 being void and illegal; therefore the Competent Authority rightly rejected the application of the appellant for seniority w.e.f the date he remained posted in OPS.
13. Under the Civil Servant (Appeal) Rules 1986, appeal against orders of Secretary lies to Chief Secretary. Therefore the appellant has not fulfilled the precondition for filing of appeal before the Service Tribunal.

GROUND.


- A. Incorrect. An error can be rectified by the Competent Authority at any time.
- B. As at para - 10 of the facts.
- C. Incorrect. An illegal order can any time be revised and error can be removed by the Competent Authority.
- D. Incorrect. As in A and C of the grounds.
- E. Incorrect. The appellant remained posted as Naib Tehsildar OPS w.e.f 19.08.2006 till 01.10.2009, therefore he cannot claim the seniority of the period he remained posted in OPS.
- F. Incorrect. All the promotions were made according to Rules through proper Departmental Promotion Committee and no one has promote illegally. The appellant is also required to wait for his turn.
- G. The appellant speaks the language through which he obtained illegal orders from a person in his favour, whose acts/orders are being enquired by NAB.
- H. Incorrect.
- I. Incorrect. M/S Haider Hussain and Quiser Naz were promoted in ACB through proper procedure while the appellant was posted in OPS which cannot be counted towards seniority.

J Incorrect. The respondent No.6 was earlier promoted as Naib Tehsildar on 8.2.2005 in his own pay & scale then promoted to the post of Naib Tehsildar on Acting Charge Basis on 10.5.2008 by the Competent Authority on the recommendation of Departmental Promotion Committee and later on promoted on regular basis by the Competent Authority to the same very post on 02.5.2009 through the Departmental Promotion Committee. Subsequently, the respondent (Nek Muhammad) filed departmental appeal before the Senior Member, Board of Revenue for granting seniority w.e.f. 10.5.2008 instead of 02.5.2009. On acceptance of appeal, the undersigned was granted seniority w.e.f. 10.5.2008 by the appellate authority.

PRAYER


- i) The seniority was issued and rectified according to Civil Servant Act, 1973
- ii) The Judgment of Apex Supreme Court of Pakistan is not applicable in the case of applicant. The order dated 01.10.2009 cannot be implemented being illegal / void and against the norms of Rules.
- iii) No junior was promoted. All promotions were made according to Rules and merit. The wrong doing of a person can be rectified at any time by the Competent Authority.

In view of the above, the appeal has no merits and may be dismissed with costs.
