






At the outset of his arguments, the learned counsel for the appellant candidly admitted that the seniority list impugned herein is admittedly tentative, and that neither a final seniority list has been issued so far nor final order within the meaning of section 4 of the NWFP (KPK) Service Tribunal Act, 1974 has been passed by the appellate authority i.e. Provincial Police Officer, KPK, Peshawar (Respondent No.2) on the representation/appeal of the appellant against the provisional/tentative seniority list. Since appeal is admissible/maintainable only against a final order under section 4 of the NWFP(KPK) Service Tribunal Act, 1974, this appeal cannot proceed and is liable to be disposed of at the initial stage. The appeal is accordingly dismissed in limine, with no order as to costs.

period of time.*

Prayer:

*That on acceptance of this appeal the
seniority list of the DSPs be revised and the name of the
appellant be placed at the place comensorating to his
seniority.*

Respectfully Sheweth:

Facts:

- i. That the appellant was performing his duties as Inspector in the Police Force during the days of insurgency in District Swat.
- ii. That as reward of the gallantry shown by the Police Officers in the days of insurgency by efficiently and gallantly performing their duties in the face of eminent threat to their lives, they were given one step up promotion by the Chief Minister Khyber Pakhtunkhwa.
- iii. That the appellant was one of those officers on which basis he was given one step up promotion vide Notification No. S/4018-51/12, dated Peshawar, the 29-05-2012 by your good self. Copy of the order is enclosed as Annexure "A".
- iv. That recently the ~~seniority~~ seniority list of the DSPs have been prepared/issued in which the name of the appellant is left over without any reasons whatsoever. Copy of the seniority list is enclosed as Annexure "B".
- v. That the appellant is still in active service as DSP yet his name is not mentioned in the list issued, against which the appellant preferred departmental appeal. The same is still pending despite the lapse of Statutory period, hence this appeal on the following grounds. Copy of the departmental appeal is enclosed as Annexure "C".

Grounds:

- a. *That the appellant has properly been promoted as DSP by the competent authority and is efficiently performing his duties without any complaints by the authorities till date.*
- b. *That vested rights have been accrued to the appellant which are now been infringed.*
- c. *That the appellant has the legitimate expectations of his name being mentioned in the seniority list of DSPs maintained by the authorities.*
- d. *That the name of the appellant has been left over in blatant violation of the law and rules, although, the appellant is in active service as DSP.*
- e. *That the authorities have used their official authority in a colorful manner and that also by travelling beyond the official authority vested in them.*

It is, therefore, very respectfully prayed that on acceptance of this appeal the name of the appellant may very kindly be included in the seniority list of the DSPs at the relevant position inline with his actual seniority.

Any other relief deemed appropriate may also very kindly granted.
