



- 2- That appellant has served the Department for more than 32 years as Field assistant. That despite of having experience and seniority the appellant has not been promoted to the post of Agriculture Inspector (BPS-11) till date though many other junior colleagues of the appellant has now been working as Agriculture Officers (BPS-17) but the appellant having more than 32 years service and being senior most employee and eligible for promotion has not been promoted till date to the post of Agriculture Inspector (BPS-11).
- That despite of that the respondent Department has issued 3-Notification dated 30.6.2011 due to which the chances of promotion to the post of Agriculture Inspector (BPS-11) has been attached with the condition that " 33% of total sanctioned posts of Agriculture inspector be allowed BPS-11 to BPS-14 as Agriculture supervisor in each wing of Agriculture Department subject to minimum service of 15 years service as Agriculture Inspector or Field Assistant ivthe curriculum of Field Assistant class will be revised and duration of the course will be enhanced from two years to three years (diploma course) for field Assistant and v- six months condensed course in the relevant field in the respective wing of the agriculture Department will be conducted for in-service staff and they will clear the examination in two terms otherwise they will be compulsory retired from service".

- 4- That all the above mentioned conditions of the said Notification are against the existing service structure of the agriculture Department. Further more due to above mentioned conditions the chances of promotion of field Assistant will certainly be stopped.
- 5- That feeling aggrieved appellant prefer this Departmental appeal on the following grounds amongst the others.

#### **GROUNDS:**

- A- That the impugned Notification dated 30.6.2011 is against the law, facts, natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That not granting/allowing promotion to the appellant to the post of Agriculture Inspector (BPS-11) from Field Assistant is against the law, facts and norms of natural justice.
- C- That appellant has not been treated by the authorities in accordance with law and rules on the subject noted above and as such the respondent Department violated Article 4 and 25 of the Constitution of Pakistan 1973.
- D- That despite of having more than 32 years service and having eligibility for promotion to the post of Agriculture Inspector the appellant has been ignored from promotion/up gradation to higher scale.
- E- That the Agriculture Department has acted in arbitrary and malafide manner by not promoting the appellant to the post of Agriculture Inspector (BPS-11).
- F- That many of the appellant junior colleagues have now been working as Agriculture Officers BPS-17 and the appellant is still working as Field Assistant (BPS-9) thus the appellant has been discriminated and not been treated amongst his similarly placed colleagues.

It is therefore humbly prayed that on acceptance of this Departmental appeal the impugned Notification dated 30.6.2011 may very kindly be set aside and the appellant may very kindly be promoted to the post Agriculture Inspector (BPS-11). Any other remedy which your good self deems fit that may also be awarded in favor of the appellant.
