

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 24-05-2022 WHEREBY THE APPELLANT HAS BEEN PROMOTED TO THE POST OF SUBJECT SPECIALIST (BPS-17) WITH IMMEDIATE EFFECT INSTEAD OF w-e-f 07.11.2019 AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned notification dated 24-05-2022 may kindly be modified/rectified to the extent that the appellant may be promoted w-e-f 07-11-2019 and not from 24-05-2022 with all back benefits including seniority. Any other remedy which this august Tribunal deems fit, may also be awarded in favor of the appellant.

R/SHWETH:

ON FACTS:

- 1. That the appellant was appointed as SST (Male) in BPS-16 on regular basis on the recommendation of Khyber Pakhtunkhwa Public Service Commission vide notification dated 07-03-2012. Copies of the notification dated 07-03-2012 is attached as annexure..... **A.**
- 2. That as per the direction of the competent authority the appellant submitted the requisite documents along with ACR/PER before the competent authority for placing it

before the DPC for promotion to the post of Subject Specialist in December 2018 held on 07.11.2019.

3. That irrespective of the fact that the appellant was eligible and qualified for promotion to the subject post but he was deferred in the meeting of Departmental Promotion Committee held on 07.11.2019 for want of PERs.
4. That the ACR and Synopsis of the appellant were submitted for departmental promotion through District Education Officer, Shangla, vide letter dated 07.03.2020 to the Director E&S Education Khyber Pakhtunkhwa, Peshawar. Copy of the Letter dated 07.03.2020 is attached as annexure.....**B.**
5. That as per the minutes of the DPC meeting held on 19.11.2020 the appellant was considered eligible for his promotion but was not promoted once again without any reason and justification. Copy of the minutes dated 19.11.2020 is attached as annexure..... **C.**
6. That although the appellant had submitted his complete PER file twice i.e for DPCs meeting held on 07.11.2019 and 19.11.2020 but astonishingly the Assistant director ACR Directorate of Elementary and Secondary Education, Khyber Pakhtunkhwa, Peshawar directed the DEO concerned to submit the PER of the appellant once again vide letter dated 16.03.2021. Copy of the letter dated 16.03.2021 is attached as annexure**D.**
7. That despite being recommended by DPC meeting held on 19.11.2020 the name of the appellant was ignored in the working papers for DPC meeting of 31.03.2021. Copy of the DPC meeting dated 31.03.2021 along with list of promoted teachers as annexure..... **E.**
8. That finally the respondent department issued impugned notification dated 24.05.2022 whereby the appellant was promoted to the post of Subject Specialist with immediate effect instead of w.e.f 07.11.2019. Copy of impugned order is attached as annexure **F.**
9. That the appellant feeling aggrieved form the impugned notification 24.05.2022 preferred departmental appeal before the appellate authority for promoting the appellant with effect from 07.11.2019 but the same has not been decided within the statutory period of Ninety days.. Copy of departmental appeal is attached as annexure**G.**

10. That the appellant feeling aggrieved and having no other remedy filed the instance service appeal on following grounds inter alia.

GROUND:

- A- That impugned Notification dated 24.05.2022 issued by the respondents is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be modified/rectified.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent department has acted arbitrary and malafidly by not considering the appellant in the year 2019 and now promoting with immediate effect instead of w-e-f 07-11-2019.
- D- That, the treatment meted out to the appellant is clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.
- E- That appellant is also entitled for his ante date promotion to the post of Subject Specialist (BPS-17).
- F- That the respondents acted in arbitrary and malafide manner while issuing the impugned orders.
- G- That respondents violated Article 38(e) of the Constitution of Islamic Republic of Pakistan 1973, according to which state is bound to eliminate disparity in the income and earning of individuals including persons in the services of the Federation, thus in light of the above quoted constitutional provision the respondents are duty bound to grant ante dated promotion to the appellant.
- H- That according to Section-9 of the Civil servant Act, 1973 read with Rule-17 of the appointment, promotion and transfer Rules appellant is fully entitle for the grant of ante dated promotion.
- I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.
