

APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 06-08-2021 WHICH HAS BEEN COMMUNICATED TO THE APPELLANT ON 05-06-2022 WHEREBY THE APPOINTMENT ORDER OF THE APPELLANT HAS BEEN CANCELLED/WITHDRAWN AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS

PRAYER:

That on acceptance of this appeal the impugned order dated 06-08-2021 communicated to the appellant on 06.05.2022 may very kindly be set aside and the appellant may kindly be reinstated into service with all back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1- That the father of the appellant was serving in the respondent department has been died during service. Copy of relevant record is attached as Annexure.....**A.**

- 2- That appellant was appointed on deceased son quota as Pharmacy Technician in BPS-12 against the vacant post (fall on vacant due to the natural death in service on his father) vide office order dated 06.05.2019. That in response the appellant took over the charge of his post and started performing his duty quite efficiently and up to the entire satisfaction of his superiors. Copies of the appointment order, arrival report, service book and attendance sheets are attached as annexure **B, C, D & E.**
- 3- That after proper verification the salary of the appellant was released by the respondents and as such the appellant received the salaries till July, 2021. Copies of the pay slips is attached as annexure..... **F.**
- 4- That while performing his duty in the concerned hospital astonishingly the respondents stopped/withheld the salaries of the appellant w.e.f. 01.08.2021 without any reason and clear justification. That feeling aggrieved the appellant time and again visited the concerned quarter for the release of his salaries but later on the impugned order dated 6.8.2021 was handed over to the appellant on 06.05.2022 whereby the appointment order was cancelled. Copies of the letter and impugned order are attached as annexure **G & H.**
- 5- That the appellant feeling aggrieved from the action of the respondents preferred Departmental appeal to the respondent but no reply has been received so far. Copy of the Departmental appeal is attached as annexure **I.**
- 6- That appellant feeling aggrieved and having no other remedy filed the instant service appeal on the following grounds amongst the others.

GROUND:


- A- That impugned order dated 06.08.2021 issued by the respondents is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and malafide manner while issuing the impugned order dated 06.08.2021.

- D- That, the treatment meted out to the appellant clearly based on discrimination and malafide and as such the respondents violated the Principle Of Natural Justice.
- E- That no charge sheet and statement of allegation has been issued to the appellant prior to the issuance of the impugned order dated 6.8.2021.
- F- That neither show cause notice nor chance of personal hearing has been provided to the appellant before issuance of the impugned order dated 6.8.2021.
- G- That appellant has been punished on no fault on his part and as such the respondents violated the principle of locus Poenitentiae.
- H- That no regular inquiry has been conducted in the matter which is as per Supreme Court Judgments is necessary in such like cases.
- I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may very graciously be accepted as prayed for, please.
