JUDGMENT

ABDUL LATIF, MEMBER:-

Facts giving rise to the instant appeal are that the

appellant was selected as Headmaster in BPS-17 through Public Service Commission NWFP (KPK) in the year 1979 and was promoted to BPS-18 and Posted as Deputy Director (Operation) in 1982. That the appellant was awarded selection grade in BPS-18 in 1988 to 1992 and that on repatriation to parent department he was posted as Deputy District Education Officer, Kohat, which was declared grade-18 post on the basis of 4 tier formula. That the appellant was promoted as a regular BPS-18 on 31.01.1995 and was posted as Principal GHS Badaber, Peshawar. That the appellant was promoted as regular to the post of BPS-19 in 1997.

That the appellant was allowed/granted move-over in BPS-20 in 1998. That a departmental appeal was filed before respondent No. 2 through respondent No. 3 in February, 2012 which was replied/rejected on 06.12.2012 and was received to the appellant on 09.03.2013. That aggrieved with the order, the appellant filed the instant service with a prayer that on acceptance of this appeal, the services of the appellant may be regularized in BPS-18 in 1992 and in BPS-19 from 01.02.1995 and moreover in BPS-20 from 01.12.0995 or from the date which are allowable under the rules of Government of Khyber Pakhtunkhwa Education Department and allowed regularization to the junior vide order dated 20.02.2010. Direction may kindly be issued to the respondents to pay all the service benefits to the appellant of higher post from the date of taking over charge of the higher post as paid to others of the same department.

2. The learned counsel for the appellant without specifying any particular act of respondents argued that all the actions of respondents were against the law, facts, material on record hence not tenable under the law. He further argued that order of respondents were in violation of service laws, rules and case laws SCMR 1996 page-1185 and SCMR 2009 page-1. He further contended that the same question of law had been decided by the Service Tribunal therefore respondents were bound to follow the same whether appellant was party before the Tribunal or not and also respondents has awarded the same relief to other petitioners. He prayed that on acceptance of this appeal, relief may be granted as prayed for in the heading of the appeal.

3. Learned Government Pleader resisted the appeal and argued that the appellant failed to assail any particular order passed by respondents which adversely affected his terms and conditions and hence the appeal did not fulfill the requirements of Section-4 of the Service Tribunal Act, 1974. He further argued that appellant stand, retired from service as revealed from his undated application addressed to the Secretary Education Department in his capacity as retired Project Manager Girls Education Project-II and that too without impugning any specific order adverse to his terms and conditions of service and hence was not maintainable being time barred as well as not in accordance with Section-4 read with Section-7 of the Service Tribunal/Act. He prayed that the appellant also failed to pinpoint any case of being similarly placed person or to substantiate his claim of being discriminated against and prayed that the appeal being not maintainable may be dismissed.

Arguments of learned counsels for the parties heard and record perused.

5. From perusal of the record it transpired the appeal filed by the appellant is not in conformity with the requirements of Section-4 and Section-7 of the Service Tribunal Act, 1974 as besides being vague it failed to assail any particular action of the respondents which adversely affected his terms and conditions of service or which discriminated against him and was violative of Article-25 of the Constitution. There is also no clarity in the contents of his application/representation to the Secretary of Education (undated) reproduced verbatim.

1 was awarded Selection Grade to BPS-18 by the department in 1989. I was repatriated to may parent department in 1992. I was posted as Deputy District Education Officer Kohat. In 1991-92, four tier formula of the service was approved by the government and the post of Deputy District Education Officer was upgraded to BPS-18. I took over the charge as Deputy District Education Officer on 01.07.1992.

It is therefore requested that I may very kindly be regularized as BPS-18 grade officer since 01.07.1992 in the light of the order issued on 20.05.2010 and obliged please.

Yours obediently, Mian Muzaffar Shah, (Rtd) Project Manager Girls Education Project-If NWFP (KPK) Peshawar." 6. A perusal of the above representation of the appellant would reveal that no specific issue was agitated therein nor was any action of the respondent department impugned by the appellant. In the above scenario, it is very difficult to assess the grievances if any of the appellant and pass orders in accordance with Section-7 of the Service Tribunal Act 1974 hence we do not justify our indulgence in the case. The appeal besides being barred by time is also deficient/defective in terms of Section-4 and 7 of the Service Tribunal Act, hence dismissed. Parties are, however, left to bear their own costs. File be consigned to the record room.







JUSTICE(R)SALIM KHAN.CHAIRMAN:- This judgment will dispose of Service Appeals No. 666/2008 by Faiz-ur-Rehman, 667/2008 by Shahbaz Khan, 668/2008 by Mahboob Jan, 669/2008 by Fazal Raziq and 670/2008 by Muhammad Rafique. The issues in these cases are almost the same.

2. Vide Appeal No. 666 of 2008 Faiz-ur-Rehman appellant contended that he was appointed as Incharge Headmaster, Govt. High School, Daskori Dir Upper vide Notification dated 17.2.2003. The appellant was promoted as regular Headmaster vide order dated 11.2.2005, but with immediate effect instead of ante-dating the promotion of the appellant. A departmental appeal was submitted by the appellant and others on 13.12.2007 but no decision was given on the same.

3. With change of personal facts regarding dates of appointments, the other facts and legal issues in the cases of the other appellants are the same.

4. The respondents contested the appeals and contended that the appellants were appointed against the vacant posts of Headmasters on acting charge basis, conditionally, subject to the approval of P.S.B. They also contended that the departmental appeals were filed late.

5. We heard the arguments and perused the record.

6. The learned counsel for the appellants relied on 2006 SCMR 1938 and contended that the appellants were entitled to the salary and allowances attaching to such posts alongwith all consequential benefits from the very date from which the appellants were posted to the said posts on offg:/acting charge basis.

7. It has been decided again and again that a civil servant is entitled to the salary, allowances and other benefits of a post to which he is posted, and against which he renders services, despite the fact that such posting is on acting charge basis or merely on officiating basis. It is admitted by the respondents that all the present appellants were posted to their respective higher posts on acting charge basis, and those posts were vacant at the time of their posting. The subsequent promotion of the appellants on regular basis also shows that they were eligible for regular promotion, but their cases were delayed due to departmental proceedings. regular promotion, but their cases were delayed due to departmental proceedings. The appellants, therefore, were entitled to ante-dation of their promotion on regular basis to the dates on which they took charge of their respective higher posts on acting charge basis. Preliminary Objections:-

- 1. The appellant has no cause of action/ locus standi.
- 2. The instant appeal is badly time barred.
- 3. The appellant has concealed the material facts from this Hon 'able Tribunal, hence liable to be dismissed.
- 4. The appellant has not come to this Hon 'able court with clean hands.
- 5. The appellant has filed the instant appeal just to pressurize the respondents.
- 6. The present appeal is liable to be dismissed for no joinder/ mis-joinder of necessary parties.
- 7. That the appellant has filed the instant appeal on malafide motives.
- 8. The instant appeal is against the prevailing law and rules.
- 9. The appellant is estopped by her own conduct to file the instant appeal.
- 10. That the instant appeal is not maintainable in the present form and also in the present circumstances of the issue.

<u>FACTS.</u>

- 1. The para is related to Service record of the appellant while the appointment order is not annexed hence no comments.
- 2. As replied in para above.
- 3. The appellant was recommended for regular BS-17 subject to the condition that his service will be governed by such rules and regulations as may be issued by the Government for the category of Govt. Servants to which he belongs.
- 4. The said appointment was made subject to the conditions that his appointment will however be purely on temporary basis and it will not confer on him any right what so ever as a result of his holding Grade 18 post. Vis-à-vis the existing terms and condition of his service in his parent Department.
- The appellant was awarded Selection Grade from BS-17 to BS-18 w.e.f 27-6-1988 against available post as per rules on the subject.
- 6. The appellant was promoted to BS-18 regular and transferred against vacant post on his pay and scale.
- 7. As replied in para-6 above. However, it is pertinent to mentioned here that said promotion to a regular BS-18 on 30-1-1995 was in accordance with rules

on the subject and allowable from the said date. The appellant never challenged the said promotion at any legal forum.

- The promotion of the appellant to BS-19 on 28-5-1999 was also in accordance with law rules on the subject and the same was not objected by the appellant on any proper forum.
- 9. The appellant was allowed move-over w.e.f 1-12-1998 notified on 16-12-1999 according to rules on the subject.
- 10. Incorrect. The appellant has not annexed any Departmental representation with this appeal however, the said appeal was also time barred one, hence the appeal in hand is liable to be dismissed.
- 11. Incorrect. The appellant has no reason to be aggrieved and has no course of action hence this appeal is liable to be dismissed on the following grounds amongst the others.

ON GROUNDS.

- A. Incorrect and not admitted. The contents of the appeal are misleading one, meaningless, against the law, rules and policy on the subject while all acts and actions as mentioned in this appeal of the respondents are in accordance with law, facts and material on record hence tenable in the eye of the law.
- B. As explained in para"A" above.
- C. Incorrect, the case of the appellant is different from the mentioned appellants in this para.
- D. Incorrect. The respondent have exercised the jurisdiction vetted to them under the law.
- E. Incorrect. The case and claims of the appellant are against the natural justice, law, rules on the subject.
- F. Incorrect. The acts and actions of the respondents are not against the Article 25 of the constitution 1973.
- G. Incorrect and not admitted. The prayer of the appellant in the heading of the appeal are against the fact, law, rules and policy in vogue, baseless with out any legal support, with out cogent reasons and based on malafide motives. The appeal in hand also does not fall with in the ambit of Section 4 of the Service Tribunal Act 1974 and liable to be dismissed. Moreover, the respondents also seek the permission of this Hon'able Tribunal to advance more arounds and proofs at time of arguments.
