Appeals U/S 4 of KPK Service Tribunal Act 1974 against the Order of the Respondent no. vide which appeal of the Appellant was dismissed 15.01.2013 seeking accurate seniority under the rules.

Respectfully sheweth:

1. That the appellant is domicile of District Hangu, and was initially appointed in this department on 17-11-1983 and later regularized on 14-06-1987, took over the charge as trained CT on the same date, presently working as trained CT in District Hangu since 30-04-2004.
2. That the present appellant was appointed initially in traible territory and was transferred to settled area on 13-04-2004. **(Copy of order is annexed as "A")**.
3. That the respondent No 1 issued final seniority list of CT (M) in district Hangu as stood on 16-08-2012 on 05-09-2012, wherein the appellant was place at serial No 119, despite of the fact that the appellant was senior than his other colleague who were junior to him. **(Copy of final seniority list is annexed as "B")**.
4. That it is very much clear from the circulatory seniority list that all those who were below in obtaining PBS-15 were also made senior to the appellant without any solid reason.
5. That aggrieved by the same order the appellant filed a departmental appeal which was dismissed vide order of the respondent No 1 rejecting the departmental appeal along with two other colleagues on 15-01-2013. **(Order dated 15-01-2013 is annexed as "C")**.

6. That respondent No 1 dismissed appeal of the appellant and issued a collective dismissal order including two other appellants, which is based on share illegality as one of the appellant namely Gul Mohammad filed an appeal on 15-01-2013, which was dismissed on the same day.
7. That a colleague appellant run from post to pillar to obtain copy of the dismissal order which and was successful 20-02-2013 which was conveyed to the Appellant.
8. That aggrieved by the same order of the respondent No 1 the appellant left with no other option but to file the instant appeal on the grounds inter alia:

GROUND

1. That the collective impugned order of the respondent No 1 is illegal, against the law and not tenable in the eye of law.
2. That the impugned order is discriminatory in nature and having no effect on the basic fundamental rights of the appellant.
3. That the appellant spend major part of his life serving the respondent department and the treatment meted out is against the general principal of administration of justice and law.
4. That the policy of seniority from trible area to settle area should not affect the spirit of equity, equality and justice.
5. That the precedent established in other such like cases must be followed and the violation of which is against the equality before the law.
6. That other points of law and facts shall be raised / argued if required for the assistance of this honorable tribunal.

It is therefore requested that on acceptance of the instant appeal the order of the respondent No1 may kindly be set aside, and the appellant may be placed in accordance with his length of services.
